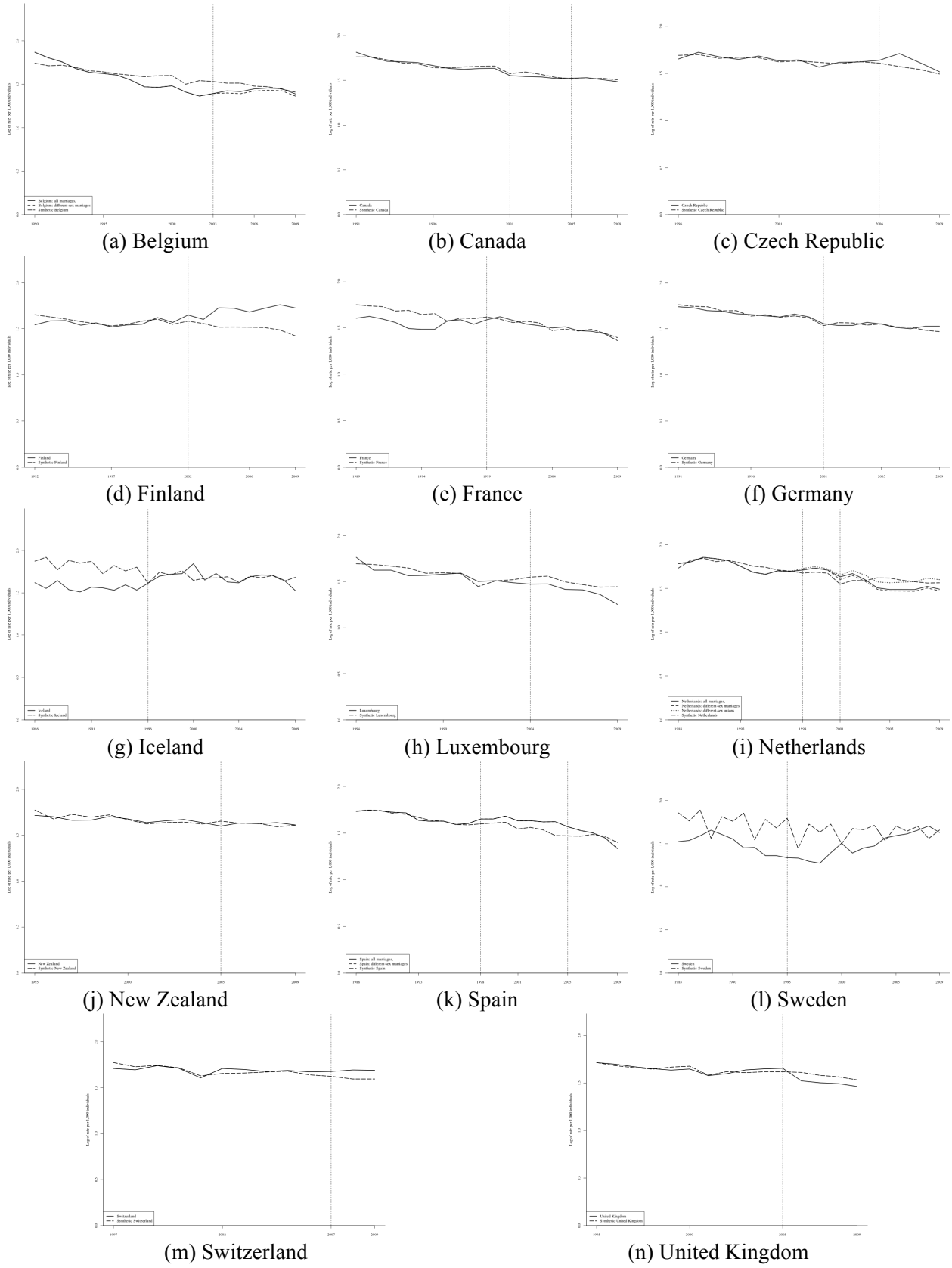

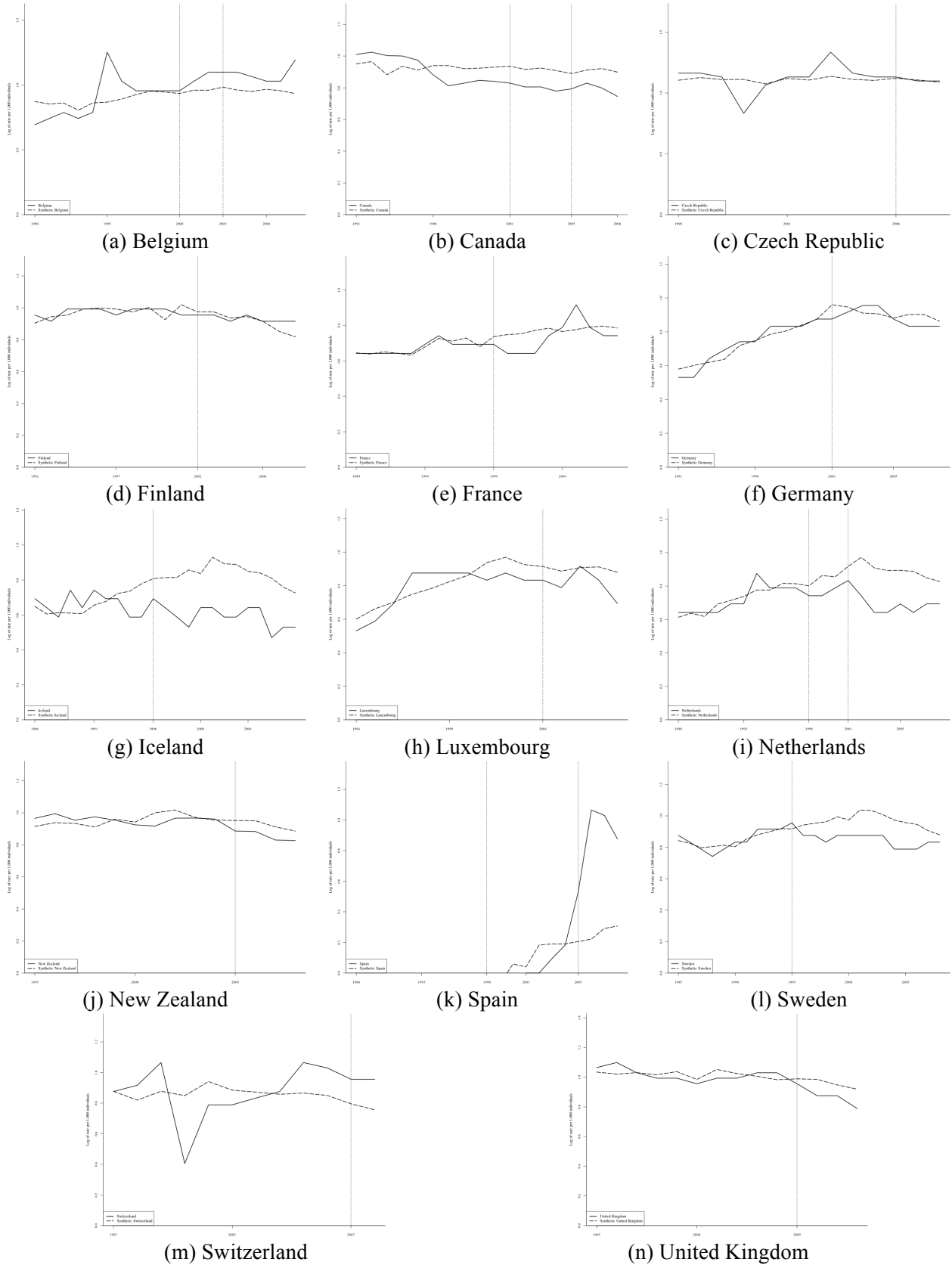

 Figure S2: Evolution of actual and synthetic divorce rate

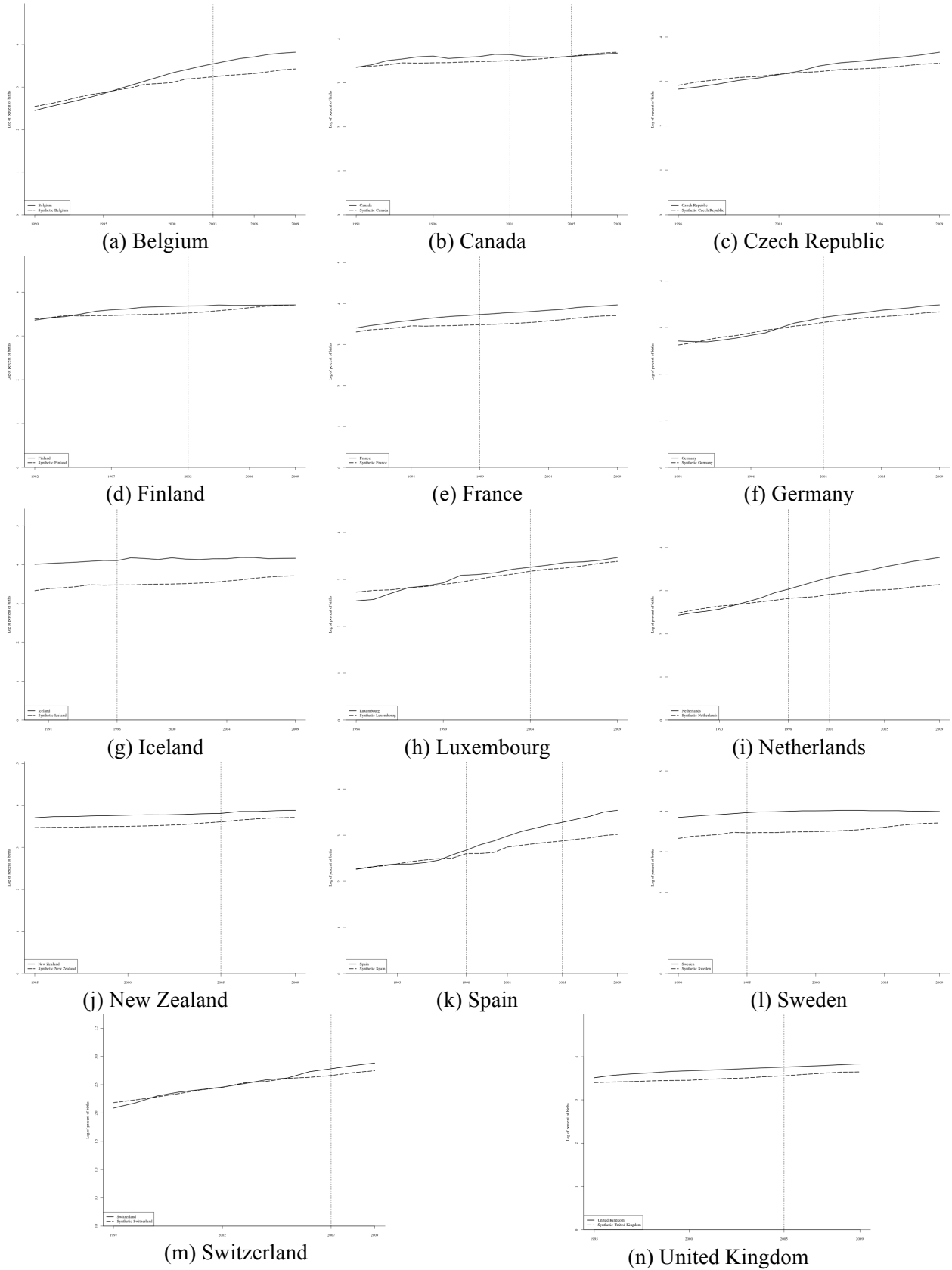


Figure S3: Evolution of actual and synthetic extramarital birth rate
