*FilteringInfo.org site to Aid Schools*

N2H2 has announced the launch of a new online resource, FilteringInfo.org. FilteringInfo.org is designed to provide teachers, librarians, administrators, and tech coordinators with information and resources on how to comply with new federally-mandated filtering legislation, how to receive funding, and where to go with questions. FilteringInfo.org comes on the heels of the FY2001 Labor, Health and Human Services, and Education Appropriations bill, which included the Children's Internet Protection Act. The N2H2 FilteringInfo.org site is divided into five sections: About Filtering, Compliance, Resources, Funding, and Staying Informed.

The Children's Internet Protection Act imposes certain requirements on public schools and public libraries

that both provide Internet access and receive federal funding. Provisions include the purchase and installation of Internet filtering software, the creation of an Internet Acceptable Use Policy and the requirement that the school or library hold at least one public meeting.

Educators and students have a new source of often difficult-to-find articles that are frequently needed for

educational technology courses. *Classic Writings on Instructional Technology* is a collection of fifteen seminal papers considered to be foundations in the field of instructional technology. These articles were selected for their influence on the field, their continued reference over the years and the reputation of the authors. Following the warm reception of the first volume, this work continues to document the history and conceptual growth of the field while offering a substantive grounding for its principles and procedures.

The articles are arranged in four parts: "Definition and Conceptual Background," "Design and Development Functions," "Delivery Options," and "The Profession." In this volume, bibliographic essays introduce each section of classic works with a brief explanation about their contributions to particular conceptual developments.
