

Multiscale Modelling and Analysis of Signalling Processes in Tissues with Non-Periodic Distribution of Cells

Abstract In this paper, a microscopic model for a signalling process in the left ventricular wall of the heart, comprising a non-periodic fibrous microstructure, is considered. To derive the macroscopic equations, the non-periodic microstructure is approximated by the corresponding locally periodic microstructure. Then, applying the methods of locally periodic homogenization (the locally periodic (l-p) unfolding operator, locally periodic two-scale (l-t-s) convergence on oscillating surfaces and l-p boundary unfolding operator), we obtain the macroscopic model for a signalling process in the heart tissue.

1 Introduction




Fig. 1 *Left*: Schematic representation of a plywood-like structure. *Right*: Cardiac muscle fiber orientations vary continuously through the left ventricular wall from a negative angle at the epicardium to positive values toward the endocardium. Republished from A.D. McCulloch, Cardiac biomechanics, in The Biomedical Engineering Handbook, 2nd edn., J.D. Bronzino (ed.), CRC Press, Boca Raton, FL, 2000 [25]

In this paper, we consider the multiscale analysis of microscopic problems posed in domains with non-periodic microstructures. We consider a model for a signalling process in the cardiac muscle tissue of the left ventricular wall, comprising plywood-like microstructure [25, 28]. The plywood-like structure is given by the superposition of planes of parallel aligned fibres, gradually rotated with a rotation angle γ , see Fig. 1. In the left ventricular wall, the orientation of the layers of muscle fibres changes from a negative angle at the epicardium

to a positive angle at the endocardium. In the microscopic model of a signalling process, we consider the diffusion of signalling molecules in the extracellular space and their interaction with receptors located on the surfaces of muscle cells. There are two main challenges in the multiscale analysis of microscopic problems posed in domains with non-periodic perforations: (i) the approximation of the non-periodic microstructure by a locally periodic one and (ii) derivation of limit equations for the non-linear equations defined on oscillating surfaces of the microstructure. First, assuming the C^2 -regularity for the rotation angle γ , we define the locally periodic microstructure which approximates the original non-periodic plywood-like structure. Similar approximation of non-periodic plywood-like microstructure by locally periodic one was considered in [7, 29]. Then, applying techniques of locally periodic homogenization (locally periodic two-scale convergence (l-t-s) and l-p unfolding operator), we derive macroscopic equations for the original microscopic model. The l-p two-scale convergence on oscillating surfaces and l-p boundary unfolding operator allow us to pass to the limit in the non-linear equations defined on surfaces of the locally periodic microstructure.

In this paper, we consider a simple model describing the interactions between processes defined in the perforated domain and on the surfaces of the microstructure. However, the techniques presented here can be also applied to more general microscopic models as well as to other non-periodic microstructures, provided the variations in the microscopic structure are sufficiently regular.

Previous results on homogenization in locally periodic media constitute the multiscale analysis of a heat-conductivity problem defined in domains with non-periodically distributed spherical balls [3, 8, 31], and elliptic and Stokes equations in non-periodic fibrous materials [4, 6, 7, 29]. Formal asymptotic expansion and two-scale convergence defined for periodic test functions, [27], were used to derive macroscopic equations for models posed in domains with locally periodic perforations, i.e., domains consisting of periodic cells with smoothly changing perforations [5, 10, 11, 22, 23, 33].

The paper is organized as follows. In Section 2, the microscopic model for a signalling process in a tissue with non-periodic plywood-like microstructure is formulated. In Section 3, we prove the existence and uniqueness results for the microscopic model and derive a priori estimates for a solution of the microscopic model. The approximation of the microscopic equations posed in the domain with non-periodic microstructure by the corresponding problem defined in a domain with locally periodic microstructure is given in Section 4. Then, applying the 1-p unfolding operator, 1-t-s convergence on oscillating surfaces, and 1-p boundary unfolding operator we derive the macroscopic model for a signalling process in the heart muscle tissue. In Appendix, we summarize the definitions and main compactness results for the 1-t-s convergence and 1-p unfolding operator.

2 Microscopic Model for a Signalling Process in Heart Tissue

In this work, we consider a receptor-based microscopic model for a cellular signalling process in cardiac tissue. A signalling system is important for proper function of cells and appropriate respond to changes in the extracellular environment. Many regulatory events in cardiac tissue are mediated via surface receptors, located in cardiac cells membrane, that transmit signals through the activation of GTP binding proteins (G proteins) [34]. Cardiac cells (myocytes) in the heart wall tissue are joined in a linear arrangement to form muscle fibres. In the left ventricular wall of the heart the orientation of layers of muscle fibre changes with position through the wall. The layers of parallel aligned muscle fibres are rotated from -60° at epicardium to $+70^{\circ}$ at endocardium [25] and create a non-periodic plywood-like microstructure. For simplicity, we assume that the individual muscle fibres are not connected to each other. However, it is possible to consider a periodic distribution of connections between the fibres.

In the mathematical model for a signalling process in cardiac tissue, we consider the binding of signalling molecules to receptors located on the cell membrane, which through the activation of G proteins (not considered in our simple model) results in the activation of a cell signalling pathway. We consider the diffusion, production and decay of ligands (signalling molecules) *c* and binding of ligands to the membrane receptors. We shall distinguish between free receptors r_f and bound receptors r_b , which correspond to receptor-ligand complexes. We assume that the receptor-ligand complex can dissociate and result in a free receptor and ligand. We also consider the production of new free receptors and natural decay of free and bound receptors.

where d_f and d_b are the decay rates, β denotes the dissociation rate for the receptor-ligand complex, α is the binding rate, the function p models the production of free receptors, and the function F describes the production and decay of ligands.

To define the plywood-like microstructure of the cardiac muscle tissue of the left ventricular wall, we consider a function $\gamma \in C^2(\mathbb{R})$, with $-\pi/2 \leq \gamma(x) \leq \pi/2$ for $x \in \mathbb{R}$ and define the rotation matrix around the x_3 -axis as

where $\gamma(x)$ denotes the rotation angle with the x_1 -axis. Denote $R_x := R(\gamma(x_3))$.

We consider an open, bounded subdomain $\Omega \subset \mathbb{R}^3$, with Lipschitz boundary, representing a part of the cardiac muscle tissue and the x_3 -axis to be orthogonal to the layers of parallel-aligned muscle fibres. We assume that the radius of the muscle fibres depends on the position in the tissue and define the characteristic function of a fibre by

$$\vartheta(x, y) = \begin{cases} 1, & |\hat{y}| \le \rho(\hat{x}_R)a, \\ 0, & |\hat{y}| > \rho(\hat{x}_R)a, \end{cases}$$

where $\hat{y} = (y_2, y_3)$ and $\hat{x}_R = ((R_x^{-1}x)_2, (R_x^{-1}x)_3), \rho \in C^1(\mathbb{R}^2)$, with $0 < \rho_0 \le \rho(\hat{x}_R) \le \rho_1 < \infty$ and $\rho(\hat{x}_R)a \le 2/5$ for all $x \in \overline{\Omega}$, i.e., $a = 2/(5\rho_1)$.

By small parameter ε we denote the characteristic size of the microstructure of cardiac tissue, given as a ratio between the characteristic diameter of muscle fibres and characteristic size of the cardiac tissue. Notice that for plywood-like microstructure the axis of each fibre can be defined by a rotated around the x_3 -axis line, parallel to the x_1 -axis and passing through a point of an ε -grid in the plane $x_1 = \text{const.}$ Thus, for $j \in \mathbb{Z}^3$, we define $x_j^{\varepsilon} = R_{x_j^{\varepsilon}} \varepsilon j$ with $R_{x_j^{\varepsilon}} := R(\gamma(x_{j,3}^{\varepsilon}))$. Notice that $x_{j,3}^{\varepsilon} = \varepsilon j_3$ and the third variable is invariant under the rotation $R_{x_s^{\varepsilon}}$. This ensures that for each fixed εj_3 we obtain a layer of parallel aligned fibres.

Then the perforated domain Ω_{ε}^* , corresponding to the extracellular space of cardiac tissue, is defined as

where $\Xi_{\varepsilon} = \{j \in \mathbb{Z}^3 : \varepsilon R_{x_j^{\varepsilon}}(\overline{Y}_1 + j) \subset \Omega\}, Y_0 = \{y \in \overline{Y}_1 : |\hat{y}| \le a\}$, with $a = 2/(5\rho_1)$ and $\rho_1 = \sup_{\overline{\Omega}} \rho(x)$, and

We aslo define $Y_{x_j^{\varepsilon}} = R_{x_j^{\varepsilon}}Y_1$, and $Y_{x_j^{\varepsilon},K}^* = R_{x_j^{\varepsilon}}(Y_1 \setminus K_{x_j^{\varepsilon}}Y_0)$ for $j \in \Xi_{\varepsilon}$.

We denote $\Gamma_{0,1} = \{y \in \mathbb{R}^3 : y_1 = \pm 1/2\}$. Then, assumptions on ρ and a ensure that $K_x(Y_0 \setminus \Gamma_{0,1}) \subset Y_1$ for all $x \in \overline{\Omega}$ and, since R is a rotation matrix, $(\varepsilon R_{x_n^{\varepsilon}} K_{x_n^{\varepsilon}} Y_0 + x_n^{\varepsilon}) \cap (\varepsilon R_{x_n^{\varepsilon}} K_{x_n^{\varepsilon}} Y_0 + x_n^{\varepsilon}) = \emptyset$ for any $m, n \in \Xi_{\varepsilon}$ with $n_2 \neq m_2$ or $n_3 \neq m_3$. Hence, Ω_{ε}^* is connected. This corresponds to our assumption that muscle fibres do not touch each other and are not directly connected, and the interactions between the muscle fibres are facilitated through the extracellular matrix.

Now, using the definition of ϑ , the characteristic function of muscle fibres in cardiac tissue reads

and the extracellular space is characterised by

The surfaces of muscle cells, i.e., the boundaries of the microstructure, are denoted by

where $\Gamma = \overline{\partial Y_0 \setminus \Gamma_{0,1}}$.

Notice that the changes in the microstructure of Ω_{ε}^* are defined by changes in the periodicity given by the linear transformation (rotation) R(x) and by changes in the shape of the microstructure (changes in the radius of muscle fibres) given by the linear transformation K(x) for $x \in \Omega$.

To determine the non-constant reaction rates for binding and dissociation processes on cell membranes, we consider $\alpha, \beta \in C^1(\overline{\Omega}; C_0^1(Y_1))$, extended in y-variable by zero to \mathbb{R}^3 , and define

Then, the microscopic model for a signalling process in cardiac tissue reads

where the dynamics in the concentrations of free and bound receptors on cell surfaces is determined by two ordinary differential equations

with initial conditions defined as

For simplicity of the presentation we shall assume that the diffusion coefficient A and the decay rates d_f , d_b are constant. We also assume that the functions F and p are independent of $x \in \Omega$. The dependence of A, d_f , d_b , F and p on the microscopic and macroscopic variables can be analyzed in the similar way as for α^{ε} and β^{ε} .

Assumption 1

- *A* is symmetric and $(A\xi, \xi) \ge a_0 |\xi|^2$ for $\xi \in \mathbb{R}^3$, $a_0 > 0$. $\gamma \in C^2(\mathbb{R}), K \in C^1(\overline{\Omega})$ with $0 < \rho_0^2 \le |\det K(x)| \le \rho_1^2 < \infty$ and $K(x)(Y_0 \setminus \Gamma_{0,1}) \subset \mathbb{R}^2$. _ Y_1 for all $x \in \overline{\Omega}$, and $d_l \ge 0$ for l = f, b.
- $F: \mathbb{R} \to \mathbb{R}$ is Lipschitz continuous, $F(\xi_{-})\xi_{-} \leq \mu_{F}|\xi_{-}|^{2}$, with $\mu_{F} > 0$ and $\xi_{-} =$ $\min\{0, \xi\}.$
- $p: \mathbb{R} \to \mathbb{R}$ is Lipschitz continuous and $p(\xi) \ge 0$ for $\xi \ge 0$.
- $\alpha, \beta \in C^1(\overline{\Omega}; C_0^1(Y_1))$ are nonnegative.
- $c_0 \in H^1(\Omega) \cap L^{\infty}(\Omega), r_{l_0}^1 \in C^1(\overline{\Omega}), \text{ and } r_{l_0}^2 \in C_0^1(Y_1), \text{ extended by zero to } \mathbb{R}^3, \text{ and } c_0,$ r_{l0}^{j} are nonnegative for l = f, b and j = 1, 2.

Notice that the C^1 -regularity of α and β is required for the approximation of the integrals defined on the boundaries of the non-periodic microstructure by the integrals defined on the boundaries of the corresponding locally periodic microstructure.

We shall use the following notations $\Omega_{\varepsilon,T}^* = (0,T) \times \Omega_{\varepsilon}^* \Gamma_T^{\varepsilon} = (0,T) \times \Gamma^{\varepsilon}, \Omega_T =$ $(0, T) \times \Omega, \Gamma_T = (0, T) \times \Gamma, \text{ and } \Gamma_{x,T} = (0, T) \times \Gamma_x.$

For $u \in L^{q}(0, \tau; L^{p}(G))$ and $v \in L^{q'}(0, \tau; L^{p'}(G))$, with 1/p + 1/p' = 1 and 1/q + 1/q' = 1 $1/q' = 1, \tau > 0$ and $G \subset \mathbb{R}^d$ for d = 2 or 3, we denote $\langle u, v \rangle_{G_\tau} = \int_0^\tau \int_G uv dx dt$.

We shall consider a weak solution of the problem (1) and (2), defined in the following way.

Definition 1 A weak solution of the microscopic problem (1) and (2) are functions c^{ε} , r_{f}^{ε} , r_{b}^{ε} such that

for all $\phi \in L^2(0, T; H^1(\Omega_{\varepsilon}^*))$, (2) are satisfied a.e. on Γ_T^{ε} , and $c^{\varepsilon} \to c_0$ in $L^2(\Omega_{\varepsilon}^*)$, $r_l^{\varepsilon} \to r_{l0}^{\varepsilon}$ in $L^2(\Gamma^{\varepsilon})$ for l = f, b, as $t \to 0$.

3 Existence, Uniqueness, and a Priori Estimates for a Weak Solution of the Microscopic Problem (1) and (2)

In a similar way as in [9, 21, 30], we can prove the existence, uniqueness, and a priori estimates for a weak solution of problem (1)–(2). Notice that for the derivation of a priori estimates a trace estimate, uniform in ε , for functions $\phi \in W^{1,p}(\Omega_{\varepsilon}^*)$ is required. The fact that $K_x(Y_0 \setminus \Gamma_{0,1}) \subset Y_1$ for all $x \in \overline{\Omega}$ and the uniform boundedness of det K, i.e., $0 < \rho_0^2 \le |\det K(x)| \le \rho_1^2 < \infty$, ensure the trace estimate for $\phi \in H^1(Y_1 \setminus K_{x_{\varepsilon}^i}Y_0)$, i.e.,

where the constant *C* depends on Y_1 , Y_0 , *K* and is independent of ε and $j \in \Xi_{\varepsilon}$. Then, considering the change of variables $x = \varepsilon R_{x_j^{\varepsilon}} y + x_j^{\varepsilon} = \varepsilon R_{x_j^{\varepsilon}} (y + j)$ and summing up over $j \in \Xi_{\varepsilon}$, we obtain for $\phi \in W^{1,p}(\Omega_{\varepsilon}^*)$, with $p \in [1, \infty)$, that

where the constant $\tilde{\mu}$ depends on Y_1, Y_0, R and K and is independent of ε .

Lemma 1 Under Assumption 1 there exists a unique non-negative weak solution of the microscopic problem (1) and (2) satisfying the following a priori estimates

$$\|r_f^{\varepsilon}\|_{L^{\infty}(\Gamma_T^{\varepsilon})} + \|r_b^{\varepsilon}\|_{L^{\infty}(\Gamma_T^{\varepsilon})} + \varepsilon^{\frac{1}{2}} \|\partial_t r_f^{\varepsilon}\|_{L^2(\Gamma_T^{\varepsilon})} + \varepsilon^{\frac{1}{2}} \|\partial_t r_b^{\varepsilon}\|_{L^2(\Gamma_T^{\varepsilon})} \le \mu, \quad (5b)$$

and

$$\|(c^{\varepsilon} - M_1 e^{M_2 t})^+\|_{L^{\infty}(0,T;L^2(\Omega^*_{\varepsilon}))} + \|\nabla(c^{\varepsilon} - M_1 e^{M_2 t})^+\|_{L^2(\Omega^*_{\varepsilon,T})} \le \mu \varepsilon,$$
(6)

where the constant μ is independent of ε , $M_1 \geq \|c_0\|_{L^{\infty}(\Omega)}$, and $M_1M_2 \geq |F(0)| + \|F'\|_{L^{\infty}}M_1 + \tilde{\mu}\|\beta\|_{L^{\infty}(\Omega \times Y_1)}\|r_b^{\varepsilon}\|_{L^{\infty}(\Gamma_T^{\varepsilon})}$, with $\tilde{\mu}$ being the constant in the trace inequality (4).

Proof (Sketch) As in [30] the existence of a solution of the microscopic problem (1) and (2) for each fixed $\varepsilon > 0$ is obtained by applying fixed point arguments and Galerkin method.

Also, using the same arguments as in [30] we obtain that $c^{\varepsilon}(t, x) \ge 0$ for $(t, x) \in \Omega_{\varepsilon,T}^*$ and $r_l^{\varepsilon}(t, x) \ge 0$ for $(t, x) \in \Gamma_T^{\varepsilon}$, with l = f, b. To derive a priori estimates, we consider the structure of the microscopic equations. For non-negative solutions, by adding the equations for r_f^{ε} and r_b^{ε} , we obtain

$$\partial_t (r_f^{\varepsilon} + r_b^{\varepsilon}) = p(r_b^{\varepsilon}) - d_b r_b^{\varepsilon} - d_f r_f^{\varepsilon}.$$

Then the Lipschitz continuity of p and the non-negativity of r_f^{ε} and r_b^{ε} imply the boundedness of r_f^{ε} and r_b^{ε} on Γ_T^{ε} . Considering c^{ε} as a test function in (3) and using the trace inequality (4), we obtain the

Considering c^{ε} as a test function in (3) and using the trace inequality (4), we obtain the estimates for c^{ε} . Testing (2) by $\partial_t r_f^{\varepsilon}$ and $\partial_t r_b^{\varepsilon}$, respectively, yields the estimates for the time derivatives of r_f^{ε} and r_b^{ε} . In the derivation of the a priori estimate for $\partial_t c^{\varepsilon}$ we use the equation for $\partial_t r_f^{\varepsilon}$ to estimate the non-linear term on the boundary Γ^{ε} , i.e.,

$$\begin{split} -\int_{\Gamma^{\varepsilon}} \alpha^{\varepsilon}(x) r_{f}^{\varepsilon} c^{\varepsilon} \partial_{t} c^{\varepsilon} d\sigma_{x} &= -\frac{1}{2} \frac{d}{dt} \int_{\Gamma^{\varepsilon}} \alpha^{\varepsilon}(x) r_{f}^{\varepsilon} |c^{\varepsilon}|^{2} d\sigma_{x} \\ &+ \frac{1}{2} \int_{\Gamma^{\varepsilon}} \alpha^{\varepsilon}(x) (p(r_{b}^{\varepsilon}) - \alpha^{\varepsilon}(x) r_{f}^{\varepsilon} c^{\varepsilon} + \beta^{\varepsilon}(x) r_{b}^{\varepsilon} - d_{f} r_{f}^{\varepsilon}) |c^{\varepsilon}|^{2} d\sigma_{x} \\ &\leq \frac{1}{2} \int_{\Gamma^{\varepsilon}} \left(\alpha^{\varepsilon}(x) p(r_{b}^{\varepsilon}) + \beta^{\varepsilon}(x) r_{b}^{\varepsilon} \right) |c^{\varepsilon}|^{2} d\sigma_{x} - \frac{1}{2} \frac{d}{dt} \int_{\Gamma^{\varepsilon}} \alpha^{\varepsilon}(x) r_{f}^{\varepsilon} |c^{\varepsilon}|^{2} d\sigma_{x}. \end{split}$$

Considering $(c^{\varepsilon} - M_1 e^{M_2 t})^+$ as a test function in (3), where M_1 and M_2 are as in the formulation of the lemma, we obtain

$$\begin{split} &\int_{\Omega_{\varepsilon}^{*}} |(c^{\varepsilon}(\tau) - M_{1}e^{M_{2}\tau})^{+}|^{2}dx + \int_{0}^{\tau} \int_{\Omega_{\varepsilon}^{*}} M_{1}M_{2}e^{M_{2}t}(c^{\varepsilon} - M_{1}e^{M_{2}t})^{+}dxdt \\ &+ \int_{0}^{\tau} \left[\int_{\Omega_{\varepsilon}^{*}} |\nabla(c^{\varepsilon} - M_{1}e^{M_{2}t})^{+}|^{2}dx + \varepsilon \int_{\Gamma^{\varepsilon}} \alpha^{\varepsilon}(x)r_{f}^{\varepsilon}c^{\varepsilon}(c^{\varepsilon} - M_{1}e^{M_{2}t})^{+}d\sigma_{x} \right]dt \\ &\leq C_{1} \int_{0}^{\tau} \left[\int_{\Omega_{\varepsilon}^{*}} F(c^{\varepsilon})(c^{\varepsilon} - M_{1}e^{M_{2}t})^{+}dx + \varepsilon \int_{\Gamma^{\varepsilon}} \beta^{\varepsilon}(x)r_{b}^{\varepsilon}(c^{\varepsilon} - M_{1}e^{M_{2}t})^{+}d\sigma_{x} \right]dt \end{split}$$

for $\tau \in (0, T]$. Using the non-negativity and boundedness of β^{ε} and r_{f}^{ε} , along with the trace inequality (4), the last integral can be estimated as

$$\begin{split} &\varepsilon \int_0^\tau \int_{\Gamma^\varepsilon} \beta^\varepsilon r_b^\varepsilon (c^\varepsilon - M_1 e^{M_2 t})^+ d\sigma_x dt \\ &\le \mu_1 \int_0^\tau \int_{\Omega^\varepsilon_\varepsilon} (c^\varepsilon - M_1 e^{M_2 t})^+ dx dt + \varepsilon \mu_1 \int_0^\tau \int_{\Omega^\varepsilon_\varepsilon} |\nabla (c^\varepsilon - M_1 e^{M_2 t})^+ |dx dt \\ &\le \mu_1 \int_0^\tau \int_{\Omega^\varepsilon_\varepsilon} (c^\varepsilon - M_1 e^{M_2 t})^+ dx dt + \mu_2 \delta \int_0^\tau \int_{\Omega^\varepsilon_\varepsilon} |\nabla (c^\varepsilon - M_1 e^{M_2 t})^+ |^2 dx dt + \mu_\delta \varepsilon^2 \end{split}$$

for any $\delta > 0$, where the constants μ_1 , μ_2 and μ_δ depend on $\|\beta\|_{L^{\infty}(\Omega \times Y_1)}$, $\|r_b^{\varepsilon}\|_{L^{\infty}(\Gamma_T^{\varepsilon})}$ and on the transformation matrices R and K, but are independent of ε . More specifically, $\mu_1 = \tilde{\mu} \|\beta\|_{L^{\infty}(\Omega \times Y_1)} \|r_b^{\varepsilon}\|_{L^{\infty}(\Gamma_T^{\varepsilon})}$. Using the non-negativity of c^{ε} and r_f^{ε} , the Lipschitz continuity of F, and the assumptions on M_1 and M_2 , and applying the Gronwall inequality yield estimate (6). To show the uniqueness of a solution of the microscopic problem (1) and (2), we consider the equations for the difference of two solutions $(c_1^{\varepsilon}, r_{f,1}^{\varepsilon}, r_{b,1}^{\varepsilon})$ and $(c_2^{\varepsilon}, r_{f,2}^{\varepsilon}, r_{b,2}^{\varepsilon})$. The nonnegativity of $\alpha^{\varepsilon}, r_{f,j}^{\varepsilon}$, and c_j^{ε} , along with the boundedness of $r_{f,j}^{\varepsilon}$, ensures

$$\|r_{f,1}^{\varepsilon}(\tau) - r_{f,2}^{\varepsilon}(\tau)\|_{L^{2}(\Gamma^{\varepsilon})}^{2} \leq \mu \int_{0}^{\tau} \left[\sum_{l=f,b} \|r_{l,1}^{\varepsilon} - r_{l,2}^{\varepsilon}\|_{L^{2}(\Gamma^{\varepsilon})}^{2} + \|c_{1}^{\varepsilon} - c_{2}^{\varepsilon}\|_{L^{2}(\Gamma^{\varepsilon})}^{2} \right] dt.$$

Testing the sum of the equations for $r_{f,1}^{\varepsilon} - r_{f,2}^{\varepsilon}$ and $r_{b,1}^{\varepsilon} - r_{b,2}^{\varepsilon}$ by $r_{f,1}^{\varepsilon} + r_{b,1}^{\varepsilon} - r_{f,2}^{\varepsilon} - r_{b,2}^{\varepsilon}$ and using the estimate from above yield

$$\begin{split} \|r_{b,1}^{\varepsilon}(\tau) - r_{b,2}^{\varepsilon}(\tau)\|_{L^{2}(\Gamma^{\varepsilon})}^{2} &\leq \|r_{b,1}^{\varepsilon}(\tau) + r_{f,1}^{\varepsilon}(\tau) - r_{b,2}^{\varepsilon}(\tau) - r_{f,2}^{\varepsilon}(\tau)\|_{L^{2}(\Gamma^{\varepsilon})}^{2} \\ &+ \|r_{f,1}^{\varepsilon}(\tau) - r_{f,2}^{\varepsilon}(\tau)\|_{L^{2}(\Gamma^{\varepsilon})}^{2} \\ &\leq \mu_{1} \int_{0}^{\tau} \sum_{l=f,b} \|r_{l,1}^{\varepsilon} - r_{l,2}^{\varepsilon}\|_{L^{2}(\Gamma^{\varepsilon})}^{2} dt + \mu_{2} \int_{0}^{\tau} \|c_{1}^{\varepsilon} - c_{2}^{\varepsilon}\|_{L^{2}(\Gamma^{\varepsilon})}^{2} dt. \end{split}$$

Combining the last two inequalities and applying the Gronwall inequality imply the estimates for $||r_{l,1}^{\varepsilon}(\tau) - r_{l,2}^{\varepsilon}(\tau)||_{L^{2}(\Gamma^{\varepsilon})}^{2}$, with l = f, b, in terms of $||c_{1}^{\varepsilon} - c_{2}^{\varepsilon}||_{L^{2}((0,\tau)\times\Gamma^{\varepsilon})}^{2}$ for $\tau \in (0, T]$.

Considering $(c^{\varepsilon} - S)^+$, with some S > 0, as a test function in (3) and using the boundedness of r_f^{ε} and r_b^{ε} we obtain

$$\|(c^{\varepsilon} - S)^{+}\|_{L^{\infty}(0,T;L^{2}(\Omega^{*}_{\varepsilon}))} + \|\nabla(c^{\varepsilon} - S)^{+}\|_{L^{2}(\Omega^{*}_{\varepsilon,T})} \leq \mu_{1}S\left(\int_{0}^{T}|\Omega^{*,S}_{\varepsilon}(t)|dt\right)^{\frac{1}{2}},$$

where $S \ge \max\{\|c_0\|_{L^{\infty}(\Omega)}, \|\beta\|_{L^{\infty}(\Omega \times Y_1)}\|r_b^{\varepsilon}\|_{L^{\infty}(\Gamma_T^{\varepsilon})}, |F(0)|\}, \mu_1 \text{ is some positive constant, and } \Omega_{\varepsilon}^{*,S}(t) = \{x \in \Omega_{\varepsilon}^* : c^{\varepsilon}(t,x) > S\}.$ Then, Theorem II.6.1 in [20] yields the boundedness of c^{ε} in $(0, T) \times \Omega_{\varepsilon}^*$ for every fixed ε .

Considering now (3) for two solutions $(c_1^{\varepsilon}, r_{f,1}^{\varepsilon}, r_{b,1}^{\varepsilon})$ and $(c_2^{\varepsilon}, r_{f,2}^{\varepsilon}, r_{b,2}^{\varepsilon})$, we obtain the estimates for $||c_1^{\varepsilon} - c_2^{\varepsilon}||_{L^2(\Omega_{\varepsilon,\tau}^{\varepsilon})}^2$ and $\varepsilon ||c_1^{\varepsilon} - c_2^{\varepsilon}||_{L^2((0,\tau) \times \Gamma^{\varepsilon})}^2$ in terms of $\varepsilon ||r_{l,1}^{\varepsilon} - r_{l,2}^{\varepsilon}||_{L^2((0,\tau) \times \Gamma^{\varepsilon})}^2$, with l = f, b and $\tau \in (0, T]$. Using the estimates for $||r_{l,1}^{\varepsilon}(\tau) - r_{l,2}^{\varepsilon}(\tau)||_{L^2(\Gamma^{\varepsilon})}^2$ in terms of $||c_1^{\varepsilon} - c_2^{\varepsilon}||_{L^2((0,\tau) \times \Gamma^{\varepsilon})}^2$, shown above, and applying the Gronwall inequality, we conclude that $r_{l,1}^{\varepsilon} = r_{l,2}^{\varepsilon}$ on $(0, T) \times \Gamma^{\varepsilon}$, with l = f, b, and $c_1^{\varepsilon} = c_2^{\varepsilon}$ in $(0, T) \times \Omega_{\varepsilon}^{*}$.

The assumptions on the non-periodic microstructure of Ω_{ε}^* and the regularity of the transformation matrices *R* and *K* ensure the following extension result.

Lemma 2 For $x_j^{\varepsilon} \in \Omega$, and $u \in W^{1,p}(Y_{x_j^{\varepsilon},K}^{\varepsilon})$, with $p \in (1, +\infty)$ and $j \in \Xi_{\varepsilon}$, there exists an extension $\tilde{u} \in W^{1,p}(Y_{x_j^{\varepsilon}})$ from $Y_{x_i^{\varepsilon},K}^{\varepsilon}$ into $Y_{x_j^{\varepsilon}}$ such that

$$\|\tilde{u}\|_{L^{p}(Y_{x_{j}^{\varepsilon}})} \leq \mu \|u\|_{L^{p}(Y_{x_{j}^{\varepsilon},K}^{*})}, \qquad \|\nabla\tilde{u}\|_{L^{p}(Y_{x_{j}^{\varepsilon}})} \leq \mu \|\nabla u\|_{L^{p}(Y_{x_{j}^{\varepsilon},K}^{*})}, \tag{7}$$

where μ depends on Y_1 , Y_0 , R and K and is independent of ε and $j \in \Xi_{\varepsilon}$.

For $u \in W^{1,p}(\Omega_{\varepsilon}^*)$ we have an extension $\tilde{u} \in W^{1,p}(\Omega)$ from Ω_{ε}^* into Ω such that

$$\|\tilde{u}\|_{L^p(\Omega)} \le \mu \|u\|_{L^p(\Omega^*_{\varepsilon})}, \qquad \|\nabla\tilde{u}\|_{L^p(\Omega)} \le \mu \|\nabla u\|_{L^p(\Omega^*_{\varepsilon})}, \tag{8}$$

where μ depends on Y_1 , Y_0 , R and K and is independent of ε .

Proof (Sketch) The proof follows the same lines as in the periodic case, see e.g. [15, 19]. The only difference here is that the extension depends on the Lipschitz continuity of *K* and *R* and the uniform boundedness from above and below of $|\det K(x)|$ and $|\det R(x)|$ for all $x \in \overline{\Omega}$.

To show (8), we first consider the extension from $R_{x_j^{\varepsilon}}((Y_1 \setminus K_{x_j^{\varepsilon}}Y_0) + j)$ into $R_{x_j^{\varepsilon}}(Y_1 + j)$ and obtain the estimates in (7). Notice that due to the definition of K(x), the fibre radius varies between different fibres in the plywood-like structure of the heart tissue, but is constant along each individual fibre. Thus, apart from the end parts of the fibres near $\partial\Omega$, we have to extend u only in the directions orthogonal to the fibres. In the definition of Ω_{ε}^* we consider those j that $\varepsilon R_{x_j^{\varepsilon}}(\overline{Y}_1 + j) \subset \Omega$. Hence the extension for the end parts of the fibres near $\partial\Omega$, i.e., for such $R_{x_j^{\varepsilon}}((Y_1 \setminus K_{x_j^{\varepsilon}}Y_0) + j)$ that $\bigcup_{m \in \{0,1\}^3} \varepsilon R_{x_j^{\varepsilon}}(\overline{Y}_1 + j \pm m) \cap \partial\Omega \neq \emptyset$, is also well-defined. Since det R(x) = 1, and $0 < \rho_0^2 \le |\det K(x)| \le \rho_1^2 < \infty$ for all $x \in \overline{\Omega}$, we obtain that the constant μ in (7) is independent of x_j^{ε} , ε , and $j \in \Xi_{\varepsilon}$. Then scaling $R_{x_j^{\varepsilon}}((Y_1 \setminus K_{x_j^{\varepsilon}}Y_0) + j)$ and $R_{x_j^{\varepsilon}}(Y_1 + j)$ by ε and summing up over $j \in \Xi_{\varepsilon}$ in (7) imply (8).

In the case when the boundary $\partial \Omega$ crosses the fibres in a non-orthogonal way, we would obtain only a local extension to a subdomain $\Omega^{\delta} = \{x \in \Omega : \operatorname{dist}(x, \partial \Omega) > \delta\}$ for any fixed $\delta > 0$.

4 Derivation of Macroscopic Equations

To derive macroscopic equations for the microscopic problem posed in a domain with the non-periodic plywood-like microstructure, we approximate it by a problem defined in the domain with the corresponding locally periodic microstructure and apply the methods of locally periodic two-scale convergence (l-t-s) and l-p unfolding operator (see Appendix for the definitions and convergence results for l-t-s convergence and l-p unfolding operator). Notice that the regularity assumptions on the orientation angle γ are essential for the construction of an appropriate locally periodic microstructure for the non-periodic plywood-like structure.

To define the locally periodic microstructure related to the original non-periodic one, we consider, similarly to [8, 29], the partition covering of Ω by a family of open non-intersecting cubes $\{\Omega_n^{\varepsilon}\}_{1 \le n \le N_{\varepsilon}}$ of side ε^r , with 0 < r < 1, such that

$$\Omega \subset \bigcup_{n=1}^{N_{\varepsilon}} \overline{\Omega}_n^{\varepsilon} \quad \text{and} \quad \Omega_n^{\varepsilon} \cap \Omega \neq \emptyset.$$

For each $x \in \mathbb{R}^3$, we consider a transformation matrix $D(x) \in \mathbb{R}^{3\times 3}$ and assume that $D, D^{-1} \in \operatorname{Lip}(\mathbb{R}^3; \mathbb{R}^{3\times 3})$ and $0 < d_0 \le |\det D(x)| \le d_1 < \infty$ for all $x \in \overline{\Omega}$. The matrix D will be defined by the rotation matrix R and its derivatives and the specific form of D will be given later.

Then, the locally periodic microstructure is defined by considering a covering of Ω_n^{ε} by parallelepipeds $\varepsilon D_{x_n^{\varepsilon}} Y$ such that

$$\Omega_n^{\varepsilon} \subset \tilde{x}_n^{\varepsilon} + \bigcup_{\xi \in \Xi_n^{\varepsilon}} \varepsilon D_{x_n^{\varepsilon}}(\overline{Y} + \xi), \quad \text{where } \Xi_n^{\varepsilon} = \{\xi \in \mathbb{Z}^3 : \varepsilon D_{x_n^{\varepsilon}}(Y + \xi) \cap \Omega_n^{\varepsilon} \neq \emptyset\},$$

and points $x_n^{\varepsilon}, \tilde{x}_n^{\varepsilon} \in \Omega_n^{\varepsilon}$, for $n = 1, ..., N_{\varepsilon}$, are arbitrary chosen, but fixed. Here $Y = (0, 1)^3$, $D_x := D(x)$, and $D_{x_n^{\varepsilon}} = D(x_n^{\varepsilon})$ for $1 \le n \le N_{\varepsilon}$. Then, the perforated domain with locally periodic microstructure is given by

$$\widetilde{\Omega}_{\varepsilon}^{*} = \operatorname{Int}\left(\bigcup_{n=1}^{N_{\varepsilon}} \Omega_{n}^{*,\varepsilon}\right) \cap \Omega, \quad \text{with } \Omega_{n}^{*,\varepsilon} = \left(\widetilde{x}_{n}^{\varepsilon} + \bigcup_{\xi \in \Xi_{n}^{\varepsilon}} \varepsilon D_{x_{n}^{\varepsilon}}(\overline{Y}_{K_{x_{n}^{\varepsilon}}}^{*} + \xi)\right) \cap \overline{\Omega}_{n}^{\varepsilon}$$

where $Y_{K_{x_n^{\varepsilon}}}^* = Y \setminus \bigcup_{j \in \{0,1\}^3} (\widetilde{K}_{x_n^{\varepsilon}} Y_0 + j)$, with $\widetilde{K}_{x_n^{\varepsilon}} = \widetilde{K}(x_n^{\varepsilon})$ for $n = 1, ..., N_{\varepsilon}$, and the transformation matrix \widetilde{K} will be specified later. We shall also denote

$$\hat{\Omega}_n^{\varepsilon} = \tilde{x}_n^{\varepsilon} + \operatorname{Int}\left(\bigcup_{\xi \in \hat{\Xi}_n^{\varepsilon}} \varepsilon D_{x_n^{\varepsilon}}(\overline{Y} + \xi)\right) \quad \text{and} \quad \Lambda_{\varepsilon}^* = \widetilde{\Omega}_{\varepsilon}^* \setminus \bigcup_{n=1}^{N_{\varepsilon}} \hat{\Omega}_n^{\varepsilon},$$

where $\hat{\Xi}_n^{\varepsilon} = \{\xi \in \Xi_n^{\varepsilon} : \varepsilon D_{x_n^{\varepsilon}}(Y + \xi) \subset (\Omega_n^{\varepsilon} \cap \Omega)\}$. The boundaries of the locally periodic microstructure are defined as

$$\widetilde{\Gamma}^{\varepsilon} = \bigcup_{n=1}^{N_{\varepsilon}} \Gamma_n^{\varepsilon} \cap \Omega, \quad \text{where } \Gamma_n^{\varepsilon} = \left(\widetilde{x}_n^{\varepsilon} + \bigcup_{\xi \in \Xi_n^{\varepsilon}} \varepsilon D_{x_n^{\varepsilon}} (\widetilde{\Gamma}_{x_n^{\varepsilon}, K} + \xi) \right) \cap \Omega_n^{\varepsilon},$$

and

$$\hat{\Gamma}^{\varepsilon} = \bigcup_{n=1}^{N_{\varepsilon}} \left(\tilde{x}_{n}^{\varepsilon} + \bigcup_{\xi \in \hat{\Xi}_{n}^{\varepsilon}} \varepsilon D_{x_{n}^{\varepsilon}} (\widetilde{\Gamma}_{x_{n}^{\varepsilon}, K} + \xi) \right),$$

where $\widetilde{\Gamma}_{x_n^\varepsilon, K} = \widetilde{K}_{x_n^\varepsilon} \Gamma$ and $\Gamma = \overline{\partial Y_0 \setminus \Gamma_{0,1}}$. For the problem analyzed here, we shall consider $\widetilde{x}_n^\varepsilon = x_n^\varepsilon$.

The following calculations illustrate the motivation for the locally periodic approximation and determine formulas for the transformation matrices D and \tilde{K} . For $n = 1, ..., N_{\varepsilon}$, we choose such $\kappa_n \in \mathbb{Z}^3$ that for $x_n^{\varepsilon} = R_{x_n^{\varepsilon}} \varepsilon \kappa_n$ we have $x_n^{\varepsilon} \in \Omega_n^{\varepsilon}$. In the definition of covering of Ω_n^{ε} by shifted parallelepipeds, we consider a numbering of $\xi \in \Xi_n^{\varepsilon}$ and write

Then for $1 \le j \le I_n^{\varepsilon}$ we consider $k_j^n = \kappa_n + \xi_j$ and $x_{k_j^n}^{\varepsilon} = R_{k_j^n} \varepsilon k_j^n$. Here $R_{k_j^n} := R_{x_{k_j^n}^{\varepsilon}}$ and $R_{\kappa_n} := R_{x_n^{\varepsilon}}$.

Using the regularity assumptions on the function γ and considering the Taylor expansion of R^{-1} around x_n^{ε} , i.e. around $\varepsilon \kappa_{n,3}$, we obtain

where $\widetilde{W}_{x_n^{\varepsilon}} = \widetilde{W}(x_n^{\varepsilon})$ with $\widetilde{W}(x) = (I - \nabla R^{-1}(\gamma(x_3))x)$. The notation of the gradient is understood as $\nabla R^{-1}(\gamma(x))x = \nabla_z (R^{-1}(\gamma(z))x)|_{z=x}$. Thus, for $x, x_n^{\varepsilon} \in \Omega_n^{\varepsilon}$, since $|x - x_n^{\varepsilon}| \le C\varepsilon^r$, the distance between $R_{x_n^{\varepsilon}}^{-1}(x - x_n^{\varepsilon}) - \widetilde{W}_{x_n^{\varepsilon}} \xi_j \varepsilon$ and $R_{k_j^{n}}^{-1}(x - x_{k_j^{n}}^{\varepsilon})$ is of the order $\sup_{1 \le j \le I_n^{\varepsilon}} |\xi_j \varepsilon|^2 \sim \varepsilon^{2r}$. This calculation together with the estimates below will ensure that the non-periodic plywood-like structure can be approximated by the corresponding locally periodic microstructure, comprising $\widetilde{Y}_{x_n^{\varepsilon}}$ -periodic structure in each Ω_n^{ε} for $n = 1, \ldots, N_{\varepsilon}$, and $|\Omega_n^{\varepsilon}| \sim \varepsilon^{3r}$ for an appropriate $r \in (0, 1)$. Here $\widetilde{Y}_x = D(x)Y$, with $D(x) = R_x W(x)$, and

where $w(x) = \gamma'(x_3)(\cos(\gamma(x_3))x_1 + \sin(\gamma(x_3))x_2)$ and $R_x = R(\gamma(x_3))$. The transformation matrix \widetilde{K} is defined as $\widetilde{K}(x) = W^{-1}(x)K(x)$ and the boundary of the muscle fibres in the locally periodic approximation is given by $\widetilde{\Gamma}_x = D(x)\widetilde{K}(x)\Gamma = R_x K(x)\Gamma$.

The definitions of *R*, *W* and γ ensure that the transformation matrices *D* and \widetilde{K} are Lipschitz continuous, as well as $0 < d_0 \le |\det D(x)| \le d_1 < \infty$ and $0 < \rho_0^2 \le |\det \widetilde{K}(x)| \le \rho_1^2 < \infty$ for all $x \in \overline{\Omega}$. Since ϑ is independent of the first variable, we consider in the definition of W(x) the shift only in the second variable. Notice that if the original microstructure would be locally periodic, i.e. $R(\gamma(x_3)) = R(\gamma(x_{n,3}^{\varepsilon}))$ for $x \in \Omega_n^{\varepsilon}$ and some $x_n^{\varepsilon} \in \Omega_n^{\varepsilon}$, then the matrix *W* would be constant in each Ω_n^{ε} and we would obtain $D(x) = R(\gamma(x_3))$ for $x \in \Omega$.

In the approximation of the problem posed in the domain with the non-periodic plywoodlike structure, we shall use the following lemma, proven in [6], that facilitate the estimate for the difference between the values of the characteristic function at two different points.

Lemma 3 ([6]) Let χ_b be the characteristic function of the fibre of radius b, i.e., $\chi_b(x) = 1$ for $|\hat{x}| \le b$ and $\chi_b(x) = 0$ for $|\hat{x}| > b$, with $\hat{x} = (x_2, x_3)$. Then

where *L* is the length of the fibre and the constant *C* is independent of *b*, δ , and *L*.

Deriving estimates for the difference of solutions of the original microscopic problem and the corresponding locally periodic approximation and applying techniques of locally periodic homogenization, we obtain the following macroscopic equations for the microscopic problem (1) and (2).

Theorem 1 A sequence of solutions of the microscopic problem (1) and (2) converges to a solution

Proof Using calculations from above, we consider a domain with a locally periodic microstructure characterised by the periodicity cell $\widetilde{Y}_{x_n^{\varepsilon}} = D_{x_n^{\varepsilon}} Y$ in each Ω_n^{ε} , with $n = 1, \ldots, N_{\varepsilon}$ and the shift $x_n^{\varepsilon} \in \Omega_n^{\varepsilon}$ in the covering of Ω_n^{ε} by $D_{x_n^{\varepsilon}}(Y + \xi)$, with $\xi \in \Xi_n^{\varepsilon}$.

Then, the characteristic function of the extracellular space $\widetilde{\Omega}_{\varepsilon}^*$ in a tissue with locally periodic microstructure is defined by $\chi_{\widetilde{\Omega}_{\varepsilon}^*} = (1 - \chi_{\widetilde{\Omega}_{f}^{\varepsilon}})\chi_{\Omega}$, where $\chi_{\widetilde{\Omega}_{f}^{\varepsilon}}$ denotes the characteristic function of fibres

The boundaries of the locally periodic microstructure are denoted by

Notice that non-periodic changes in the shape of the perforations (radius of muscle fibres) are approximated by the same transformation matrix K(x). This is consistent with the results obtained in [10, 11, 23, 33]. However spatial changes in the periodicity are approximated by $D_x = R_x W_x$.

The reaction rates (binding and dissociation rates) are defined in terms of locally periodic microstructure in the following way

To show that we can approximate the problem (1) and (2) by a microscopic problem defined in the domain with the locally periodic microstructure, we have to prove that the

difference between the characteristic function of the original domain $\chi_{\Omega_{\varepsilon}^*}$ and of the locally periodic perforated domain $\chi_{\widetilde{\Omega}_{\varepsilon}^*}$ converges to zero strongly in $L^2(\Omega)$ as $\varepsilon \to 0$. Also, we have to show that the difference between boundary integrals and their locally periodic approximations converges to zero as $\varepsilon \to 0$. This will ensure that as $\varepsilon \to 0$ the sequence of solutions of the original microscopic problem (1)–(2) will converge to a solution of the macroscopic equations obtained by homogenization of the corresponding problem defined in the domain with locally periodic microstructure.

For the difference between $\chi_{\Omega_{\epsilon}^{*}}$ and $\chi_{\widetilde{\Omega}_{\epsilon}^{*}}$, we have

where $x_n^{\varepsilon} = R_{x_n^{\varepsilon}} \varepsilon \kappa_n$, $x_{k_j}^{\varepsilon} = R_{x_{k_j}^{\varepsilon}} \varepsilon k_j$, with $k_j = \kappa_n + j$, and

We notice that $\varepsilon^3 |J_n^{\varepsilon}| \le C \varepsilon^{3r}$ and $|N_{\varepsilon}| \le C \varepsilon^{-3r}$. For the first integral, we have

To estimate the second integral, we use Lemma 3. Since in each Ω_n^{ε} the length of fibres is of order ε^r , applying estimate in Lemma 3, equality (9), and the estimates $N_{\varepsilon} \leq C\varepsilon^{-3r}$ and $|J_n^{\varepsilon}| \leq C\varepsilon^{3(r-1)}$, we conclude that

To estimate the difference between boundary integral we have to extend c^{ε} , r_{f}^{ε} , and r_{b}^{ε} from Ω_{ε}^{*} to Ω . For c^{ε} , we can consider the extension as in Lemma 2. Then, using the extended \tilde{c}^{ε} and the fact that the reaction rates and the initial data are defined on whole Ω we can extend r_{f}^{ε} and r_{b}^{ε} to Ω as solutions of the ordinary differential equations with \tilde{c}^{ε} instead of c^{ε}

The non-negativity of c^{ε} and the construction of the extension ensure that \tilde{c}^{ε} is non-negative. Then, in the same way as for r_f^{ε} and r_b^{ε} , using the properties of p and the non-negativity of the coefficients and initial data, we obtain the non-negativity of $\tilde{r}_f^{\varepsilon}$ and $\tilde{r}_b^{\varepsilon}$. Thus, adding the equations for $\tilde{r}_f^{\varepsilon}$ and $\tilde{r}_b^{\varepsilon}$, we obtain the boundedness of $\tilde{r}_f^{\varepsilon}$ and $\tilde{r}_b^{\varepsilon}$ in Ω_T , i.e.

where the constants μ_j , with j = 2, 3, 4, depend on the derivatives of α , β , and μ_j , with j = 1, 2, 3, 4, are independent of ε . Hence, for each $\varepsilon > 0$, the extensions $\tilde{r}_f^{\varepsilon}, \tilde{r}_b^{\varepsilon}$, and \tilde{c}^{ε} are well-defined on the boundaries $\tilde{\Gamma}^{\varepsilon}$ of the locally periodic microstructure. In what follows we shall use the same notation for a function and for its extension.

Notice that ε^{-1} in the estimates for ∇r_f^{ε} and ∇r_b^{ε} will be compensated by ε in the estimate for the difference between neighbouring points in non-periodic and locally periodic domains, respectively, i.e.

for $\psi \in C^1(\overline{\Omega}_T)$, where $K_x^R = R_x K_x$. Considering the regularity of K and R and the uniform boundedness from below and above of $|\det K|$, and using the trace estimate for the $L^2(\Gamma)$ -norm of a $H^{\varsigma}(Y)$ -function, with $\varsigma \in (1/2, 1)$, the first integral we can estimate as

Thus, we conclude that for $r \in (1/2, 1)$, the difference between the boundary integrals for non-periodic and locally periodic microstructures converges to zero as $\varepsilon \to 0$.

Notice that since the extensions of c^{ε} and r_l^{ε} , with l = f, b, are in $L^2(0, T; H^1(\Omega))$ and $\partial \Omega$ is Lipschitz continuous, we can extend them to $L^2(0, T; H^1(\Omega_1))$ with $\Omega \subset \Omega_1$.

Now, we rewrite the weak formulation of the microscopic equation for c^{ε} as

The definition of $\widetilde{\Omega}_{\varepsilon}^*$, $\widetilde{\Gamma}^{\varepsilon}$, $\widetilde{\alpha}^{\varepsilon}$, and $\widetilde{\beta}^{\varepsilon}$ implies that the original non-periodic problem is approximated by equations posed in a domain with locally periodic microstructure. Hence we can apply the methods of locally periodic two-scale convergence (l-t-s) and l-p unfolding operator to derive the limit equations.

Using the extension of c^{ε} , we have that the sequences $\{c^{\varepsilon}\}$, $\{\nabla c^{\varepsilon}\}$ and $\{\partial_t c^{\varepsilon}\}$ are defined on Ω_T and we can determine $\mathcal{T}^{\varepsilon}_{\mathcal{L}}(c^{\varepsilon})$, $\mathcal{T}^{\varepsilon}_{\mathcal{L}}(\nabla c^{\varepsilon})$, $\partial_t \mathcal{T}^{\varepsilon}_{\mathcal{L}}(c^{\varepsilon})$, and $\mathcal{T}^{b,\varepsilon}_{\mathcal{L}}(c^{\varepsilon})$. The regularity assumptions on γ and K ensure that $\chi_{\widetilde{Y}_{x,K}^*} \in L^{\infty}(\bigcup_{x \in \Omega} \{x\} \times \widetilde{Y}_x)$ and $\chi_{\widetilde{Y}_{x,K}^*} \in C(\overline{\Omega}; L_{per}^p(\widetilde{Y}_x))$ for $p \in (1, +\infty)$.

Applying the results from [30] we obtain $\mathcal{T}_{\mathcal{L}}^{\varepsilon}(\chi_{\widetilde{\Omega}_{\varepsilon}^{\varepsilon}}^{\varepsilon})(x, \tilde{y}) \to \chi_{\widetilde{Y}_{x,K}^{\varepsilon}}(x, D_{x}\tilde{y})$ in $L^{p}(\Omega \times Y)$ and $\mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(\widetilde{\beta}^{\varepsilon})(x, \bar{y}) \to \widetilde{\beta}(x, D_{x}\widetilde{K}_{x}\bar{y}), \mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(\widetilde{\alpha}^{\varepsilon})(x, \bar{y}) \to \widetilde{\alpha}(x, D_{x}\widetilde{K}_{x}\bar{y})$ in $L^{p}(\Omega \times \Gamma)$ for $p \in (1, +\infty)$, as $\varepsilon \to 0$.

Using the a priori estimates for c^{ε} , r_{f}^{ε} and r_{b}^{ε} , the strong convergence of $\mathcal{T}_{\mathcal{L}}^{\varepsilon}(c^{\varepsilon})$ in $L^{2}(\Omega_{T}; H^{1}(Y))$, the strong convergence and boundedness of $\mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(\widetilde{\alpha}^{\varepsilon})$, the weak convergence and boundedness of $\mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(\widetilde{\alpha}^{\varepsilon})$, the weak convergence and boundedness of $\mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(\widetilde{\alpha}^{\varepsilon})$, the weak convergence and boundedness of $\mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(\widetilde{\alpha}^{\varepsilon})$, together with the regularity of D, γ , and K, and the strong convergence of $\mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(\psi^{\varepsilon})$, we obtain

$$\begin{split} &\lim_{\varepsilon \to 0} \left\langle \sum_{n=1}^{N_{\varepsilon}} \frac{\sqrt{g_{x_{n}^{\varepsilon}}}}{\sqrt{g} |\widetilde{Y}_{x_{n}^{\varepsilon}}|} \mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(\widetilde{\alpha}^{\varepsilon}) \mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(c^{\varepsilon}) \mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(r_{f}^{\varepsilon}) \chi_{\Omega_{n}^{\varepsilon}}, \mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(\psi^{\varepsilon}) \right\rangle_{\Omega_{T} \times \Gamma} \\ &= \left\langle \frac{\sqrt{g_{x}}}{\sqrt{g} |\widetilde{Y}_{x}|} \widetilde{\alpha}(x, D_{x}\widetilde{K}_{x}\bar{y}) c(t, x) r_{f}(t, x, D_{x}\widetilde{K}_{x}\bar{y}), \psi_{1}(t, x) \right\rangle_{\Omega_{T} \times \Gamma} \end{split}$$

Similar arguments along with the Lipschitz continuity of *F* and the strong convergence of $\mathcal{T}_{\mathcal{L}}^{\varepsilon}(\chi_{\widetilde{\Omega}^*}^{\varepsilon})$ ensure

$$\langle \mathcal{T}^{\varepsilon}_{\mathcal{L}}(\chi^{\varepsilon}_{\widetilde{\Omega}^{*}_{\varepsilon}}) F(\mathcal{T}^{\varepsilon}_{\mathcal{L}}(c^{\varepsilon})), \mathcal{T}^{\varepsilon}_{\mathcal{L}}(\psi^{\varepsilon}) \rangle_{\Omega_{T} \times Y} \to \langle \chi^{\infty}_{Y_{x,K}}(x, D_{x}\tilde{y}) F(c), \psi_{1} \rangle_{\Omega_{T} \times Y}$$

as $\varepsilon \to 0$. Using the convergence results (16), the strong convergence of $\mathcal{T}_{\mathcal{L}}^{\varepsilon}(\psi^{\varepsilon})$ and $\mathcal{T}_{\mathcal{L}}^{\varepsilon}(\nabla\psi^{\varepsilon})$ and the fact that $|\Lambda_{\varepsilon}^{*}| \to 0$ as $\varepsilon \to 0$, taking the limit as $\varepsilon \to 0$, and considering the change of variables $y = D_x \tilde{y}$ for $\tilde{y} \in Y$ and $y = D_x \tilde{K}_x \bar{y}$ for $\bar{y} \in \Gamma$, we obtain

$$\begin{split} \langle |\widetilde{Y}_{x}|^{-1}c,\psi_{1}\rangle_{\widetilde{Y}_{x,K}^{*}\times\Omega_{T}}^{*} + \langle |\widetilde{Y}_{x}|^{-1}A(\nabla c + \nabla_{y}c_{1}),\nabla\psi_{1} + \nabla_{y}\psi_{2}\rangle_{\widetilde{Y}_{x,K}^{*}\times\Omega_{T}}^{*} \\ + \langle |\widetilde{Y}_{x}|^{-1}\left[\widetilde{\alpha}(x,y)r_{f}c - \widetilde{\beta}(x,y)r_{b}\right],\psi_{1}\rangle_{\widetilde{\Gamma}_{x}\times\Omega_{T}}^{*} = \langle |\widetilde{Y}_{x}|^{-1}F(c),\psi_{1}\rangle_{\widetilde{Y}_{x,K}^{*}\times\Omega_{T}}^{*}. \end{split}$$

Considering $\psi_1(t, x) = 0$ for $(t, x) \in \Omega_T$, we obtain

$$c_1(t, x, y) = \sum_{j=1}^3 \partial_{x_j} c(t, x) w^j(x, y),$$

where w^j are solutions of (12). Choosing $\psi_2(t, x, y) = 0$ for $(t, x) \in \Omega_T$ and $y \in \widetilde{Y}_x$ yields the macroscopic equation for *c*.

Using the strong convergence of $\mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(c^{\varepsilon})$ in $L^2(\Omega_T; L^2(\Gamma))$, estimates (5a)–(5b) and (6), and the Lipschitz continuity of p we obtain that $\{\mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(r_j^{\varepsilon})\}$ is a Cauchy sequence in $L^2(\Omega_T; L^2(\Gamma))$ for j = f, b, and hence upto a subsequence, $\mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(r_j^{\varepsilon}) \to r_j(\cdot, \cdot, D_x \widetilde{K}_x \cdot)$ strongly in $L^2(\Omega_T; L^2(\Gamma))$. Then applying the l-p boundary unfolding operator to the equations on $\widetilde{\Gamma}^{\varepsilon}$ and taking the limit as $\varepsilon \to 0$ we obtain the equations for r_f and r_b . The proof of the uniqueness of a solution of the macroscopic problem is similar to the corre- sponding proof for the microscopic problem, and hence the convergence of the whole sequences of solutions of the microscopic problem follows.

Remark 1 Notice that for the proof of the homogenization results it is sufficient to have a local extension of c^{ε} from Ω_{ε}^* to Ω^{δ} , with $\Omega^{\delta} = \{x \in \Omega : \operatorname{dist}(x, \partial \Omega) > \delta\}$ for any fixed $\delta > 0$, and hence, the local strong convergence of $\mathcal{T}_{\mathcal{L}}^{\varepsilon}(c^{\varepsilon})$, i.e., the strong convergence in $L^2(0, T; L^2_{\operatorname{loc}}(\Omega; H^1(Y)))$.

Remark 2 For numerical computations of the cell problems (12) and the ordinary differential equations (11), defining the dynamics of receptor densities, approaches from the two-scale finite element method [24] or the heterogeneous multiscale method [1, 2, 17, 18] can be applied.

Appendix: Definition and Convergence Results for the l-t-s Convergence and l-p Unfolding Operator

We shall consider the space $C(\overline{\Omega}; C_{per}(\widetilde{Y}_x))$ given in a standard way, i.e. for any $\widetilde{\psi} \in C(\overline{\Omega}; C_{per}(Y))$ the relation $\psi(x, y) = \widetilde{\psi}(x, D_x^{-1}y)$ with $x \in \Omega$ and $y \in \widetilde{Y}_x$ yields $\psi \in C(\overline{\Omega}; C_{per}(\widetilde{Y}_x))$. In the same way the spaces $L^p(\Omega; C_{per}(\widetilde{Y}_x))$, $L^p(\Omega; L_{per}^q(\widetilde{Y}_x))$ and $C(\overline{\Omega}; L_{per}^q(\widetilde{Y}_x))$, for $1 \le p \le \infty$, $1 \le q < \infty$, are given.

Due to the assumptions on D, i.e. $D \in \operatorname{Lip}(\overline{\Omega})$ and $0 < d_0 \le |\det D(x)| \le d_1 < \infty$ for all $x \in \overline{\Omega}$, we obtain that the function $u : \Omega \to C(\widetilde{Y}_x)$ is well-defined. The separability of $C_{\operatorname{per}}(\widetilde{Y}_x)$ for each $x \in \Omega$ and the Weierstrass approximation for continuous functions $u : \Omega \to C_{\operatorname{per}}(\widetilde{Y}_x)$ ensure the separability of $C(\overline{\Omega}; C_{\operatorname{per}}(\widetilde{Y}_x))$. Also, we have the following relation for the norm $\|\psi\|_{C(\overline{\Omega}; C_{\operatorname{per}}(\widetilde{Y}_x))} := \sup_{x \in \overline{\Omega}} \sup_{y \in \widetilde{Y}_x} |\psi(x, y)|$:

The assumptions on D and K ensure that

$$L^{2}(\Omega; L^{2}(\widetilde{\Gamma}_{x})) = \{ u : \bigcup_{x \in \Omega} (\{x\} \times \widetilde{\Gamma}_{x}) \to \mathbb{R} \text{ measurable, with}$$
$$u(x) \in L_{2}(\widetilde{\Gamma}_{x}) \text{ for a.e. } x \in \Omega \text{ and} \int_{\Omega} \|u\|_{L^{2}(\widetilde{\Gamma}_{x})}^{2} dx < \infty \}$$

are well-defined, separable Hilbert spaces, see e.g. [16, 26, 32].

Consider $\psi \in C(\overline{\Omega}; C_{per}(\widetilde{Y}_x))$ and corresponding $\widetilde{\psi} \in C(\overline{\Omega}; C_{per}(Y))$. As a locally periodic (l-p) approximation of ψ , we name $\mathcal{L}^{\varepsilon} : C(\overline{\Omega}; C_{per}(\widetilde{Y}_x)) \to L^{\infty}(\Omega)$ given by, see [29],

If we choose $\tilde{x}_n^{\varepsilon} = D_{x_n^{\varepsilon}} \varepsilon k$ for some $k \in \mathbb{Z}^3$, then the periodicity of $\tilde{\psi}$ implies

for $x \in \Omega$, see e.g. [29] for more details. In the similar way, we define $\mathcal{L}^{\varepsilon}\psi$ and $\mathcal{L}_{0}^{\varepsilon}\psi$ for ψ in $C(\overline{\Omega}; L_{per}^{q}(\widetilde{Y}_{x}))$ or $L^{p}(\Omega; C_{per}(\widetilde{Y}_{x}))$.

We define also a regular approximation of $\mathcal{L}^{\varepsilon}\psi$

$$(\mathcal{L}_{\rho}^{\varepsilon}\psi)(x) = \sum_{n=1}^{N_{\varepsilon}} \widetilde{\psi}\left(x, \frac{D_{x_{n}^{\varepsilon}}^{-\varepsilon}x}{\varepsilon}\right) \phi_{\Omega_{n}^{\varepsilon}}(x) \quad \text{for } x \in \Omega,$$

where $\phi_{\Omega_n^{\varepsilon}}$ are approximations of $\chi_{\Omega_n^{\varepsilon}}$ such that $\phi_{\Omega_n^{\varepsilon}} \in C_0^{\infty}(\Omega_n^{\varepsilon})$ and

$$\sum_{n=1}^{N_{\varepsilon}} |\phi_{\Omega_n^{\varepsilon}} - \chi_{\Omega_n^{\varepsilon}}| \to 0 \text{ in } L^2(\Omega), \quad \|\nabla^m \phi_{\Omega_n^{\varepsilon}}\|_{L^{\infty}(\mathbb{R}^d)} \le C\varepsilon^{-\rho m} \text{ for } 0 < r < \rho < 1.$$

We recall here the definition of locally periodic two-scale (l-t-s) convergence and l-p unfolding operator, see [29, 30] for details.

Definition 2 ([29]) Let $u^{\varepsilon} \in L^{p}(\Omega)$ for all $\varepsilon > 0$ and $1 . where $\mathcal{L}^{\varepsilon}$ is the l-p approximation of ψ and 1/p + 1/q = 1.

Definition 3 ([30]) A sequence $\{u^{\varepsilon}\} \subset L^{p}(\widetilde{\Gamma}^{\varepsilon})$, with $1 , is said to converge locally periodic two-scale (l-t-s) to <math>u \in L^{p}(\Omega; L^{p}(\widetilde{\Gamma}_{x}))$ if

$$\varepsilon \| u^{\varepsilon} \|_{L^{p}(\widetilde{\Gamma}^{\varepsilon})}^{p} \leq C$$

and for any $\psi \in C(\overline{\Omega}; C_{per}(\widetilde{Y}_x))$

$$\lim_{\varepsilon \to 0} \varepsilon \int_{\widetilde{\Gamma}^{\varepsilon}} u^{\varepsilon}(x) \mathcal{L}^{\varepsilon} \psi(x) d\sigma_{x} = \int_{\Omega} \frac{1}{|\widetilde{Y}_{x}|} \int_{\widetilde{\Gamma}_{x}} u(x, y) \psi(x, y) d\sigma_{y} dx,$$

where $\mathcal{L}^{\varepsilon}$ is the l-p approximation of ψ defined in (17).

Lemma 4 ([30]) For $\psi \in C(\overline{\Omega}; C_{per}(\widetilde{Y}_x))$ and $1 \le p < \infty$, we have that

$$\lim_{\varepsilon \to 0} \varepsilon \int_{\widetilde{\Gamma}^{\varepsilon}} |\mathcal{L}^{\varepsilon} \psi(x)|^{p} d\sigma_{x} = \int_{\Omega} \frac{1}{|\widetilde{Y}_{x}|} \int_{\widetilde{\Gamma}_{x}} |\psi(x, y)|^{p} d\sigma_{y} dx.$$

Definition 4 ([30]) For any Lebesgue-measurable on Ω function ψ the locally periodic unfolding operator (1-p unfolding operator) $\mathcal{T}_{\mathcal{L}}^{\varepsilon}$ is defined as

$$\mathcal{T}_{\mathcal{L}}^{\varepsilon}(\psi)(x, y) = \sum_{n=1}^{N_{\varepsilon}} \psi \left(\varepsilon D_{x_{n}^{\varepsilon}} \left[D_{x_{n}^{\varepsilon}}^{-1} x/\varepsilon \right]_{Y} + \varepsilon D_{x_{n}^{\varepsilon}} y \right) \chi_{\hat{\Omega}_{n}^{\varepsilon}}(x)$$

for $x \in \Omega$ and $y \in Y$.

The definition implies that $\mathcal{T}_{\mathcal{L}}^{\varepsilon}(\phi)$ is Lebesgue-measurable on $\Omega \times Y$ and is zero for $x \in \Lambda^{\varepsilon}$, where $\Lambda^{\varepsilon} = \bigcup_{n=1}^{N_{\varepsilon}} (\Omega_n^{\varepsilon} \setminus \hat{\Omega}_n^{\varepsilon}) \cap \Omega$.

Definition 5 ([30]) For any Lebesgue-measurable on $\widetilde{\Gamma}^{\varepsilon}$ function ψ the l-p boundary unfolding operator $\mathcal{T}_{\mathcal{L}}^{b,\varepsilon}$ is defined as

$$\mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(\psi)(x,y) = \sum_{n=1}^{N_{\varepsilon}} \psi \left(\varepsilon D_{x_{n}^{\varepsilon}} \left[D_{x_{n}^{\varepsilon}}^{-1} x/\varepsilon \right]_{Y} + \varepsilon D_{x_{n}^{\varepsilon}} \widetilde{K}_{x_{n}^{\varepsilon}} y \right) \chi_{\hat{\Omega}_{n}^{\varepsilon}}(x)$$

for $x \in \Omega$ and $y \in \Gamma$.

These definitions provide a generalization of the periodic unfolding operator and periodic boundary unfolding operator introduced in [12–14] to locally periodic microstructures.

Theorem 2 ([30]) For a sequence $\{w^{\varepsilon}\} \subset L^{p}(\Omega)$, with $p \in (1, \infty)$, satisfying

$$\mathcal{T}_{\mathcal{L}}^{\varepsilon}(w^{\varepsilon}) \to w(\cdot, D_x \cdot) \qquad \text{weakly in } L^p(\Omega; W^{1,p}(Y)),$$
$$\varepsilon \mathcal{T}_{\mathcal{L}}^{\varepsilon}(\nabla w^{\varepsilon}) \to D_x^{-T} \nabla_y w(\cdot, D_x \cdot) \quad \text{weakly in } L^p(\Omega \times Y).$$

Theorem 3 ([30]) For a sequence $\{w^{\varepsilon}\} \subset W^{1,p}(\Omega)$, with $p \in (1, \infty)$, that converges weakly to w in $W^{1,p}(\Omega)$, there exist a subsequence (denoted again by $\{w^{\varepsilon}\}$) and a function $w_1 \in L^p(\Omega; W^{1,p}_{per}(\widetilde{Y}_x))$ such that

$$\mathcal{T}_{\mathcal{L}}^{\varepsilon}(w^{\varepsilon}) \to w \qquad \text{weakly in } L^{p}(\Omega; W^{1,p}(Y)),$$
$$\mathcal{T}_{\mathcal{L}}^{\varepsilon}(\nabla w^{\varepsilon})(\cdot, \cdot) \to \nabla_{x} w(\cdot) + D_{x}^{-T} \nabla_{y} w_{1}(\cdot, D_{x} \cdot) \text{ weakly in } L^{p}(\Omega \times Y).$$

Theorem 4 ([30]) For a sequence $\{w^{\varepsilon}\} \subset L^{p}(\widetilde{\Gamma}^{\varepsilon})$, with $p \in (1, \infty)$, satisfying

$$\varepsilon \| w^{\varepsilon} \|_{L^{p}(\widetilde{\Gamma}^{\varepsilon})}^{p} \leq C$$

there exist a subsequence (denoted again by $\{w^{\varepsilon}\}$) and $w \in L^{p}(\Omega; L^{p}(\widetilde{\Gamma}_{x}))$ such that

 $w^{\varepsilon} \rightarrow w$ locally periodic two-scale (l-t-s).

Theorems 4 and 5 imply that for $\{w^{\varepsilon}\} \subset L^{p}(\widetilde{\Gamma}^{\varepsilon})$ with $\varepsilon \|w^{\varepsilon}\|_{L^{p}(\widetilde{\Gamma}^{\varepsilon})}^{p} \leq C$ we have the weak convergence of $\{\mathcal{T}_{\mathcal{L}}^{b,\varepsilon}(w^{\varepsilon})\}$ in $L^{p}(\Omega \times \Gamma)$, where $p \in (1, \infty)$.
