# Bayesian Assessment of Availabilities and Unavailabilities of Multistate Monotone Systems

#### Abstract

In the present paper we consider a multistate monotone system of multistate components. Following a Bayesian approach, the ambition is to arrive at the posterior distributions of the system availabilities and unavailabilities to the various levels in a fixed time interval based on both prior information and data on both the components and the system. We argue that a realistic approach is to start out by describing our uncertainty on the component availabilities and unavailabilities to the various levels in a fixed time interval, based on both prior information and data on the components, by the moments up till order $m$ of their marginal distributions. From these moments analytic bounds on the corresponding moments of the system availabilities and unavailabilities to the various levels in a fixed time interval are arrived at. Applying these bounds and prior system information we may then fit prior distributions of the system availabilities and unavailabilities to the various levels in a fixed time interval. These can in turn be updated by relevant data on the system. This generalizes results given in Natvig and Eide (Scand J Statist 14:319-327, 1987) considering a binary monotone system of binary components at a fixed point of time. Furthermore, considering a simple network system, we show that the analytic bounds can be slightly improved by straightforward simulation techniques.

## 1 Basic Definitions and Ideas

Let $S=\{0,1, \ldots, M\}$ be the set of states of the system; the $M+1$ states representing successive levels of performance ranging from the perfect functioning level $M$ down to the complete failure level 0 . Furthermore, let $C=\{1, \ldots, n\}$ be the set of components and in general $S_{i}, i=1, \ldots, n$ the set of states of the $i$ th component. We require $\{0, M\} \subseteq S_{i} \subseteq S$. Hence, the states 0 and $M$ are chosen to represent the endpoints of a performance scale that might be used for both the system and its components. Note that in most applications there is no need for the same detailed description of the components as for the system.

Let $x_{i}, i=1, \ldots, n$ denote the state or performance level of the $i$ th component at a fixed point of time and $\boldsymbol{x}=\left(x_{1}, \ldots, x_{n}\right)$. It is assumed that the state, $\phi$, of the system at the fixed point of time is a deterministic function of $\boldsymbol{x}$; i.e. $\phi=\phi(\boldsymbol{x})$. Here $\boldsymbol{x}$ takes values in $S_{1} \times S_{2} \times \cdots \times S_{n}$ and $\phi$ takes values in $S$. The function $\phi$ is called the structure function of the system. We often denote a multistate system by $(C, \phi)$.

We start by giving a series of basic definitions.

Definition 1 A system is a multistate monotone system (MMS) iff its structure function $\phi$ satisfies:
(i) $\phi(\boldsymbol{x})$ is non-decreasing in each argument
(ii) $\quad \phi(\mathbf{0})=0$ and $\phi(\boldsymbol{M})=M \quad \mathbf{0}=(0, \ldots, 0), \boldsymbol{M}=(M, \ldots, M)$.

Definition 2 The monotone system $(A, \chi)$ is a module of the monotone system (C, $\phi$ ) iff

\phi(\boldsymbol{x})=\psi\left[\chi\left(\boldsymbol{x}^{A}\right), \boldsymbol{x}^{A^{c}}\right],
$$

where $\psi$ is a monotone structure function and $A \subseteq C$.

Intuitively, a module is a monotone subsystem that acts as if it were just a supercomponent.

Definition 3 A modular decomposition of a monotone system $(C, \phi)$ is a set of disjoint modules $\left\{\left(A_{k}, \chi_{k}\right)\right\}_{k=1}^{r}$ together with an organizing monotone structure function $\psi$, i.e.
(i) $C=\cup_{i=1}^{r} A_{i}$ where $A_{i} \cap A_{j}=\emptyset \quad i \neq j$,
(ii) $\phi(\boldsymbol{x})=\psi\left[\chi_{1}\left(\boldsymbol{x}^{A_{1}}\right), \ldots, \chi_{r}\left(\boldsymbol{x}^{A_{r}}\right)\right]=\psi[\chi(\boldsymbol{x})]$.

Making a modular decomposition of a system is a way of breaking it into a collection of subsystems which can be dealt with more easily.

In the following $\boldsymbol{y}<\boldsymbol{x}$ means that $y_{i} \leq x_{i}$ for $i=1, \ldots, n$, and $y_{i}<x_{i}$ for some $i$.

Definition 4 Let $\phi$ be the structure function of an MMS and let $j \in\{1, \ldots, M\}$. A vector $\boldsymbol{x}$ is said to be a path vector to level $j$ iff $\phi(\boldsymbol{x}) \geq j$. The corresponding path set is given by $C_{\phi}^{j}(\boldsymbol{x})=\left\{i \mid x_{i} \geq 1\right\}$. A minimal path vector to level $j$ is a path vector $\boldsymbol{x}$ such that $\phi(\boldsymbol{y})<j$ for all $\boldsymbol{y}<\boldsymbol{x}$. The corresponding path set is also said to be minimal.

Definition 5 Let $\phi$ be the structure function of an MMS and let $j \in\{1, \ldots, M\}$. A vector $\boldsymbol{x}$ is said to be a cut vector to level $j$ iff $\phi(\boldsymbol{x})<j$. The corresponding cut set is given by $D_{\phi}^{j}(\boldsymbol{x})=\left\{i \mid x_{i}<M\right\}$. A minimal cut vector to level $j$ is a cut vector $\boldsymbol{x}$ such that $\phi(\boldsymbol{y}) \geq j$ for all $\boldsymbol{y}>\boldsymbol{x}$. The corresponding cut set is also said to be minimal.

We now consider the relation between the stochastic performance of the system $(C, \phi)$ and the stochastic performances of the components. Let $\tau$ be an index set contained in $[0, \infty)$.

Definition 6 The performance process of the $i$ th component, $i=1, \ldots, n$ is a stochastic process $\left\{X_{i}(t), t \in \tau\right\}$, where for each fixed $t \in \tau, X_{i}(t)$ is a random variable which takes values in $S_{i} . X_{i}(t)$ denotes the state of the $i$ th component at time $t$. The joint performance process for the components $\{\boldsymbol{X}(t), t \in \tau\}=\left\{\left(X_{1}(t), \ldots, X_{n}(t)\right), t \in \tau\right\}$ is the corresponding vector stochastic process. The performance process of an MMS with structure function $\phi$ is a stochastic process $\{\phi(\boldsymbol{X}(t)), t \in \tau\}$, where for each fixed $t \in \tau, \phi(\boldsymbol{X}(t))$ is a random variable which takes values in $S . \phi(\boldsymbol{X}(t))$ denotes the system state at time $t$.

We assume that the sample functions of the performance process of a component are continuous from the right on $\tau$. It then follows that the sample functions of $\{\phi(\boldsymbol{X}(t)), t \in \tau\}$ are also continuous from the right on $\tau$. Now consider a time interval $I=\left[t_{A}, t_{B}\right] \subset[0, \infty)$ and let $\tau(I)=\tau \cap I$.

Definition 7 The marginal performance processes $\left\{X_{i}(t), t \in \tau\right\}, i=1, \ldots, n$ are independent in the time interval $I$ iff, for any integer $m$ and $\left\{t_{1}, \ldots, t_{m}\right\} \subset \tau(I)$ the random vectors $\left\{X_{1}\left(t_{1}\right), \ldots, X_{1}\left(t_{m}\right)\right\}, \ldots,\left\{X_{n}\left(t_{1}\right), \ldots, X_{n}\left(t_{m}\right)\right\}$ are independent.

Definition 8 The joint performance process for the components $\{\boldsymbol{X}(t), t \in \tau\}$ is associated in the time interval $I$ iff, for any integer $m$ and $\left\{t_{1}, \ldots, t_{m}\right\} \subset \tau(I)$ the random variables in the array

$$
\begin{aligned}
& X_{1}\left(t_{1}\right) \ldots X_{1}\left(t_{m}\right) \\
& \vdots \\
& X_{n}\left(t_{1}\right) \ldots X_{n}\left(t_{m}\right)
\end{aligned}
$$

are associated.

For an introduction to the theory of associated random variables we refer to Barlow and Proschan (1975).

Definition 9 Let $i=1, \ldots, n, j=1, \ldots, M$. The availability, $p_{i}^{j(I)}$, and the unavailability, $q_{i}^{j(I)}$, to level $j$ in the time interval $I$ of the $i$ th component are given by

p_{i}^{j(I)}=P\left[X_{i}(s) \geq j \forall s \in \tau(I)\right] \quad q_{i}^{j(I)}=P\left[X_{i}(s)<j \forall s \in \tau(I)\right] .
$$

The availability, $p_{\phi}^{j(I)}$, and the unavailability, $q_{\phi}^{j(I)}$, to level $j$ in the time interval $I$ for an MMS with structure function $\phi$ are given by

$$
p_{\phi}^{j(I)}=P[\phi(\boldsymbol{X}(s)) \geq j \forall s \in \tau(I)] \quad q_{\phi}^{j(I)}=P[\phi(\boldsymbol{X}(s))<j \forall s \in \tau(I)] .
$$

Let for $i=1, \ldots, n, j=0, \ldots, M$,

& r_{i}^{j(I)}=p_{i}^{j(I)}-p_{i}^{j+1(I)}=P\left[\min _{s \in \tau(I)} X_{i}(s)=j\right] \\
& r_{\phi}^{j(I)}=p_{\phi}^{j(I)}-p_{\phi}^{j+1(I)}=P\left[\min _{s \in \tau(I)} \phi(\boldsymbol{X}(s))=j\right] .
\end{aligned}

Introduce for $i=1, \ldots, n$ the component availability and unavailability vectors

$$
\boldsymbol{p}_{i}^{(I)}=\left\{p_{i}^{j(I)}\right\}_{j=1, \ldots, M} \quad \boldsymbol{q}_{i}^{(I)}=\left\{q_{i}^{j(I)}\right\}_{j=1, \ldots, M},

the $n \times M$ component availability and unavailability matrices

$$
\boldsymbol{P}_{\phi}^{(I)}=\left\{p_{i}^{j(I)}\right\}_{\substack{i=1, \ldots, n \\ j=1, \ldots, M}} \quad \boldsymbol{Q}_{\phi}^{(I)}=\left\{q_{i}^{j(I)}\right\}_{\substack{i=1, \ldots, n \\ j=1, \ldots, M}}
$$

and the system availability and unavailability vectors

$$
\boldsymbol{p}_{\phi}^{(I)}=\left\{p_{\phi}^{j(I)}\right\}_{j=1, \ldots, M} \quad \boldsymbol{q}_{\phi}^{(I)}=\left\{q_{\phi}^{j(I)}\right\}_{j=1, \ldots, M} .
$$

Finally, introduce for $i=1, \ldots, n$ the component parameter vectors

$$
\boldsymbol{r}_{i}^{(I)}=\left\{r_{i}^{j(I)}\right\}_{j=0, \ldots, M},
$$

the $n \times(M+1)$ parameter matrix

$$
\boldsymbol{R}_{\phi}^{(I)}=\left\{r_{i}^{j(I)}\right\}_{\substack{i=1, \ldots, n \\ j=0, \ldots, M}}
$$

and the system parameter vector

$$
\boldsymbol{r}_{\phi}^{(I)}=\left\{r_{\phi}^{j(I)}\right\}_{j=0, \ldots, M} .
$$

When $I=[t, t]$, we just drop $I$ from the notation and use reliability and unreliability instead of respectively availability and unavailability.

Note that for $i=1, \ldots, n$

p_{i}^{j(I)}+q_{i}^{j(I)} \leq 1 \quad p_{\phi}^{j(I)}+q_{\phi}^{j(I)} \leq 1 . \tag{1}
\end{equation*}

Suppose now that we run $K_{i}$ independent experiments for component $i$ registering $x_{i}^{(k)}(s) \forall s \in \tau(I)$ in the $k$ th experiment, $k=1, \ldots, K_{i}, i=1, \ldots, n$. Let for $j=1, \ldots, M, i=1, \ldots, n$

D_{i}^{1 j(I)}=\sum_{k=1}^{K_{i}} I\left[x_{i}^{(k)}(s) \geq j \forall s \in \tau(I)\right] \quad D_{i}^{2 j(I)}=\sum_{k=1}^{K_{i}} I\left[x_{i}^{(k)}(s)<j \forall s \in \tau(I)\right],
$$

and for $j=0, \ldots, M, i=1, \ldots, n$

D_{i}^{j(I)}=\sum_{k=1}^{K_{i}} I\left[\min _{s \in \tau(I)} x_{i}^{(k)}(s)=j\right] .
$$

Let for $r=1,2 \boldsymbol{D}_{i}^{r(I)}=\left(D_{i}^{r 1(I)}, \ldots, D_{i}^{r M(I)}\right), \boldsymbol{D}^{r(I)}=\left(\boldsymbol{D}_{1}^{r(I)}, \ldots, \boldsymbol{D}_{n}^{r(I)}\right)$. Furthermore, let $\boldsymbol{D}_{i}^{(I)}=\left(D_{i}^{0(I)}, \ldots, D_{i}^{M(I)}\right)$ and $\boldsymbol{D}^{(I)}=\left(\boldsymbol{D}_{1}^{(I)}, \ldots, \boldsymbol{D}_{n}^{(I)}\right)$.

Suppose also that we run $K$ independent experiments on the system level registering $\phi\left(\boldsymbol{x}^{(k)}(s)\right) \forall s \in \tau(I)$ in the $k$ th experiment, $k=1, \ldots, K$. Let for $j=1, \ldots, M$

$$
\begin{aligned}
D_{\phi}^{1 j(I)} & =\sum_{k=1}^{K} I\left[\phi\left(\boldsymbol{x}^{(k)}(s)\right) \geq j \forall s \in \tau(I)\right] \\
D_{\phi}^{2 j(I)} & =\sum_{k=1}^{K} I\left[\phi\left(\boldsymbol{x}^{(k)}(s)\right)<j \forall s \in \tau(I)\right],
\end{aligned}
$$

and for $j=0, \ldots, M$

$$
D_{\phi}^{j(I)}=\sum_{k=1}^{K} I\left[\min _{s \in \tau(I)} \phi\left(\boldsymbol{x}^{(k)}(s)\right)=j\right] .
$$

Let for $r=1,2 \boldsymbol{D}_{\phi}^{r(I)}=\left(D_{\phi}^{r 1(I)}, \ldots, D_{\phi}^{r M(I)}\right)$. Furthermore, let $\boldsymbol{D}_{\phi}^{(I)}=\left(D_{\phi}^{0(I)}, \ldots\right.$, $D_{\phi}^{M(I)}$. When $I=[t, t]$, we also drop $I$ from the notation in all these data variables and data vectors.

Assume that the prior distribution of respectively the component availability and unavailability matrices, before running any experiment on the component level, $\pi\left(\boldsymbol{P}_{\phi}^{(I)}\right)$ and $\pi\left(\boldsymbol{Q}_{\phi}^{(I)}\right)$, can be written as

$$
\pi\left(\boldsymbol{P}_{\phi}^{(I)}\right)=\prod_{i=1}^{n} \pi_{i}\left(\boldsymbol{p}_{i}^{(I)}\right) \quad \pi\left(\boldsymbol{Q}_{\phi}^{(I)}\right)=\prod_{i=1}^{n} \pi_{i}\left(\boldsymbol{q}_{i}^{(I)}\right)
$$

where for $i=1, \ldots, n \pi_{i}\left(\boldsymbol{p}_{i}^{(I)}\right)$ is the prior marginal distribution of $\boldsymbol{p}_{i}^{(I)}$ and $\pi_{i}\left(\boldsymbol{q}_{i}^{(I)}\right)$ is the prior marginal distribution of $\boldsymbol{q}_{i}^{(I)}$. Hence, we assume that the components have independent prior component availability vectors and independent prior component unavailability vectors.

Note that before the experiments are carried through $D_{i}^{1 j(I)}$ is binomially distributed with parameters $K_{i}$ and $p_{i}^{j(I)}$, and $D_{i}^{2 j(I)}$ binomially distributed with parameters $K_{i}$ and $q_{i}^{j(I)}$. We assume that given $\boldsymbol{P}_{\phi}^{(I)}, \boldsymbol{D}_{1}^{1(I)}, \ldots, \boldsymbol{D}_{n}^{1(I)}$ are independent and that given $\boldsymbol{Q}_{\phi}^{(I)}, \boldsymbol{D}_{1}^{2(I)}, \ldots, \boldsymbol{D}_{n}^{2(I)}$ are independent. Hence, since we have assumed that the components have independent prior availability vectors, using Bayes‘ theorem the posterior distribution of the component availability matrix, $\pi\left(\boldsymbol{P}_{\phi}^{(I)} \mid \boldsymbol{D}^{1(I)}\right)$, can be written as

\begin{aligned}
\pi\left(\boldsymbol{P}_{\phi}^{(I)} \mid \boldsymbol{D}^{1(I)}\right) & =\frac{\pi\left(\boldsymbol{D}^{1(I)} \mid \boldsymbol{P}_{\phi}^{(I)}\right) \pi\left(\boldsymbol{P}_{\phi}^{(I)}\right)}{\int \pi\left(\boldsymbol{D}^{1(I)} \mid \boldsymbol{P}_{\phi}^{(I)}\right) \pi\left(\boldsymbol{P}_{\phi}^{(I)}\right) d \boldsymbol{P}_{\phi}^{(I)}} \\
& =\frac{\prod_{i=1}^{n} \pi_{i}\left(\boldsymbol{D}_{i}{ }^{1(I)} \mid \boldsymbol{p}_{i}^{(I)}\right) \pi_{i}\left(\boldsymbol{p}_{i}^{(I)}\right)}{\prod_{i=1}^{n} \int \pi_{i}\left(\boldsymbol{D}_{i}{ }^{1(I)} \mid \boldsymbol{p}_{i}^{(I)}\right) \pi_{i}\left(\boldsymbol{p}_{i}^{(I)}\right) d \boldsymbol{p}_{i}^{(I)}}=\prod_{i=1}^{n} \frac{\pi_{i}\left(\boldsymbol{D}_{\boldsymbol{i}}{ }^{1(I)} \mid \boldsymbol{p}_{i}^{(I)}\right) \pi_{i}\left(\boldsymbol{p}_{i}^{(I)}\right)}{\pi_{i}\left(\boldsymbol{D}_{i}^{1(I)}\right)} \\
& =\prod_{i=1}^{n} \pi_{i}\left(\boldsymbol{p}_{i}^{(I)} \mid \boldsymbol{D}_{i}^{1(I)}\right),
\end{aligned}
$$

where $\pi_{i}\left(\boldsymbol{p}_{i}^{(I)} \mid \boldsymbol{D}_{i}^{1(I)}\right)$ is the posterior marginal distribution of $\boldsymbol{p}_{i}^{(I)}$. Similarly, the posterior distribution of the component unavailability matrix, $\pi\left(\boldsymbol{Q}_{\phi}^{(I)} \mid \boldsymbol{D}^{2(I)}\right)$, can be written as

\pi\left(\boldsymbol{Q}_{\phi}^{(I)} \mid \boldsymbol{D}^{2(I)}\right)=\prod_{i=1}^{n} \pi_{i}\left(\boldsymbol{q}_{i}^{(I)} \mid \boldsymbol{D}_{i}^{2(I)}\right)
$$

Hence, the posterior component availability vectors are independent given $\boldsymbol{D}^{1(I)}$ and the posterior component unavailability vectors are independent given $\boldsymbol{D}^{2(I)}$.

Now specialize $I=[t, t]$ and assume that the component states $X_{1}, \ldots, X_{n}$ are independent given $\boldsymbol{P}_{\phi}$. Since in this case $\boldsymbol{p}_{\phi}$ is a function of $\boldsymbol{P}_{\phi}$, the distribution, $\pi\left(\boldsymbol{p}_{\phi}\left(\boldsymbol{P}_{\phi}\right) \mid \boldsymbol{D}^{1}\right)$, can then be arrived at. Based on prior knowledge on the system level this may be adjusted to the prior distribution of the system reliability vector, $\pi_{0}\left(\boldsymbol{p}_{\phi}\left(\boldsymbol{P}_{\phi}\right) \mid \boldsymbol{D}^{1}\right)$. Note that before the experiments are carried through $D_{\phi}^{1 j}$ is binomially distributed with parameters $K$ and $p_{\phi}^{j}$. Including the data $\boldsymbol{D}_{\phi}^{1}$, we end up with the posterior distribution of the system reliability vector, $\pi\left(\boldsymbol{p}_{\phi}\left(\boldsymbol{P}_{\phi}\right) \mid \boldsymbol{D}^{1}, \boldsymbol{D}_{\phi}^{1}\right)$, for $j=1, \ldots, M$.

When considering the case $I=[t, t]$, we can instead of $\boldsymbol{P}_{\phi}$ as well consider the parameter matrix $\boldsymbol{R}_{\phi}$ and assume that the components have independent prior vectors $\boldsymbol{r}_{i}, i=1, \ldots, n$, each having a Dirichlet distribution being the natural conjugate prior. Furthermore, we assume that given $\boldsymbol{R}_{\phi}, \boldsymbol{D}_{1}, \ldots, \boldsymbol{D}_{n}$ are independent. Note that before the experiments are carried through $\boldsymbol{D}_{i}$ is multinomially distributed with parameters $K_{i}$ and $\boldsymbol{r}_{i}$. Hence, the posterior marginal distribution of $\boldsymbol{r}_{i}$ given the data $\boldsymbol{D}_{i}, \pi_{i}\left(\boldsymbol{r}_{i} \mid \boldsymbol{D}_{i}\right)$, is Dirichlet. Furthermore, we have

$$
\pi\left(\boldsymbol{R}_{\phi} \mid \boldsymbol{D}\right)=\prod_{i=1}^{n} \pi_{i}\left(\boldsymbol{r}_{i} \mid \boldsymbol{D}_{i}\right)
$$

Hence, life can be made easy at the component level. Assume that the component states $X_{1}, \ldots, X_{n}$ are independent given $\boldsymbol{R}_{\phi}$. The distribution, $\pi\left(\boldsymbol{r}_{\phi}\left(\boldsymbol{R}_{\phi}\right) \mid \boldsymbol{D}\right)$, is tried to be arrived at. If this is successful, based on prior knowledge on the system level, it is adjusted to $\pi_{0}\left(\boldsymbol{r}_{\phi}\left(\boldsymbol{R}_{\phi}\right) \mid \boldsymbol{D}\right)$. This may be possible for simple systems. Note that before the experiments are carried through, $\boldsymbol{D}_{\phi}$ is multinomially distributed with parameters $K$ and $\boldsymbol{r}_{\phi}$. Hence, if $\pi_{0}\left(\boldsymbol{r}_{\phi}\left(\boldsymbol{R}_{\phi}\right) \mid \boldsymbol{D}\right)$, as in a dream, ended up as a Dirichlet distribution, the posterior distribution, $\pi\left(\boldsymbol{r}_{\phi}\left(\boldsymbol{R}_{\phi}\right) \mid \boldsymbol{D}, \boldsymbol{D}_{\phi}\right)$, also would be a Dirichlet distribution. Do not forget this was a dream, also based on independent components given $\boldsymbol{R}_{\phi}$ ! So life will at least not be easy at the system level even when $I=[t, t]$.

For an arbitrary $I \boldsymbol{p}_{\phi}^{(I)}$ is not a function of just $\boldsymbol{P}_{\phi}^{(I)}$, and $\boldsymbol{q}_{\phi}^{(I)}$ not a function of just $\boldsymbol{Q}_{\phi}^{(I)}$. Hence, the approach above for the case $I=[t, t]$ can not be extended.

In Section 2 we discuss two different approaches to the computation of posterior moments for component availabilities and unavailabilities, the first one generalizing an approach given in Mastran and Singpurwalla (1978). In Section 3 we start out by describing our uncertainty on the component availabilities and unavailabilities to the various levels in a fixed time interval, based on both prior information and data on the components, by the moments up till order $m$ of their marginal distributions. From these moments analytic bounds on the corresponding moments of the system availabilities and unavailabilities to the various levels in a fixed time interval are arrived at. Applying these bounds and prior system information we may then fit prior
distributions of the system availabilities and unavailabilities to the various levels in a fixed time interval. These can in turn be updated by relevant data on the system. This generalizes results given in Natvig and Eide (1987) considering a binary monotone system of binary components at a fixed point of time. In Section 4 we present a straightforward simulation technique for obtaining bounds that improve the analytic bounds. Considering a simple network system, we show that the former bounds are slightly better than the latter.

## 2 Moments for Posterior Component Availabilities and Unavailabilities

Based on the experiences of the previous section we reduce our ambitions. We start by specifying marginal moments $E\left\{\left(p_{i}^{j(I)}\right)^{s}\right\}$ and $E\left\{\left(q_{i}^{j(I)}\right)^{s}\right\}$ for $s=1, \ldots, m+K_{i}, j=$ $1, \ldots, M$ of $\pi_{i}\left(\boldsymbol{p}_{i}^{(I)}\right)$ and $\pi_{i}\left(\boldsymbol{q}_{i}^{(I)}\right), i=1, \ldots, n$. We will first illustrate how these can be updated to give posterior moments $E\left\{\left(p_{i}^{j(I)}\right)^{s} \mid D_{i}^{1 j(I)}\right\}$ and $E\left\{\left(q_{i}^{j(I)}\right)^{s} \mid D_{i}^{2 j(I)}\right\}$ for $s=1, \ldots, m, j=1, \ldots, M$ by using Lemma 1 in Mastran and Singpurwalla (1978). Note that we lose information by conditioning on $D_{i}^{1 j(I)}$ instead of $\boldsymbol{D}_{i}^{1(I)}$ and $D_{i}^{2 j(I)}$ instead of $\boldsymbol{D}_{i}^{2(I)}$. However, such improved conditioning does not work with this approach. We have

\\
=\int_{0}^{1}\left(p_{i}^{j(I)}\right)^{s+D_{i}^{1 j(l)}} \sum_{r=0}^{K_{i}-D_{i}^{1 j(I)}}\binom{K_{i}-D_{i}^{1 j(I)}}{r}(-1)^{r}\left(p_{i}^{j(I)}\right)^{r} \pi_{i}\left(p_{i}^{j(I)}\right) d p_{i}^{j(I)} .
\end{gathered}
$$

Hence,

E\left\{\left(p_{i}^{j(I)}\right)^{s} \mid D_{i}^{1 j(I)}\right\}=\frac{\sum_{r=0}^{K_{i}-D_{i}^{1 j(I)}\binom{K_{i}-D_{r}^{1 j(l)}}{r}(-1)^{r} E\left\{\left(p_{i}^{j(I)}\right)^{s+D_{i}^{1 j(l)}+r}\right\}}}{\sum_{r=0}^{K_{i}-D_{i}^{1 j(l)}}\binom{K_{i}-D_{i}^{1 /(l)}}{r}(-1)^{r} E\left\{\left(p_{i}^{j(I)}\right)^{D_{i}^{1 j(l)}+r}\right\}} .
$$

A similar expression is valid for $E\left\{\left(q_{i}^{j(I)}\right)^{s} \mid D_{i}^{2 j(I)}\right\}$. The advantage of using this lemma is that it is applicable for general prior distributions $\pi_{i}\left(p_{i}^{j(I)}\right)$ and $\pi_{i}\left(q_{i}^{j(I)}\right)$. A serious drawback is, however, that to arrive at $E\left\{\left(p_{i}^{j(I)}\right)^{s} \mid D_{i}^{1 j(I)}\right\}$ and $E\left\{\left(q_{i}^{j(I)}\right)^{s} \mid D_{i}^{2 j(I)}\right\}$ for $s=1, \ldots, m, j=1, \ldots, M$ one must specify marginal moments up till order $m+K_{i}$ of the corresponding prior distributions $\pi_{i}\left(p_{i}^{j(I)}\right)$ and $\pi_{i}\left(q_{i}^{j(I)}\right)$. This may be completely unrealistic unless $K_{i}$ is small.

A more realistic alternative is given in the following. Assume that the components have independent prior parameter vectors $\boldsymbol{r}_{i}^{(I)}, i=1, \ldots, n$, each having a Dirichlet distribution being the natural conjugate prior. Note that before the experiments are carried through $\boldsymbol{D}_{i}^{(I)}$ is multinomially distributed with parameters $K_{i}$ and $\boldsymbol{r}_{i}^{(I)}$. Hence, the posterior marginal distribution of $\boldsymbol{r}_{i}^{(I)}$ given the data $\boldsymbol{D}_{i}^{(I)}, \pi_{i}\left(\boldsymbol{r}_{i}^{(I)} \mid \boldsymbol{D}_{i}^{(I)}\right)$, is Dirichlet. We now have

p_{i}^{j(I)}=\sum_{\ell=j}^{M} r_{i}^{\ell(I)} \quad D_{i}^{1 j(I)}=\sum_{\ell=j}^{M} D_{i}^{\ell(I)} . \tag{2}
\end{equation*}
$$

Hence, the posterior marginal distribution of $p_{i}^{j(I)}$ given the data $D_{i}^{1 j(I)}$ is beta. Accordingly, we lose no information by conditioning on $D_{i}^{1 j(I)}$ instead of $\boldsymbol{D}_{i}^{1(I)}$. We now assume that the prior distribution $\pi_{i}\left(p_{i}^{j(I)}\right)$ is beta with parameters $a_{i}^{j(I)}$ and $b_{i}^{j(I)}$. It then follows that $\pi_{i}\left(p_{i}^{j(I)} \mid D_{i}^{1 j(I)}\right)$ is beta with parameters $a_{i}^{j(I)}+D_{i}^{1 j(I)}$ and $b_{i}^{j(I)}+K_{i}-D_{i}^{1 j(I)}$. We have

E\left\{\left(p_{i}^{j(I)}\right)^{s} \mid D_{i}^{1 j(I)}\right\}= & \int_{0}^{1}\left(p_{i}^{j(I)}\right)^{s} \frac{\Gamma\left(a_{i}^{j(I)}+b_{i}^{j(I)}+K_{i}\right)}{\Gamma\left(a_{i}^{j(I)}+D_{i}^{1 j(I)}\right) \Gamma\left(b_{i}^{j(I)}+K_{i}-D_{i}^{1 j(I)}\right)} \\
& \times\left(p_{i}^{j(I)}\right)^{a_{i}^{j(I)}+D_{i}^{1 j(I)}-1}\left(1-p_{i}^{j(I)}\right)^{b_{i}^{j(I)}+K_{i}-D_{i}^{1 /(I)}-1} d p_{i}^{j(I)} \\
= & \frac{\Gamma\left(a_{i}^{j(I)}+b_{i}^{j(I)}+K_{i}\right) \Gamma\left(a_{i}^{j(I)}+D_{i}^{1 j(I)}+s\right)}{\Gamma\left(a_{i}^{j(I)}+D_{i}^{1 j(I)}\right) \Gamma\left(a_{i}^{j(I)}+b_{i}^{j(I)}+K_{i}+s\right)} \\
& \times \int_{0}^{1} \frac{\Gamma\left(a_{i}^{j(I)}+b_{i}^{j(I)}+K_{i}+s\right)}{\Gamma\left(a_{i}^{j(I)}+D_{i}^{1 j(I)}+s\right) \Gamma\left(b_{i}^{j(I)}+K_{i}-D_{i}^{1 j(I)}\right)} \\
& \times\left(p_{i}^{j(I)}\right)^{a_{i}^{j(I)}+D_{i}^{1 j(I)}+s-1}\left(1-p_{i}^{j(I)}\right)^{b_{i}^{j(I)}+K_{i}-D_{i}^{1 j(I)}-1} d p_{i}^{j(I)} \\
= & \frac{\Gamma\left(a_{i}^{j(I)}+b_{i}^{j(I)}+K_{i}\right) \Gamma\left(a_{i}^{j(I)}+D_{i}^{1 j(I)}+s\right)}{\Gamma\left(a_{i}^{j(I)}+D_{i}^{1 j(I)}\right) \Gamma\left(a_{i}^{j(I)}+b_{i}^{j(I)}+K_{i}+s\right)},
\end{aligned}
$$

the integral being equal to 1 since we are integrating up a beta density with parameters $a_{i}^{j(I)}+D_{i}^{1 j(I)}+s$ and $b_{i}^{j(I)}+K_{i}-D_{i}^{1 j(I)}$. A similar expression is valid for $E\left\{\left(q_{i}^{j(I)}\right)^{s} \mid D_{i}^{2 j(I)}\right\}$.

## 3 Bounds for Moments for System Availabilities and Unavailabilities

From the marginal moments $E\left\{\left(p_{i}^{\ell(I)}\right)^{s} \mid D_{i}^{1 \ell(I)}\right\}$ and $E\left\{\left(q_{i}^{\ell(I)}\right)^{s} \mid D_{i}^{2 \ell(I)}\right\}$, we derive lower bounds on the marginal moments $E\left\{\left(p_{\phi}^{j(I)}\right)^{s} \mid \boldsymbol{D}^{1(I)}\right\}$ and upper bounds on the marginal moments $E\left\{\left(p_{\phi}^{j(I)}\right)^{s} \mid \boldsymbol{D}^{2(I)}\right\}$ for $s=1, \ldots, m, \ell=1, \ldots, M, j=1, \ldots, M$. Similarly, we derive lower bounds on the marginal moments $E\left\{\left(q_{\phi}^{j(I)}\right)^{s} \mid \boldsymbol{D}^{2(I)}\right\}$ and upper bounds on the marginal moments $E\left\{\left(q_{\phi}^{j(I)}\right)^{s} \mid \boldsymbol{D}^{1(I)}\right\}$. Note that we now do not necessarily need the marginal performance processes of the components to be independent in $I$. From these bounds and prior knowledge on the system level we may fit $\pi_{0}\left(\boldsymbol{p}_{\phi}^{(I)}\right)$ and $\pi_{0}\left(\boldsymbol{q}_{\phi}^{(I)}\right)$. This may finally be updated to give $\pi\left(\boldsymbol{p}_{\phi}^{(I)} \mid \boldsymbol{D}_{\phi}^{1(I)}\right)$ and $\pi\left(\boldsymbol{q}_{\phi}^{(I)} \mid \boldsymbol{D}_{\phi}^{2(I)}\right)$.

What we will concentrate on is how to establish the bounds on the marginal moments of system availabilities and unavailabilities from the marginal moments of component availabilities and unavailabilities. To simplify notation we drop the reference to the data $\left(\boldsymbol{D}^{1(I)}, \boldsymbol{D}^{2(I)}\right)$ from experiments on the component level.

Let us just for a while return to the case $I=[t, t]$ and assume that the component states $X_{1}, \ldots, X_{n}$ are independent given $\boldsymbol{R}_{\phi}$. Then we get

Hence, since we assume that the components have independent prior vectors $\boldsymbol{r}_{i}$ for $i=1, \ldots, n$, generalizing a result in Natvig and Eide (1987), we get

E\left\{p_{\phi}^{j}\left(\boldsymbol{R}_{\phi}\right)\right\}=\sum_{\boldsymbol{x}} I[\phi(\boldsymbol{x}) \geq j] \prod_{i=1}^{n} E\left\{r_{i}^{x_{i}}\right\}=p_{\phi}^{j}\left(E\left\{\boldsymbol{R}_{\phi}\right\}\right),
$$

where

E\left\{\boldsymbol{R}_{\phi}\right\}=\left\{E\left\{r_{i}^{j}\right\}\right\}_{\substack{i=1, \ldots, n \\ j=0, \ldots, M}} .
$$

Accordingly, one can arrive at an exact expression for $E\left\{p_{\phi}^{j}\left(\boldsymbol{R}_{\phi}\right)\right\}$ for not too large systems. The point is, however, that there seems to be no easy way to extend the approach above to give exact expressions for higher order moments of $p_{\phi}^{j}\left(\boldsymbol{R}_{\phi}\right)$. Hence, even when $I=[t, t]$ and component states are independent given $\boldsymbol{R}_{\phi}$, one needs bounds on higher order moments of $p_{\phi}^{j}\left(\boldsymbol{R}_{\phi}\right)$.

We need the following theorem proved in Natvig and Eide (1987).
Theorem 1 If $Y_{1}, \ldots, Y_{n}$ are associated random variables such that $0 \leq Y_{i} \leq 1, i=$ $1, \ldots, n$, then for $\alpha>0$

Proof For the case $Y_{1}, \ldots, Y_{n}$ binary and $\alpha=1$, Eqs. 3 and 4 are proved in Theorem 3.1, page 32 of Barlow and Proschan (1975). The proof, however, also works when $0 \leq Y_{i} \leq 1, i=1, \ldots, n$. Using this fact and that non-decreasing functions of associated random variables are associated we get

and Eq. 3 is proved. Equation 4 is proved in the same way. Finally, Eq. 5 follows since

and that $Y_{1}$ and $Y_{2}$ are assumed to be independent.

Equation 5 reveals the unpleasant fact that a symmetry in Eqs. 3 and 4 seems only possible for $\alpha=1$, when $Y_{1}, \ldots, Y_{n}$ are not binary.

In the following, considering an MMS $(C, \phi)$, for $j \in\{1, \ldots, M\}$ let $\boldsymbol{y}_{k}^{j}=\left(y_{1 k}^{j}\right.$, $\left.\ldots, y_{n k}^{j}\right), k=1, \ldots, n_{\phi}^{j}$ be its minimal path vectors to level $j$ and $\boldsymbol{z}_{k}^{j}=\left(z_{1 k}^{j}, \ldots, z_{n k}^{j}\right)$, $k=1, \ldots, m_{\phi}^{j}$ be its minimal cut vectors to level $j$ and

The three following theorems are taken from Natvig (2011).

Assume the marginal performance processes of the components to be independent in the time interval I. Then for $j=1, \ldots, M$

Due to the lack of symmetry in Theorem 1, we have not been able to obtain corresponding upper bounds for $E\left\{\left(p_{\phi}^{j(I)}\right)^{m}\right\}$ and $E\left\{\left(q_{\phi}^{j(I)}\right)^{m}\right\}, m=2,3, \ldots$ in this theorem. As for Theorem 5 we cannot apply the best upper bounds in Eqs. 8 and 9.

It is important to note that the bounds for $E\left\{\left(p_{\phi}^{j(I)}\right)\right\}$ and $E\left\{\left(q_{\phi}^{j(I)}\right)\right\}$ given in this section equal the bounds in Section 3.2 of Natvig (2011) by replacing $\boldsymbol{P}_{\phi}^{(I)}$ by $E\left\{\left(\boldsymbol{P}_{\phi}^{(I)}\right)^{1}\right\}$ and $\boldsymbol{Q}_{\phi}^{(I)}$ by $E\left\{\left(\boldsymbol{Q}_{\phi}^{(I)}\right)^{1}\right\}$. However, this is not true for higher order moments.

## 4 A Simulation Approach and a Case Study

An objection against the bounds in Theorems 5 and 6 and Corollaries 7 and 8 is that they are based on knowing all minimal path and cut vectors of the system. It is
natural to try to both improve the bounds and reduce the computational complexity by introducing modular decompositions.

Looking at the bounds for $E\left\{\left(p_{\phi}^{j(I)}\right)^{m}\right\}$ and $E\left\{\left(q_{\phi}^{j(I)}\right)^{m}\right\}$ for $m=2,3, \ldots$, it seems that only the lower bounds of Theorem 5 are of the form that fits into the machinery of Section 3.3 of Natvig (2011). We now get the following theorem

& \ell_{\phi}^{‘ j(I) m}\left(E\left\{\left(\boldsymbol{P}_{\phi}^{(I)}\right)^{m}\right\}\right)=\ell_{\psi}^{‘ j(I) m}\left(\ell_{\psi}^{‘(I) m}\left(E\left\{\left(\boldsymbol{P}_{\phi}^{(I)}\right)^{m}\right\}\right) \leq E\left\{\left(p_{\phi}^{j(I)}\right)^{m}\right\}\right.  \tag{31}\\
& \bar{\ell}_{\phi}^{\prime j(I) m}\left(E\left\{\left(\boldsymbol{Q}_{\phi}^{(I)}\right)^{m}\right\}\right)=\bar{\ell}_{\psi}^{\prime j(I) m}\left(\overline{\boldsymbol{\ell}}_{\psi}^{‘(I) m}\left(E\left\{\left(\boldsymbol{Q}_{\phi}^{(I)}\right)^{m}\right\}\right) \leq E\left\{\left(q_{\phi}^{j(I)}\right)^{m}\right\} .\right. \tag{32}
\end{align*}
$$

Proof Equation 31 follows from the lower bound of Eq. 15 and from Eq. 3.45 of Natvig (2011), by in the last expression replacing $\boldsymbol{P}_{\phi}^{(I)}$ by $E\left\{\left(\boldsymbol{P}_{\phi}^{(I)}\right)^{m}\right\}$. Note that in this case the latter array given by Eq. 13 can be replaced by an $n \times M$ matrix by fixing $s$ at $m$. Hence, an $n \times M$ matrix is replaced by an $n \times M$ matrix. Equation 32 follows by a duality argument.

Hence, our analytical bounds are not improved by using a modular decomposition. On the other hand the computational complexity is reduced since we have to find minimal path and cut vectors only for each module and for the organizing structure.

All analytical bounds on the marginal moments $E\left\{\left(p_{\phi}^{j(I)}\right)^{m} \mid \boldsymbol{D}^{1(I)}\right\}$ and $E\left\{\left(q_{\phi}^{j(I)}\right)^{m} \mid \boldsymbol{D}^{2(I)}\right\}$ for $m=1, \ldots, j=1, \ldots, M$ given in Section 2 can be improved by straightforward simulation techniques. Let us illustrate this on the lower bounds in Eq. 15. As in the proof of Theorem 5, with full notation, we have from Eq. 6

$$
\begin{equation*}
E\left\{\left(p_{\phi}^{j(I)}\right)^{m} \mid \boldsymbol{D}^{1(I)}\right\} \geq E\left\{\max _{1 \leq k \leq n_{\phi}^{j}} \prod_{i \in C_{\phi}^{j}\left(\boldsymbol{y}_{k}^{j}\right)}\left(p_{i}^{y_{i k}^{j}(I)}\right)^{m} \mid \boldsymbol{D}^{1(I)}\right\} \tag{33}
\end{equation*}
$$

For $i=1, \ldots, n$ we simulate from the posterior marginal distribution of $\boldsymbol{r}_{i}^{(I)}$ given the data $\boldsymbol{D}_{i}^{(I)}, \pi_{i}\left(\boldsymbol{r}_{i}^{(I)} \mid \boldsymbol{D}_{i}^{(I)}\right)$, assumed being Dirichlet. We then calculate $p_{i}^{j(I)}$ from Eq. 2 for $i=1, \ldots, n, j=1, \ldots, M$. For each round of $n$ simulations the quantity $\max _{1 \leq k \leq n_{\phi}^{j}} \prod_{i \in C_{\phi}^{j}}\left(\boldsymbol{y}_{k}^{j}\right)\left(p_{i}^{y_{i k}^{j}(I)}\right)^{m}$ is calculated, and the right hand side of Eq. 33 is estimated by the average of the simulated quantities. Theoretically, as seen from the proof, this improves the lower bound of Eq. 15 of Theorem 5. Similarly, we obtain a simulated lower bound which improves the lower bound of Eq. 17 of Theorem 6. In practice, the analytic bounds may be marginally better due to simulation uncertainty.

This simulation technique can also be applied to arrive at improved bounds using modular decompositions. From Theorem 4 we for instance get the following inequalities as starting points for the simulations.

Corollary 10 Let $(C, \phi)$ be an MMS with modular decomposition given by Definition 3. Assume the marginal performance processes of the components to be independent in the time interval I. Then for $j=1, \ldots, M$

\begin{align*}
E\left\{\left(B_{\psi}^{* j(I)}\left(\boldsymbol{B}_{\psi}^{*(I)}\left(\boldsymbol{P}_{\phi}^{(I)}\right)\right)\right)^{m} \mid \boldsymbol{D}^{1(I)}\right\} & \leq E\left\{\left(p_{\phi}^{j}\right)^{m} \mid \boldsymbol{D}^{1(I)}\right\} \\
E\left\{\left(p_{\phi}^{j}\right)^{m} \mid \boldsymbol{D}^{2(I)}\right\} & \leq E\left\{\left(1-\bar{B}_{\psi}^{* j(I)}\left(\overline{\boldsymbol{B}}_{\psi}^{*(I)}\left(\boldsymbol{Q}_{\phi}^{(I)}\right)\right)\right)^{m} \mid \boldsymbol{D}^{2(I)}\right\}  \tag{34}\\
E\left\{\left(\bar{B}_{\psi}^{* j(I)}\left(\overline{\boldsymbol{B}}_{\psi}^{*(I)}\left(\boldsymbol{Q}_{\phi}^{(I)}\right)\right)\right)^{m} \mid \boldsymbol{D}^{2(I)}\right\} & \leq E\left\{\left(q_{\phi}^{j}\right)^{m} \mid \boldsymbol{D}^{2(I)}\right\} \\
E\left\{\left(q_{\phi}^{j}\right)^{m} \mid \boldsymbol{D}^{1(I)}\right\} & \leq E\left\{\left(1-B_{\psi}^{* j(I)}\left(\boldsymbol{B}_{\psi}^{*(I)}\left(\boldsymbol{P}_{\phi}^{(I)}\right)\right)\right)^{m} \mid \boldsymbol{D}^{1(I)}\right\} . \tag{35}
\end{align*}
$$

To illustrate the theory consider the simple network system depicted in Fig. 1. Here module 1 is the parallel system of the components $a_{1}$ and $b_{1}$ and module 2 the parallel system of the components $a_{2}$ and $b_{2}$. We assume that the set of states of the $i$ th component is given by $S_{i}=\{0,3\}, i=1,2,3,4$, i.e. we have a binary description at the component level. Let for each module the state be 0 if neither of the components work, 1 if one component works and 3 if two components work. The states of the system are given in Table 1.

Note for instance that the state 1 is critical both for each module and the system as a whole in the sense that the failing of a component leads to the 0 state.

The minimal path and cut vectors for the system of Fig. 1 are given in respectively Tables 2 and 3.

Following the argument leading to Eq. 2 we assume that the posterior marginal distribution of $p_{i}^{j(I)}$ given the data $D_{i}^{1 j(I)}$ is beta with parameters $\alpha E\left\{p_{i}^{j(I)}\right\}$ and $\alpha(1-$ $\left.E\left\{p_{i}^{j(I)}\right\}\right)$. Hence,

$$
\operatorname{Var}\left\{p_{i}^{j(I)}\right\}=E\left\{p_{i}^{j(I)}\right\}\left(1-E\left\{p_{i}^{j(I)}\right\}\right) /(\alpha+1)
$$

and the second order moment is given by

$$
E\left\{\left(p_{i}^{j(I)}\right)^{2}\right\}=E\left\{p_{i}^{j(I)}\right\}\left(1+E\left\{p_{i}^{j(I)}\right\} \alpha\right) /(\alpha+1)
$$

$E\left\{p_{i}^{j(I)}\right\}$ is chosen to be equal to the value of $p_{i}^{j(I)}$ calculated by a standard deterministic analysis as given in Natvig (2011). In these calculations the marginal performance processes of the two modules are assumed independent in the time interval $I$ and also that the two components of each module fail and are repaired/replaced independently of each other. All components have the same instantaneous failure rate $\lambda=0.001$ and repair/replacement rate $\mu=0.01$.

In Table 4 the analytical lower bounds from Corollary $8, B_{\phi}^{* j(I) m}\left(E\left\{\left(\boldsymbol{P}_{\phi}^{(I)}\right)^{m}\right\}\right)$, for $E\left\{\left(p_{\phi}^{j(I)}\right)^{m}\right\}$ for $m=1,2$ and the corresponding simulated lower bounds, both not using and using modular decompositions, are calculated for the time interval $I$ equal to $[100,110],[100,200],[1000,1100]$, the parameter $\alpha$ equal to $1,10,1,000$ and for system level $j$ equal to 1, 2, 3. Looking at the lower bounds for $E\left\{\left(p_{\phi}^{j(I)}\right)\right\}$ there are just minor differences between the analytical and the simulated bounds that are not based on modular decompositions except for $\alpha=1, j=2$ and the two longest intervals $[100,200]$ and $[1000,1100]$, where the improvements are quite small. Correspondingly, there are just minor improvements of the simulated bounds that are based on modular decompositions compared to the ones that are not except for $\alpha=10,1000, j=2$ and the two longest intervals [100, 200] and [1000, 1100], where the improvements are quite small. Furthermore, the analytical bounds do not not depend on the $\alpha$ parameter which is natural since $E\left\{p_{i}^{j(I)}\right\}$ is independent of this parameter. That these lower bounds are decreasing in the length of the interval $I$

and the system state $j$ is just a reflection of the fact that these properties hold for $E\left\{\left(p_{\phi}^{j(I)}\right)\right\}$.

Turning to the lower bounds for $E\left\{\left(p_{\phi}^{j(I)}\right)^{2}\right\}$ there are again just minor differences between the analytical and the simulated bounds that are not based on modular decompositions again except for $\alpha=1, j=2$ and the two longest intervals [100, 200] and $[1000,1100]$, where the improvements are quite small. Correspondingly, there are just minor improvements of the simulated bounds that are based on modular decompositions compared to the ones that are not except for $\alpha=10,1000, j=2$ and the two longest intervals $[100,200]$ and $[1000,1100]$, where the improvements are quite small. Furthermore, these bounds are decreasing in the $\alpha$ parameter which is natural since $E\left\{\left(p_{i}^{j(I)}\right)^{2}\right\}$ is decreasing in this parameter. That these lower bounds are decreasing in the length of the interval $I$ and the system state $j$ is just a reflection of the fact that these properties also hold for $E\left\{\left(p_{\phi}^{j(I)}\right)^{2}\right\}$. It should also be noted that combining the lower bounds for $E\left\{\left(p_{\phi}^{j(I)}\right)\right\}$ and $E\left\{\left(p_{\phi}^{j(I)}\right)^{2}\right\}$ does not lead to a lower bound for $\operatorname{Var}\left\{\left(p_{\phi}^{j(I)}\right)\right\}$. However, for the analytical lower bounds it is revealing that this leads to positive variances. For the corresponding simulated lower bounds this
is obviously the case. Finally, it should be remarked that in contrast to the analytical bounds, the simulated bounds are improved by using modular decompositions.
