As I read through the list of manuscripts slated for publication in the June issue, I am struck by the common theme of enhancing bioavailability for poorly soluble drugs. Approaches such as the use of nanoparticles, gastro-retentive delivery, and emulsion technology are all included in this issue. I hope you will find the papers in this issue inspiring to your research and development work.
