The Asian-Pacific Resource and Research Centre for Women (ARROW) was established in 1993 as an Asian-Pacific non-governmental, non-profit organization. ARROW runs a Women and Health Programme which aims to strengthen initiatives, to re-orient health, population and reproductive health policies and programmes with women's and gender perspectives. The Programme also intends to improve women NGOs' capacity to influence health, population and family planning organizations at all levels. This is achieved by ARROW through the collection, generation and dissemination of timely, relevant and action-oriented information on women's health to key organizations and individuals.

ARROW's present projects include the coordination of the Malaysian component of a seven-country ethnographic study of the International Reproductive Rights Research Action Group (IRRAG). The research documents low income women's understanding of their entitlements in marriage, childbearing and contraception. CWPE was formed in October 1991 by representatives from the Black Women's Health Book Collective, the Population and Development Programme and Civil Liberties and Public Policy Programmes at Hampshire College. It has since welcomed in representatives from the national Conference of Black Lawyers, the Asian Women's Health Organization. Korean American Women in Need, the Midwest Treaty Network. Women of All Red Nations, the Political Ecology Group, the Black Women's Health Project, and a number of other organizations. From the start CWPE's mission has been to give voice to grassroots women in the US and abroad on issues of population control and the environment, offering analyses that account for the pervasive effects of war. urbanization. over-consumption, and the global poverty rather than those that focus solely on the effects of population growth.

They are especially critical of the attempts to blame environmental degradation on the 'overpopulation' of the poor and people of colour, while the main causes of damage are profitdriven economic systems, militarization, poorly planned urbanization, disproportionately high patterns of consumption among the world's economic elite and the displacement of small farmers and indigenous peoples by agribusiness, timber mining and energy interests. *Contact: Andrea Lee Smith, CWPE.
