# Iterative approximation of a common solution of a split generalized equilibrium problem and a fixed point problem for nonexpansive semigroup

#### Abstract

Purpose: In this paper, we introduce and study an iterative method to approximate a common solution of a split generalized equilibrium problem and a fixed point problem for a nonexpansive semigroup in real Hilbert spaces. Methods: We prove a strong convergence theorem of the iterative algorithm in Hilbert spaces under certain mild conditions. Results: We obtain a strong convergence result for approximating a common solution of a split generalized equilibrium problem and a fixed point problem for a nonexpansive semigroup in real Hilbert spaces, which is a unique solution of a variational inequality problem. Further, we obtain some consequences of our main result. Conclusions: The results presented in this paper are the supplement, extension, and generalization of results in the study of Plubtieng and Punpaeng and that of Cianciaruso et al. The approach of the proof given in this paper is also different.

## Introduction

Throughout the paper, unless otherwise stated, let $H_{1}$ and $H_{2}$ be real Hilbert spaces with inner product $\langle\cdot, \cdot\rangle$ and norm $\|\cdot\|$. Let $C$ and $Q$ be nonempty closed convex subsets of $H_{1}$ and $H_{2}$, respectively.
A mapping $f: C \rightarrow C$ is said to be a contraction if there exists a constant $\alpha \in(0,1)$ such that $\|f x-f y\| \leq$ $\alpha\|x-y\|, \forall x, y \in C$. A mapping $T: C \rightarrow C$ is said to be nonexpansive if $\|T x-T y\| \leq\|x-y\|, \forall x, y \in C$. $\operatorname{Fix}(T)$ denotes the fixed point set of the nonexpansive mapping $T: C \rightarrow C$.
Let $B: H_{1} \rightarrow H_{1}$ be a strongly positive linear bounded operator, i.e., if there exists a constant $\bar{\gamma}>0$ such that

\langle B x, x\rangle \geq \bar{\gamma}\|x\|^{2}, \quad \forall x \in H_{1} .
$$

A typical problem is to minimize a quadratic function over the set of fixed points of nonexpansive mapping $T$ :

$$
\min _{x \in \operatorname{Fix}(T)} \frac{1}{2}\langle B x, x\rangle-\langle x, b\rangle,
$$

where $b$ is a given point in $H_{1}$.
In 2006, Marino and Xu [1] considered the following iterative method:

$$
x_{n+1}=\alpha_{n} \gamma f\left(x_{n}\right)+\left(I-\alpha_{n} B\right) T x_{n}, \quad \forall n \geq 0,
$$

with $0<\gamma<\frac{\bar{\gamma}}{\alpha}$ and proved that the sequence $\left\{x_{n}\right\}$ converges strongly to the unique solution of the variational inequality

$$
\langle(B-\gamma f) z, x-z\rangle, \quad \forall x \in \operatorname{Fix}(T)
$$

which is the optimality condition for the minimization problem

$$
\min _{x \in \operatorname{Fix}(T)} \frac{1}{2}\langle B x, x\rangle-h(x)
$$

where $h$ is the potential function for $\gamma f$.

A family $S:=\{T(s): 0 \leq s<\infty\}$ of mappings from $C$ into itself is called a nonexpansive semigroup on $C$ if it satisfies the following conditions:
(i) $T(0) x=x$ for all $x \in C$.
(ii) $T(s+t)=T(s) T(t)$ for all $s, t \geq 0$.
(iii) $\|T(s) x-T(s) y\| \leq\|x-y\|$ for all $x, y \in C$ and $s \geq 0$.
(iv) For all $x \in C, s \mapsto T(s) x$ is continuous.

The set of all the common fixed points of a family $S$ is denoted by $\operatorname{Fix}(S)$, i.e.,

$$
\begin{aligned}
\operatorname{Fix}(S): & =\{x \in C: T(s) x=x, 0 \leq s<\infty\} \\
& =\bigcap_{0 \leq s<\infty} \operatorname{Fix}(T(s)),
\end{aligned}
$$

where $\operatorname{Fix}(T(s))$ is the set of fixed points of $T(s)$. It is well known that $\operatorname{Fix}(S)$ is closed and convex.
The fixed point problem (FPP) for a nonexpansive semigroup $S$ is:

Find $x \in C$ such that $x \in \operatorname{Fix}(S)$.
In 1997, Shimizu and Takahashi [2] introduced and studied the following iterative method to prove a strong convergence theorem for FPP (1) in a real Hilbert space:

$$
x_{n+1}=\alpha_{n} u+\left(1-\alpha_{n}\right) \frac{1}{s_{n}} \int_{0}^{s_{n}} T(s) x_{n} d s, \quad \forall n \in \mathbb{N},
$$

where $\left\{\alpha_{n}\right\}$ is a sequence in $(0,1)$ and $\left\{s_{n}\right\}$ is a sequence of positive real numbers which diverges to $+\infty$. Later, Chen and Song [3] introduced and studied the following iterative method to prove a strong convergence theorem for FPP (1) in a real Hilbert space:

$$
x_{n+1}=\alpha_{n} f\left(x_{n}\right)+\left(1-\alpha_{n}\right) \frac{1}{s_{n}} \int_{0}^{s_{n}} T(s) x_{n} d s, \quad \forall n \in \mathbb{N},
$$

where $f$ is a contraction mapping. Recently, Plubtieng and Punpaeng [4] introduced and studied the following iterative method to prove a strong convergence theorem for FPP (1) in a real Hilbert space:

$$
\begin{aligned}
x_{n+1}= & \alpha_{n} f\left(x_{n}\right)+\beta_{n} x_{n} \\
& +\left(1-\alpha_{n}-\beta_{n}\right) \frac{1}{s_{n}} \int_{0}^{s_{n}} T(s) x_{n} d s, \quad \forall n \in \mathbb{N},
\end{aligned}
$$

where $\left\{\alpha_{n}\right\}$ and $\left\{\beta_{n}\right\}$ are the sequences in $(0,1)$ and $\left\{s_{n}\right\}$ is a positive real divergent sequence.
The equilibrium problem (EP) [5] is of finding $x \in C$ such that

$$
\begin{equation*}
F(x, y) \geq 0, \quad \forall y \in C \tag{2}
\end{equation*}
$$

where $F: C \times C \rightarrow \mathbb{R}$ is a bifunction. The solution set of $\mathrm{EP}(2)$ is denoted by $\operatorname{EP}(F)$.

Cianciaruso et al. [6] introduced and studied the following iterative method to prove a strong convergence theorem for FPP (1) and EP (2) in a real Hilbert space: $x_{0} \in H_{1}$ :

$$
\begin{aligned}
& x_{n+1}=\alpha_{n} \gamma f\left(x_{n}\right)+\left(1-\alpha_{n} B\right) \frac{1}{s_{n}} \int_{0}^{s_{n}} T(s) u_{n} d s, \quad \forall n \in \mathbb{N}, \\
& F\left(u_{n}, y\right)+\frac{1}{r_{n}}\left\langle y-u_{n}, u_{n}-x_{n}\right\rangle \geq 0, \quad \forall y \in H_{1},
\end{aligned}
$$

where $\left\{\alpha_{n}\right\}$ is a sequence in $(0,1)$ and $\left\{s_{n}\right\}$ is a positive real divergent sequence.
Recently, Moudafi [7] introduced the following split equilibrium problem (SEP):
Let $F_{1}: C \times C \rightarrow \mathbb{R}$ and $F_{2}: Q \times Q \rightarrow \mathbb{R}$ be nonlinear bifunctions and $A: H_{1} \rightarrow H_{2}$ be a bounded linear operator, then the SEP is to find $x^{*} \in C$ such that

$$
\begin{equation*}
F_{1}\left(x^{*}, x\right) \geq 0, \quad \forall x \in C \tag{3}
\end{equation*}
$$

and such that

$$
\begin{equation*}
y^{*}=A x^{*} \in Q \text { solves } F_{2}\left(y^{*}, y\right) \geq 0, \quad \forall y \in Q . \tag{4}
\end{equation*}
$$

When looked separately, (3) is the classical EP, and we denoted its solution set by $\operatorname{EP}\left(F_{1}\right)$. SEP (3)-(4) constitutes a pair of equilibrium problems which have to be solved so that the image $y^{*}=A x^{*}$, under a given bounded linear operator $A$, of the solution $x^{*}$ of EP (3) in $H_{1}$ is the solution of another EP (4) in another space $H_{2}$, and we denote the solution set of EP (4) by $\operatorname{EP}\left(F_{2}\right)$.
The solution set of SEP (3)-(4) is denoted by $\Omega=\{p \in$ $\left.\operatorname{EP}\left(F_{1}\right): A p \in \operatorname{EP}\left(F_{2}\right)\right\}$. SEP (3)-(4) includes the split variational inequality problem, split zero problem, and split feasibility problem (see, for instance, [7-12]).
In this paper, we consider a split generalized equilibrium problem (SGEP): Find $x^{*} \in C$ such that

$$
\begin{equation*}
F_{1}\left(x^{*}, x\right)+h_{1}\left(x^{*}, x\right) \geq 0, \quad \forall x \in C \tag{5}
\end{equation*}
$$

and such that

$$
\begin{equation*}
y^{*}=A x^{*} \in Q \text { solves } F_{2}\left(y^{*}, y\right)+h_{2}\left(y^{*}, y\right) \geq 0, \quad \forall y \in Q, \tag{6}
\end{equation*}
$$

where $F_{1}, h_{1}: C \times C \rightarrow \mathbb{R}$ and $F_{2}, h_{2}: Q \times Q \rightarrow \mathbb{R}$ are nonlinear bifunctions and $A: H_{1} \rightarrow H_{2}$ is a bounded linear operator.
We denote the solution set of generalized equilibrium problem (GEP) (5) and GEP (6) by $\operatorname{GEP}\left(F_{1}, h_{1}\right)$ and $\operatorname{GEP}\left(F_{2}, h_{2}\right)$, respectively. The solution set of SGEP (5)-(6) is denoted by $\Gamma=\left\{p \in \operatorname{GEP}\left(F_{1}, h_{1}\right): A p \in \operatorname{GEP}\left(F_{2}, h_{2}\right)\right\}$.
If $h_{1}=0$ and $h_{2}=0$, then SGEP (5)-(6) reduces to SEP (3)-(4). If $h_{2}=0$ and $F_{2}=0$, then SGEP (5)-(6) reduces to the equilibrium problem considered by Cianciaruso et al. [13].

Motivated by the works of Moudafi [7], Marino and Xu [1], Shimizu and Takahashi [2], Chen and Song [3], Plubtieng and Punpaeng [4], and Cianciaruso et al. [6,13] and by the ongoing research in this direction, we introduce and study an iterative method for approximating a common solution of SGEP (5)-(6) and FPP (6) for a nonexpansive semigroup in real Hilbert spaces. The results presented in this paper extend and generalize the works of Shimizu and Takahashi [2], Chen and Song [3], Plubtieng and Punpaeng [4], and Cianciaruso et al. [6].
Now, we recall some concepts and results which are needed in sequel.
For every point $x \in H_{1}$, there exists a unique nearest point in $C$ denoted by $P_{C} x$ such that

$$
\begin{equation*}
\left\|x-P_{C} x\right\| \leq\|x-y\|, \quad \forall y \in C . \tag{7}
\end{equation*}
$$

$P_{C}$ is called the metric projection of $H_{1}$ onto $C$. It is well known that $P_{C}$ is a nonexpansive mapping and is characterized by the following property:

$$
\begin{equation*}
\left\langle x-P_{C} x, y-P_{C} x\right\rangle \leq 0 . \tag{8}
\end{equation*}
$$

Further, it is well known that every nonexpansive operator $T: H_{1} \rightarrow H_{1}$ satisfies, for all $(x, y) \in H_{1} \times H_{1}$, the inequality

$$
\begin{align*}
\langle(x-T(x)) & -(y-T(y)), T(y)-T(x)\rangle \\
& \leq(1 / 2) \|(T(x)-x)-\left(T(y)-y \|^{2}\right. \tag{9}
\end{align*}
$$

and therefore, we get, for all $(x, y) \in H_{1} \times \operatorname{Fix}(T)$,

$$
\begin{equation*}
\langle x-T(x), y-T(x)\rangle \leq(1 / 2)\|T(x)-x\|^{2} \tag{10}
\end{equation*}
$$

(see, e.g., Theorem 3 in [14] and Theorem 1 in [15]).
It is also known that $H_{1}$ satisfies Opial's condition [16], i.e., for any sequence $\left\{x_{n}\right\}$ with $x_{n} \rightharpoonup x$, the inequality

$$
\begin{equation*}
\lim \inf _{n \rightarrow \infty}\left\|x_{n}-x\right\|<\lim \inf _{n \rightarrow \infty}\left\|x_{n}-y\right\| \tag{11}
\end{equation*}
$$

holds for every $y \in H_{1}$ with $y \neq x$.
Lemma 1. [17] Let $\left\{x_{n}\right\}$ and $\left\{y_{n}\right\}$ be bounded sequences in a Banach space $X$ and $\left\{\beta_{n}\right\}$ be a sequence in $[0,1]$ with $0<\lim \inf _{n \rightarrow \infty} \beta_{n} \leq \lim \sup _{n \rightarrow \infty} \beta_{n}<1$. Suppose $x_{n+1}=(1-$ $\left.\beta_{n}\right) y_{n}+\beta_{n} x_{n}$, for all integers $n \geq 0$ and $\lim \sup \left(\| y_{n+1}-\right.$ $\left.y_{n}\|-\| x_{n+1}-x_{n} \|\right) \leq 0$. Then, $\lim _{n \rightarrow \infty}\left\|y_{n}-x_{n}\right\|=0$.

Lemma 2. [2] Let $C$ be a nonempty bounded closed convex subset of a Hilbert space $H_{1}$ and let $S:=\{T(s): 0 \leq$ $s<\infty\}$ be a nonexpansive semigroup on $C$, for each $x \in C$ and $t>0$. Then, for any $0 \leq h<\infty$,

$$
\lim _{t \rightarrow \infty} \sup _{x \in C}\left\|\frac{1}{t} \int_{0}^{t} T(s) x d s-T(h)\left(\frac{1}{t} \int_{0}^{t} T(s) x d s\right)\right\|=0
$$

Lemma 3. [18] Let $\left\{a_{n}\right\}$ be a sequence of nonnegative real numbers such that

$$
a_{n+1} \leq\left(1-\alpha_{n}\right) a_{n}+\delta_{n}, \quad n \geq 0
$$

where $\left\{\alpha_{n}\right\}$ is a sequence in $(0,1)$ and $\left\{\delta_{n}\right\}$ is a sequence in $\mathbb{R}$ such that
(i) $\sum_{n=1}^{\infty} \alpha_{n}=\infty$.
(ii) $\lim \sup _{n \rightarrow \infty} \frac{\delta_{n}}{\alpha_{n}} \leq 0$ or $\sum_{n=1}^{\infty}\left|\delta_{n}\right|<\infty$.

Then, $\lim _{n \rightarrow \infty} a_{n}=0$.
Lemma 4. [1] Assume that $B$ is a strong positive linear bounded operator on a Hilbert space $H_{1}$ with coefficient $\bar{\gamma}>0$ and $0<\rho<\|B\|^{-1}$. Then, $\|I-\rho B\| \leq 1-\rho \bar{\gamma}$.

Lemma 5. The following inequality holds in a real Hilbert space $H_{1}$ :

$$
\|x+y\|^{2} \leq\|x\|^{2}+2\langle y, x+y\rangle, \quad \forall x, y \in H_{1} .
$$

Assumption 1 [19] Let $F: C \times C \longrightarrow \mathbb{R}$ be a bifunction satisfying the following assumptions:
(i) $F(x, x) \geq 0, \forall x \in C$,
(ii) $F$ is monotone, i.e., $F(x, y)+F(y, x) \leq 0, \forall x \in C$,
(iii) $F$ is upper hemicontinuous, i.e., for each $x, y, z \in C$, $\lim \sup _{t \rightarrow 0} F(t z+(1-t) x, y) \leq F(x, y)$,
(iv) For each $x \in C$ fixed, the function $y \rightarrow F(x, y)$ is convex and lower semicontinuous;
let $h: C \times C \longrightarrow \mathbb{R}$ such that
(i) $h(x, x) \geq 0, \forall x \in C$,
(ii) For each $y \in C$ fixed, the function $x \rightarrow h(x, y)$ is upper semicontinuous,
(iii) For each $x \in C$ fixed, the function $y \rightarrow h(x, y)$ is convex and lower semicontinuous,
and assume that for fixed $r>0$ and $z \in C$, there exists a nonempty compact convex subset $K$ of $H_{1}$ and $x \in C \cap K$ such that

$$
F(y, x)+h(y, x)+\frac{1}{r}\langle y-x, x-z\rangle<0, \quad \forall y \in C \backslash K .
$$

The proof of the following lemma is similar to the proof of Lemma 2.13 in [19] and hence omitted.

Lemma 6. Assume that $F_{1}, h_{1}: C \times C \longrightarrow \mathbb{R}$ satisfying Assumption 1. Let $r>0$ and $x \in H_{1}$. Then, there exists $z \in C$ such that

$$
F_{1}(z, y)+h_{1}(z, y)+\frac{1}{r}\langle y-z, z-x\rangle \geq 0, \quad \forall y \in C .
$$

Lemma 7. [12] Assume that the bifunctions $F_{1}, h_{1}: C \times$ $C \longrightarrow \mathbb{R}$ satisfy Assumption 1 and $h_{1}$ is monotone. For $r>$ 0 and for all $x \in H_{1}$, define a mapping $T_{r}^{\left(F_{1}, h_{1}\right)}: H_{1} \rightarrow C$ as follows:

$$
\begin{aligned}
T_{r}^{\left(F_{1}, h_{1}\right)}(x)= & \left\{z \in C: F_{1}(z, y)+h_{1}(z, y)\right. \\
& \left.+\frac{1}{r_{n}}\langle y-z, z-x\rangle \geq 0, \quad \forall y \in C\right\}
\end{aligned}
$$

Then, the following hold:
(i) $T_{r}^{\left(F_{1}, h_{1}\right)}$ is single-valued.
(ii) $T_{r}^{\left(F_{1}, h_{1}\right)}$ is firmly nonexpansive, i.e.,

$$
\begin{gathered}
\left\|T_{r}^{\left(F_{1}, h_{1}\right)} x-T_{r}^{\left(F_{1}, h_{1}\right)} y\right\|^{2} \leq\left\langle T_{r}^{\left(F_{1}, h_{1}\right)} x-T_{r}^{\left(F_{1}, h_{1}\right)} y, x-y\right\rangle, \\
\forall x, y \in H_{1} .
\end{gathered}
$$

(iii) $\operatorname{Fix}\left(T_{r}^{\left(F_{1}, h_{1}\right)}\right)=\operatorname{GEP}\left(F_{1}, h_{1}\right)$.
(iv) $\operatorname{GEP}\left(F_{1}, h_{1}\right)$ is compact and convex.

Further, assume that $F_{2}, h_{2}: Q \times Q \longrightarrow \mathbb{R}$ satisfying Assumption 1. For $s>0$ and for all $w \in H_{2}$, define a mapping $T_{s}^{\left(F_{2}, h_{2}\right)}: H_{2} \rightarrow Q$ as follows:

$$
\begin{aligned}
T_{s}^{\left(F_{2}, h_{2}\right)}(w)= & \left\{d \in Q: F_{2}(d, e)+h_{2}(d, e)\right. \\
& \left.+\frac{1}{s}\langle e-d, d-w\rangle \geq 0, \forall e \in Q\right\}
\end{aligned}
$$

Then, we easily observe that $T_{s}^{\left(F_{2}, h_{2}\right)}$ is single-valued and firmly nonexpansive, $\operatorname{GEP}\left(F_{2}, h_{2}, Q\right)$ is compact and convex, and $\operatorname{Fix}\left(T_{s}^{\left(F_{2}, h_{2}\right)}\right)=\operatorname{GEP}\left(F_{2}, h_{2}, Q\right)$, where $\operatorname{GEP}\left(F_{2}, h_{2}, Q\right)$ is the solution set of the following generalized equilibrium problem:
Find $y^{*} \in Q$ such that $F_{2}\left(y^{*}, y\right)+h_{2}\left(y^{*}, y\right) \geq 0, \forall y \in Q$.
We observe that $\operatorname{GEP}\left(F_{2}, h_{2}\right) \subset \operatorname{GEP}\left(F_{2}, h_{2}, Q\right)$. Further, it is easy to prove that $\Gamma$ is a closed and convex set.

Remark 1. Lemmas 6 and 7 are slight generalizations of Lemma 3.5 in [13] where the equilibrium condition $F_{1}(x, x)=h_{1}(x, x)=0$ has been relaxed to $F_{1}(x, x) \geq 0$ and $h_{1}(x, x) \geq 0$ for all $x \in C$. Further, the monotonicity of $h_{1}$ in Lemma 6 is not required.

Lemma 8. [13] Let $F_{1}: C \times C \longrightarrow \mathbb{R}$ be a bifunction satisfying Assumption 1 hold and let $T_{r}^{F_{1}}$ be defined as in Lemma 4 for $r>0$. Let $x, y \in H_{1}$ and $r_{1}, r_{2}>0$. Then,

$$
\left\|T_{r_{2}}^{F_{1}} y-T_{r_{1}}^{F_{1}} x\right\| \leq\|y-x\|+\left|\frac{r_{2}-r_{1}}{r_{2}}\right|\left\|T_{r_{2}}^{F_{1}} y-y\right\| .
$$

Notation. Let $\left\{x_{n}\right\}$ be a sequence in $H_{1}$, then $x_{n} \rightarrow x$ (respectively, $x_{n} \rightharpoonup x$ ) denotes strong (respectively, weak) convergence of the sequence $\left\{x_{n}\right\}$ to a point $x \in H_{1}$.

## Methods

In this section, we prove a strong convergence theorem based on the proposed iterative method for computing the approximate common solution of SGEP (5)-(6) and FPP (1) for a nonexpansive semigroup in real Hilbert spaces.

We assume that $\Gamma \neq \emptyset$.

Theorem 1. Let $H_{1}$ and $H_{2}$ be two real Hilbert spaces and let $C \subseteq H_{1}$ and $Q \subseteq H_{2}$ be nonempty closed convex subsets. Let $A: H_{1} \rightarrow H_{2}$ be a bounded linear operator. Assume that $F_{1}, h_{1}: C \times C \rightarrow \mathbb{R}$ and $F_{2}, h_{2}: Q \times Q \rightarrow$ $\mathbb{R}$ are the bifunctions satisfying Assumption $1 ; h_{1}, h_{2}$ are monotone and $F_{2}$ is upper semicontinuous in the first argument. Let $S=\{T(s): 0 \leq s<\infty\}$ be a nonexpansive semigroup on $C$ such that $\operatorname{Fix}(S) \cap \Gamma \neq \emptyset$. Let $f: C \rightarrow C$ be a contraction mapping with constant $\alpha \in(0,1)$ and $B$ be a strongly positive linear bounded self-adjoint operator on $H_{1}$ with constant $\bar{\gamma}>0$ such that $0<\gamma<\frac{\bar{\gamma}}{\alpha}<\gamma+\frac{1}{\alpha}$. Let $\left\{s_{n}\right\}$ is a positive real sequence which diverges to $+\infty$. For a given $x_{0} \in C$ arbitrarily, let the iterative sequences $\left\{u_{n}\right\}$ and $\left\{x_{n}\right\}$ be generated by iterative algorithm:

$$
\begin{align*}
u_{n}= & T_{r_{n}}^{\left(F_{1}, h_{1}\right)}\left(x_{n}+\delta A^{*}\left(T_{r_{n}}^{\left(F_{2}, h_{2}\right)}-I\right) A x_{n}\right) ; \\
x_{n+1}= & \alpha_{n} \gamma f\left(x_{n}\right)+\beta_{n} x_{n}  \tag{12}\\
& +\left(\left(1-\beta_{n}\right) I-\alpha_{n} B\right) \frac{1}{s_{n}} \int_{0}^{s_{n}} T(s) u_{n} d s,
\end{align*}
$$

where $r_{n} \subset(0, \infty)$ and $\delta \in(0,1 / L), L$ is the spectral radius of the operator $A^{*} A$, and $A^{*}$ is the adjoint of $A$, and $\left\{\alpha_{n}\right\}$ and $\left\{\beta_{n}\right\}$ are the sequences in $(0,1)$ satisfying the following conditions:
(i) $\lim _{n \rightarrow \infty} \alpha_{n}=0$ and $\sum_{n=0}^{\infty} \alpha_{n}=\infty$.
(ii) $0<\lim \inf _{n \rightarrow \infty} \beta_{n} \leq \lim \sup _{n \rightarrow \infty} \beta_{n}<1$.
(iii) $\liminf r_{n}>0$ and $\lim _{n \rightarrow \infty}\left|r_{n+1}-r_{n}\right|=0$.
(iv) $\lim _{n \rightarrow \infty} \frac{\left|s_{n+1}-s_{n}\right|}{s_{n+1}}=0$.

Then, the sequence $\left\{x_{n}\right\}$ converges strongly to $z \in$ $\operatorname{Fix}(S) \cap \Gamma$, where $z=P_{\operatorname{Fix}(S) \cap \Gamma}(I-B+\gamma f) z$.

Since $\| u_{n}-$ $x_{n} \| \rightarrow 0, u_{n} \rightharpoonup w$ as $n \rightarrow \infty$ and $\left\{x_{n}\right\}$ is bounded, there exists a subsequence $\left\{x_{n_{k}}\right\}$ of $\left\{x_{n}\right\}$ such that $x_{n_{k}} \rightharpoonup w$, and since $A$ is a bounded linear operator, so $A x_{n_{k}} \rightharpoonup A w$.
Now, setting $v_{n_{k}}=A x_{n_{k}}-T_{r_{n_{k}}}^{F_{2}} A x_{n_{k}}$. It follows from (31) that $\lim _{k \rightarrow \infty} v_{n_{k}}=0$ and $A x_{n_{k}}-v_{n_{k}}=T_{r_{n_{k}}}^{F_{2}} A x_{n_{k}}$.
Therefore, from Lemma 7, we have

Since $F_{2}$ and $h_{2}$ are upper semicontinuous in the first argument, taking lim sup to above inequality as $k \rightarrow \infty$ and using condition (iii), we obtain

which means that $A w \in \operatorname{GEP}\left(F_{2}, h_{2}\right)$, and hence, $w \in \Gamma$.
Next, we claim that $\lim \sup \left\langle f(z)-z, x_{n}-z\right\rangle \leq 0$, where
$z=P_{\operatorname{Fix}(S) \cap \Gamma}(I-B+\gamma f) z$. Now, from (8), we have

Finally, we show that $x_{n} \rightarrow z$ :

\leq & \left\|\beta_{n}\left(x_{n}-z\right)+\left[\left(1-\beta_{n}\right) I-\alpha_{n} B\right]\left(t_{n}-z\right)\right\|^{2} \\
& +2 \alpha_{n}\left\langle\gamma f\left(x_{n}\right)-B z, x_{n+1}-z\right\rangle \\
\leq & {\left[\left\|\left(\left(1-\beta_{n}\right) I-\alpha_{n} B\right)\left(t_{n}-z\right)\right\|\right.} \\
& \left.+\left\|\beta_{n}\left(x_{n}-z\right)\right\|\right]^{2}+2 \alpha_{n} \gamma\left\langle f\left(x_{n}\right)\right. \\
& \left.-f(z), x_{n+1}-z\right\rangle+2 \alpha_{n}\langle\gamma f(z) \\
& \left.-B z, x_{n+1}-z\right\rangle \\
\leq & {\left.\left[\left(1-\beta_{n}\right)-\alpha_{n} \bar{\gamma}\right)\left\|x_{n}-z\right\|+\beta_{n}\left\|x_{n}-z\right\|\right]^{2} } \\
& +2 \alpha_{n} \gamma \alpha\left\|x_{n}-z\right\|\left\|x_{n+1}-z\right\| \\
& +2 \alpha_{n}\left\langle\gamma f(z)-B z, x_{n+1}-z\right\rangle \\
\leq & \left(1-\alpha_{n} \bar{\gamma}\right)^{2}\left\|x_{n}-z\right\|^{2}+\alpha_{n} \gamma \alpha\left\{\left\|x_{n}-z\right\|^{2}\right. \\
& \left.+\left\|x_{n+1}-z\right\|^{2}\right\}+2 \alpha_{n}\left\langle\gamma f(z)-B z, x_{n+1}-z\right\rangle \\
\leq & \left(1-\alpha_{n} \bar{\gamma}\right)^{2}\left\|x_{n}-z\right\|^{2}+\alpha_{n} \gamma \alpha\left\|x_{n}-z\right\|^{2} \\
& +\gamma \alpha\left\|x_{n+1}-z\right\|^{2}+2 \alpha_{n}\langle\gamma f(z) \\

This implies that

& +\frac{2 \alpha_{n}}{1-\gamma \alpha}\left\langle\gamma f(z)-B z, x_{n+1}-z\right\rangle \\
= & {\left[1-\frac{2(\bar{\gamma}-\gamma \alpha) \alpha_{n}}{1-\gamma \alpha}\right]\left\|x_{n}-z\right\|^{2}+\frac{\left(\alpha_{n} \bar{\gamma}\right)^{2}}{1-\gamma \alpha}\left\|x_{n}-z\right\|^{2} } \\
& +\frac{2 \alpha_{n}}{1-\gamma \alpha}\left\langle\gamma f(z)-B z, x_{n+1}-z\right\rangle \\
\leq & {\left[1-\frac{2(\bar{\gamma}-\gamma \alpha) \alpha_{n}}{1-\gamma \alpha}\right]\left\|x_{n}-z\right\|^{2}+\frac{2(\bar{\gamma}-\gamma \alpha) \alpha_{n}}{1-\gamma \alpha} } \\
& \times\left\{\frac{\left(\alpha_{n} \bar{\gamma}^{2}\right) M}{2(\bar{\gamma}-\gamma \alpha)}+\frac{1}{\bar{\gamma}-\gamma \alpha}\left\langle\gamma f(z)-B z, x_{n+1}-z\right\rangle\right\} \\
= & \left(1-\delta_{n}\right)\left\|x_{n}-z\right\|^{2}+\delta_{n} \sigma_{n}, \tag{34}

where $M:=\sup \left\{\left\|x_{n}-z\right\|^{2}: n \geq 1\right\}, \delta_{n}=\frac{2(\bar{\gamma}-\gamma \alpha) \alpha_{n}}{1-\gamma \alpha}$, and $\sigma_{n}=\frac{\left(\alpha_{n} \bar{\gamma}^{2}\right) M}{2(\bar{\gamma}-\gamma \alpha)}+\frac{1}{\bar{\gamma}-\gamma \alpha}\left\langle\gamma f(z)-B z, x_{n+1}-z\right\rangle$. Since $\lim _{n \rightarrow \infty} \alpha_{n}=0$ and $\sum_{n=0}^{\infty} \alpha_{n}=\infty$, it is easy to see that $\lim _{n \rightarrow \infty} \delta_{n}=0, \sum_{n=0}^{\infty} \delta_{n}=\infty$, and $\lim \sup _{n \rightarrow \infty} \sigma_{n} \leq 0$. Hence, from (33), (34), and Lemma 3, we deduce that $x_{n} \rightarrow z$. This completes the proof.
We have the following consequences of Theorem 1.
Corollary 1. Let $H_{1}$ and $H_{2}$ be two real Hilbert spaces and let $C \subseteq H_{1}$ and $Q \subseteq H_{2}$ be nonempty closed convex subsets. Let $A: H_{1} \rightarrow H_{2}$ be a bounded linear operator. Assume that $F_{1}: C \times C \rightarrow \mathbb{R}$ and $F_{2}: Q \times Q \rightarrow \mathbb{R}$ are the bifunctions satisfying Assumption 1 and $F_{2}$ is upper semicontinuous in the first argument. Let $S=\{T(s)$ : $0 \leq s<\infty\}$ be a nonexpansive semigroup on $C$ such that Fix $(S) \cap \Omega \neq \emptyset$. Let $f: C \rightarrow C$ be a contraction mapping with constant $\alpha \in(0,1)$ and $B$ be a strongly positive linear bounded self-adjoint operator on $H_{1}$ with constant $\bar{\gamma}>0$ such that $0<\gamma<\frac{\bar{\gamma}}{\alpha}<\gamma+\frac{1}{\alpha}$. Let $\left\{s_{n}\right\}$ is a
positive real sequence which diverges to $+\infty$. For a given $x_{0} \in C$ arbitrarily, let the iterative sequences $\left\{u_{n}\right\}$ and $\left\{x_{n}\right\}$ be generated by

u_{n}= & T_{r_{n}}^{F_{1}}\left(x_{n}+\delta A^{*}\left(T_{r_{n}}^{F_{2}}-I\right) A x_{n}\right) ; \\
x_{n+1}= & \alpha_{n} \gamma f\left(x_{n}\right)+\beta_{n} x_{n} \\
& +\left(\left(1-\beta_{n}\right) I-\alpha_{n} B\right) \frac{1}{s_{n}} \int_{0}^{s_{n}} T(s) u_{n} d s,
\end{aligned}

where $r_{n} \subset(0, \infty)$ and $\delta \in(0,1 / L), L$ is the spectral radius of the operator $A^{*} A$, and $A^{*}$ is the adjoint of $A$, and $\left\{\alpha_{n}\right\}$ and $\left\{\beta_{n}\right\}$ are the sequences in $(0,1)$ satisfying the following conditions:
(i) $\lim _{n \rightarrow \infty} \alpha_{n}=0$ and $\sum_{n=0}^{\infty} \alpha_{n}=\infty$.
(ii) $0<\lim \inf _{n \rightarrow \infty} \beta_{n} \leq \lim \sup _{n \rightarrow \infty} \beta_{n}<1$.
(iii) $\lim \inf _{n \rightarrow \infty} r_{n}>0, \sum_{n=1}^{\infty}\left|r_{n+1}-r_{n}\right|<\infty$.
(iv) $\lim _{n \rightarrow \infty} \frac{\left|s_{n+1}-s_{n}\right|}{s_{n+1}}=0$.

Then, the sequence $\left\{x_{n}\right\}$ converges strongly to $z \in \operatorname{Fix}(S) \cap$ $\Omega$, where $z=P_{F i x(S) \cap \Omega}(I-B+\gamma f) z$.

Proof. Taking $h_{1}=h_{2}=0$ in Theorem 1, then the conclusion of Corollary 1 is obtained.

Corollary 2. [6] Let $H$ be a real Hilbert space and let $C \subseteq H$ be a nonempty closed convex subset. Assume that $F: C \times C \rightarrow \mathbb{R}$ is a bifunction satisfying Assumption 1 for Fonly. Let $S=\{T(s): 0 \leq s<\infty\}$ be a nonexpansive semigroup on $C$ such that Fix $(S) \cap E P(F)=\emptyset$. Let $f: C \rightarrow$ $C$ be a contraction mapping with constant $\alpha \in(0,1)$ and $B$ be a strongly positive linear bounded self-adjoint operator on $H$ with constant $\bar{\gamma}>0$ such that $0<\gamma<\frac{\bar{\gamma}}{\alpha}<\gamma+\frac{1}{\alpha}$. Let $\left\{s_{n}\right\}$ is a positive real sequence which diverges to $+\infty$. For a given $x_{0} \in C$ arbitrarily, let the iterative sequences $\left\{u_{n}\right\}$ and $\left\{x_{n}\right\}$ be generated by

& u_{n}=T_{r_{n}}^{F} x_{n} \\
& x_{n+1}=\alpha_{n} \gamma f\left(x_{n}\right)+\left(1-\alpha_{n} B\right) \frac{1}{s_{n}} \int_{0}^{s_{n}} T(s) u_{n} d s,
\end{aligned}
$$

where $r_{n} \subset(0, \infty)$ and $\left\{\alpha_{n}\right\}$ is a sequence in $(0,1)$ satisfying
(i) $\lim _{n \rightarrow \infty} \alpha_{n}=0$ and $\sum_{n=0}^{\infty} \alpha_{n}=\infty$.
(ii) $\lim \inf _{n \rightarrow \infty} r_{n}>0, \sum_{n=1}^{\infty}\left|r_{n+1}-r_{n}\right|<\infty$.
(iii) $\lim _{n \rightarrow \infty} \frac{\left|s_{n+1}-s_{n}\right|}{s_{n+1}}=0$.

Then, the sequence $\left\{x_{n}\right\}$ converges strongly to $z \in \operatorname{PFix}(S) \cap$ $E P(F)$, where $z=P_{F i x(S) \cap E P(F)}(I-B+\gamma f) z$.

Proof. Taking $F_{1}=F_{2}=F, H_{1}=H_{2}=H, h_{1}=h_{2}=0$, $\left\{\beta_{n}\right\}=0$, and $A=0$ in Theorem 1, then the conclusion of Corollary 2 is obtained.

Corollary 3. [4] Let H be a real Hilbert space and let $C \subseteq H$ be a nonempty closed convex subset. Let $S=\{T(s)$ : $0 \leq s<\infty\}$ be a nonexpansive semigroup on $C$ such that Fix $(S) \neq \emptyset$. Let $f: C \rightarrow C$ be a contraction mapping with constant $\alpha \in(0,1)$. Let $\left\{s_{n}\right\}$ be a positive real sequence which diverges to $+\infty$. For a given $x_{0} \in C$ arbitrarily, let the iterative sequence $\left\{x_{n}\right\}$ be generated by

x_{n+1}= & \alpha_{n} \gamma f\left(x_{n}\right)+\beta_{n} x_{n} \\
& +\left(1-\alpha_{n}-\beta_{n}\right) \frac{1}{s_{n}} \int_{0}^{s_{n}} T(s) x_{n} d s,
\end{aligned}
$$

where $\left\{\alpha_{n}\right\}$ and $\left\{\beta_{n}\right\}$ are the sequences in $(0,1)$ satisfying the following conditions:
(i) $\lim _{n \rightarrow \infty} \alpha_{n}=0$ and $\sum_{n=0}^{\infty} \alpha_{n}=\infty$.
(ii) $0<\lim \inf _{n \rightarrow \infty} \beta_{n} \leq \lim \sup _{n \rightarrow \infty} \beta_{n}<1$.
(iii) $\lim _{n \rightarrow \infty} \frac{\left|s_{n+1}-s_{n}\right|}{s_{n+1}}=0$.

Then, the sequence $\left\{x_{n}\right\}$ converges strongly to $z \in \operatorname{Fix}(S)$, where $z=P_{F i x(S)} f(z)$.

Proof. Taking $H_{1}=H_{2}=H, u_{n}=x_{n}, F_{1}=F_{2}=h_{1}=$ $h_{2}=0$, and $B=I$ in Theorem 1, then the conclusion of Corollary 3 is obtained.

## Results and discussion

We introduce and study an iterative method for approximating a common solution of split generalized equilibrium problem and fixed point problem for a nonexpansive semigroup in real Hilbert spaces. We obtain a strong convergence result for approximating a common solution of split generalized equilibrium problem and fixed point problem for a nonexpansive semigroup in real Hilbert spaces. Further, we obtain some consequences of our main result.

## Conclusions

The results presented in this paper extend and generalize the works of Shimizu and Takahashi [2], Chen and Song [3], Plubtieng and Punpaeng [4], and Cianciaruso et al. [6]. The algorithm considered in Theorem 1 is different from those considered in [7-10] in the sense that the variable sequence $\left\{r_{n}\right\}$ has been taken in place of fixed $r$. Further, the approach of the proof presented in this paper is also different. The use of the iterative method presented in this paper for the split monotone variational inclusions considered in Moudafi [9] needs further research effort.
