# Notes

1. Many would prefer to use the ‘actor network theory’ (ANT) formulation to describe how physical artefacts are involved in social systems. While I have no doubt that ANT is highly useful in many studies, I am also sympathetic to criticisms of ANT made by Collins and Yearley (1992, 317–22) about how different stories could be told about apparently the same network. In addition I sympathise with arguments made by Bloor (1999) that we should analyse the impact of physical artefacts through analysing what people believe about them.
2. A horizontal axis wind turbine is the type usually seen, while a vertical axis machine involves the blades moving around the tower rather as a merry-go-round revolves around a central vertical axis.
3. All statistics on wind power are taken from *Wind Power Monthly* except where otherwise indicated.
