Jon Kraus, professor emeritus and former chair, Political Science Department, State University of New York (SUNY)/Fredonia until 2003, now lives in New York City. His research fields include African political economy, democratization in Africa, trade unions, and U.S. foreign policy. Since 1964 he has conducted field research regularly in West Africa, especially in Ghana and Nigeria, and in the Middle East. Dr. Kraus is coauthor/editor of *Transformed by Crisis: The Presidency of George W. Bush* (Palgrave/Macmillan, 2004), contributing a critique of the Bush government's foreign policy. Dr. Kraus has contributed to some twenty books, including *When Parties Fail, Labor and Unions in Asia and Africa*, *Ghana: Political Economy of Reform*, *Soldier and State in Africa*, *Socialism in the Third World*, *Industrial Relations in Africa*, *Africa's Agrarian Crisis*, *Coping with Africa's Food Crisis*, *Privatization and Investment in Sub-Saharan Africa*, *African Development Perspectives Yearbook 4*, *Ghana and the Ivory Coast*, *Political Economy of Foreign Policy in Ecowas States*, and *Africa Contemporary Survey, 1989-90*. He is also the author of twenty-plus articles that have been published in the *Journal of Modern African Studies*, *African Studies Review*, *Development and Change*, *Current History*, *Africa Report*, and *Labor, Capital and Society*. He has served as a consultant to the U.S. Department of State and on AID & USIA contracts on civil society and democratization in Ghana and Nigeria. Dr. Kraus is also a former associate editor/board member of the *Canadian Journal of African Studies*.

Emmanuel Akwetey is the executive director of the Institute of Democratic Governance, a think-tank in Accra, Ghana, through which he maintains regular links with civil society groups and research institutes in Africa to develop governance capabilities. He received his PhD in 1994 from the University of Stockholm with completion of his thesis, *Trade Unions and Democratization: Comparative Study of Zambia and Ghana*. Dr. Akwetey is the author of "Democratic Transition and Post-Colonial Labor Regimes in Zambia and Ghana," in Bjorn Beckman & L. M. Sachikonye, eds., *Labor Regimes and Liberalization* (2001). In Ghana Dr. Akwetey has worked as a research coordinator and public policy analyst on projects for major state and non-state organizations. He has also served as a consultant to the government of Ghana and several international development partners, including the UNDP, the World Bank, the Canadian International Development Agency, and Danida.

Gretchen Bauer is an associate professor in the Department of Political Science and International Relations at the University of Delaware. She is currently serving as associate dean for the Social Sciences and History in the College of Arts and

Sciences. She is the author of *Labor and Democracy in Namibia, 1971–1996* (1998); *Politics in Southern Africa: State and Society in Transition* (2005), with Scott D. Taylor; and *Women in African Parliaments* (2006), edited with Hannah E. Britton. She has also published in the *Journal of Southern African Studies* and the *Journal of Modern African Studies*. Dr. Bauer began her work and study in Africa as a Peace Corps volunteer in Kenya from 1982 to 1983 and was a Ford Foundation intern in Nairobi in the summer of 1989. From 1991 to 1993 she was a visiting research fellow at the Namibia Institute for Social and Economic Research, and during 2002 she was a visiting researcher at the Institute for Public Policy Research in Windhoek, Namibia. Her current research focuses on women in national legislatures in east and southern Africa.

Geoffrey Bergen is currently country program coordinator for Kenya, Eritrea, and Somalia at the World Bank. Since joining that agency in 1993, he has held positions as head of development communications, country manager for Niger, and speechwriter to the president. Dr. Bergen earned his PhD in political science from UCLA in 1994. His dissertation was titled *Unions in Senegal: A Perspective on National Development in Africa*. Dr. Bergen also holds an MA in international relations from the Johns Hopkins School of Advanced International Studies (1985), and a BA in English from the University of California–Berkeley (1977). He was a Peace Corps volunteer in Niger (1977–79) and has worked for the U.S. Department of Labor.

Robert Charlick is a professor of political science and international relations at Cleveland State University. From 1991 to 1994 he was senior governance advisor to the African Bureau of the United States Agency for International Development (USAID). His areas of research specialty are the development of “civil society” as a political force, local organization and democratic development, particularly in West Africa, and conflict prevention and management. Dr. Charlick has participated in and directed studies on these subjects in more than twenty countries, and he has written extensively about rural development, cooperatives, unions, and student organizations in Africa, Asia, and the Caribbean. He is the author of *Niger: Personal Rule and Survival in the Sahel* (1991) and contributor to *The Political Economy of Foreign Policy in Ecowas*, *Democratie et developpement: Mirage ou espoir raisonnable?* and *Transitions in Africa* (forthcoming). He also has published articles in such scholarly journals as *African Studies Review*, *Public Administration and Development*, *African Review*, *Corruption and Reform*, *Rural Africana*, and *Sociology of Education*. Most recently, Dr. Charlick has been working on the nature of Islamism in Africa and its relationship to global economic and political forces.

William Freund has recently retired as professor of economic history at the University of KwaZulu-Natal in South Africa, where he continues to teach part-time. A recent Festschrift in his honor, published by the journal *African Studies* (Johannesburg), outlines his career in the field. His PhD dissertation at Yale University concerned the last phase of Dutch rule at the Cape of South Africa at the start of the nineteenth century. His more recent interests include African political economy, development issues, labor, and urban history. He is the author of, among other titles, *The Making of Contemporary Africa* and *The African Worker*. Dr. Freund

is the coeditor of *(D)urban Vortex: South African City in Transition*. His newest book, *The African City: A History*, was released in 2007 by Cambridge University Press. His 1984 article “Labor and Labor History in African Studies,” in *African Studies Review* is a seminal survey of the field. Apart from his South African experience, he has taught in the past in Nigeria and Tanzania, and at Kirkland College and Harvard University in the United States. He is currently on the experts panel for Corus 2, the development-funding arm of the French foreign ministry.

Richard Saunders is an associate professor in the Department of Political Science at York University, Toronto. From 1986 to 2002 he lived and worked in Zimbabwe as a journalist and civil society researcher and strategist. He has worked closely with the Zimbabwe Congress of Trade Unions and other community-based organizations and civic networks active in the area of social and economic rights. His research and writing focus includes social unionism in southern Africa, media policy, democratization, and regional responses to post-apartheid South African capital flows into neighboring countries. Dr. Saunders is the author of *Dancing Out of Tune: A History of the Media in Zimbabwe* (1999) and *Never the Same Again: Zimbabwe's Growth Towards Democracy, 1980–2000* (2000). His forthcoming book (2007) is *Mediating Zimbabwe: The Press, Politics and Power*.
