

## Notes on Contributors

**Liliana Acero, Ph.D.**, is a Visiting Professor and Course Director at the Institute of Women's Studies, the University of Ottawa on New Reproductive Technologies, Gender and Women in Development, Professor at the Virtual Master's Programme on Gender, Society and Policies at FLACSO and at the Master on Business and International Relations, the University of Belgrano, Argentina and directs two NGOs on Gender, Education, and Health in Argentina and Chile. In 1983, she obtained an Honour's Ph.D. and was a Research and Visiting Fellow at Science Policy Research Unit and the Institute of Development Studies, The University of Sussex, as well as, an Associate Professor and Postdoctoral Researcher at the Universities of Massachusetts, at Amherst and at Brown University. IPSA awarded her as best Senior Researcher on Developing Countries (1993–1994), due to her work on the social, household, and gender impacts of new technologies.

**Cynthia Lee Andruske, Ph.D.**, is a new scholar, recent graduate from the University of British Columbia (UBC) in the Department of Educational Studies, and adjunct professor at the University of Houston Clear Lake where she teaches distance courses on multiculturalism. Through her doctoral dissertation, *"I'm Not Sitting on the Couch Eating Bonbons!"*: *Women's Transitions from Welfare to Paid Work and Education*, she explored women's resistance, welfare policy, self-directed learning, and citizenship. As a Research Associate for the Liu Institute for Global Issues at UBC, she worked with Dr. Spiegel on gender, health, social organization, and globalization issues. She is associated with the Centre for Research in Women's Studies and Gender Relations at UBC. Her publications have featured marginalized women, resistance, popular theater, and literacy. Dr. Andruske's current research focuses on gender, health, cultural influences, resistance globalization, Latin America, and women's citizenship through hospitality.

**Stella Aguinaga Bialous, R.N., MScN, Dr. PH.**, is a nurse, tobacco policy consultant, and the president of Tobacco Policy International. She is the co-investigator of the Tobacco Free Nurses initiative and works as

a consultant for the World Health Organization. She is also a former board member of the International Society of Nurses in Cancer Care and is Chair of the Society's Tobacco Control Task Force. She has published several articles on issues related to international tobacco control policy, monitoring the activities of the tobacco industry, and on nurses and tobacco control. Dr. Bialous is also a member of California's Tobacco Education and Research Oversight Committee (TEROC) and, in 2003, was the first recipient of the American Legacy Foundation's Sybil G. Jacobs Adult Award for Outstanding Use of Tobacco Industry Documents for public health.

**Lisa Sowle Cahill, Ph.D., M.A.**, an active voice in theology and ethics today is J. Donald Monan, S.J., Professor at Boston College. Dr. Cahill is a past president of the Catholic Theological Society of America (1992–1993), and the Society of Christian Ethics (1997–1998), and is a fellow of the American Academy of Arts and Sciences. Her works include *Theology, Bioethics, and Society* (Georgetown University Press, 2005), *Bioethics and the Common Good* (Marquette University Press, 2004), *Family: A Christian Social Perspective* (Fortress, 2000) and *Sex, Gender, and Christian Ethics* (Cambridge University Press, 1996). She is the editor of *Genetics, Theology, Ethics: An Interdisciplinary Conversation* (Crossroad, 2005). Dr. Cahill received her M.A. and Ph.D. degrees from the University of Chicago Divinity School.

**Jeff Collin, Ph.D., M.A.**, is lecturer in the Centre on Global Change and Health at the London School of Hygiene & Tropical Medicine with additional appointments at Cambridge and Bristol. Dr. Collin's research interests are in globalization, tobacco control, health inequalities, and health policy. Currently, he is involved in research projects based on the analysis of tobacco industry documents, funded by the U.S. National Cancer Institute and the Rockefeller Foundation. His recent publications based on these projects include five articles on the tobacco industry in Asia in the special regional supplement of *Tobacco Control*, 2004; 13 (Suppl 2). He is also the author of "Think Global, Smoke Local: Transnational tobacco companies and cognitive globalisation" in Lee K., ed., *Globalization and Health: Case Studies* (London: Palgrave, 2002) and, with K. Lee, *Globalisation & Transborder Health Risk in the UK* (London: Nuffield Trust, 2003).

**Joanne Csete, Ph.D., M.P.H.**, is the Executive Director of the Canadian HIV/AIDS Legal Network. Dr. Csete was most recently the founding director of the HIV/AIDS and Human Rights Program at Human Rights Watch. In this capacity, she oversaw the development of a body of research and an agenda of advocacy actions related to a range of human rights issues linked

to HIV/AIDS, including numerous reports on gender-related human rights abuses. She was previously chief of policy and programs in the regional office of UNICEF in Nairobi, working especially on HIV/AIDS, and before that senior advisor in the Programme Division of UNICEF's New York headquarters. She worked in Africa for about ten years on public health and nutrition programs, mostly in Rwanda, Burundi, Democratic Republic of Congo, and Kenya. Having a doctoral degree in public health nutrition from Cornell University, she was on the faculty of Nutritional Sciences at the University of Wisconsin–Madison from 1988 to 1993.

**Manisha Desai, Ph.D.**, is Associate Professor of Sociology, Acting Director of Women and Gender in Global Perspectives, and Associate Director of the Program in South Asia and Middle Eastern Studies at the University of Illinois at Urbana Champaign. Her research and teaching interests include gender, globalization, feminism, social movements, human rights, and contemporary Indian society. Her most recent book is an edited volume on Women in Asia and Oceania published by Greenwood in 2003. She is currently finishing a book on Gender and Globalization for the Gender Lens Series of Altimira Press.

**Lesley Doyal, M.Sc.**, is Professor of Health and Social Care, School for Policy Studies, University of Bristol and Visiting Fellow, University of Cape Town. Professor Doyal has published widely on international health policy, gender, and health care and gender, health and development. She has a particular interest in the links between gender studies and health studies and in the interface between biological and social sciences. She has acted as a consultant to the WHO, UN, Commonwealth Secretariat, and the Global Forum for Health Research.

**Caren A. Grown, Ph.D., M.A.**, is Director of the Poverty Reduction and Economic Governance team at the International Center for Research on Women, where she leads research on asset accumulation and women's property rights and the impact of multilateral and national economic policies on gender equality. From 1992 to 2001, Grown was a Senior Program Officer at the John D. and Catherine MacArthur Foundation in Chicago, Illinois, where she managed research networks and competitions on a wide range of economic issues. Before joining the MacArthur Foundation, Grown was an economist with the Center for Economic Studies at the U.S. Bureau of the Census. She has guest coedited three special issues of *World Development* on macroeconomics, international trade, and gender inequality, and has written widely on gender and development issues. Grown holds M.A. and Ph.D. degrees in economics from the New School University and a Bachelor's degree in Political Science from UCLA.

**Wendy Harcourt, Ph.D.**, Programme Advisor and Editor of *Development* quarterly journal of the Society for International Development (S.I.D.) (published by Palgrave Macmillan). After receiving her Ph.D. from the Australian National University in 1987, Dr. Harcourt joined S.I.D. in 1988 and since 1995 has been editor of the *Development* journal. She has contributed to S.I.D.'s policy and research work in the fields of gender in development, alternative economics, sustainable development, culture, health, globalization, and reproductive health and rights. She is currently Chairperson of Women in Development Europe.

**Norbert Hirschhorn, M.D.**, is a physician specializing in global public health, and an adjunct lecturer at the School of Public Health, Yale University. His career spans four decades of research and teaching in maternal and child health; more recently he researched the tobacco industry documents released as a result of court cases in the United States. Nominally retired, he provides pro bono services to a global network of tobacco control advocates, and to the National Public Health Institute, Finland.

**Gillian Lewando-Hundt, Ph.D.**, is an applied medical anthropologist. She is the Professor of Social Sciences in Health at the University of Warwick and is Co-director of the Institute of Health ([healthatwarwick.ac.uk](http://healthatwarwick.ac.uk)). She studied at the Universities of Edinburgh and Warwick. She has held posts at Ben Gurion University of the Negev, Israel, at the University of Birmingham and the London School of Hygiene and Tropical Medicine, UK. Her research program "Eliciting Local Voices on Global Health Issues" focuses on working with disadvantaged groups in the area of health inequalities of care and access. She is currently carrying out research in the Middle East, South Africa, and the United Kingdom.

**Theresa Kaijage, Ph.D., M.P.H., M.S.W.**, is with the Institute of Social Work in Dar es Salaam, Tanzania. In 1989, Theresa Kaijage founded WAMATA, a Tanzanian advocacy and counseling group for families affected by HIV/AIDS—the first AIDS service organization in Tanzania. (WAMATA is a Swahili acronym for "People in the Fight Against AIDS in Tanzania.") Kaijage's research focuses on changing behavior and gender roles in a state transitioning from socialism to capitalism under the shadow of HIV/AIDS. Ms. Kaijage is the recipient of a number of distinguished awards in recognition of her unique contributions to Tanzania including the 2000 Teresa Maximus Distinguished Professor of Social Work Award, Marywood University in Pennsylvania; 2002 Shepherd Wellness Community AIDS Candlelight Memorial Award, Pittsburgh, Pennsylvania; 2004 James E. Dixon Humanitarian Award for HIV Education, The Seven Project, Inc.,

Pittsburgh, PA; and the 1997 Distinguished Social Work Alumni Award, George Warren Brown School of Social Work.

**Ulrike Maschewsky-Schneider, Ph.D.**, is Professor at the Institute for Health Sciences, Technical University of Berlin. She is chair of the Berlin Center for Public Health and has been a member in the Executive Committee of the German Society for Social Medicine and Prevention and the German Society of Public Health. Previously, Dr. Maschewsky-Schneider was the Chief of the Department of Epidemiology at Bremen Institute for Prevention Research and Social Medicine. Her research focuses on sociological concepts and methods of the health sciences; evaluation research in health promotion and prevention; and women's health research (including work on women and tobacco). Dr. Maschewsky has published several articles and books and has been involved in numerous research projects, including the first Women's Health Report for Germany and a public health project entitled "Gender Bias-Gender Research?"

**Mahesh Maskey, M.B.B.S., M.P.H., D.Sc.**, is Assistant Professor in Epidemiology in the Department of Community Medicine and Family Health, Institute of Medicine, Tribhuvan University, Nepal. His major research interests are in the field of reproductive health and globalization. He has developed and applied an alternative method of measuring perinatal and neonatal mortality in developing countries. He is actively involved in efforts promoting public health and the health of women and children.

**Carolyn M. Mazure, Ph.D.**, is a Professor of Psychiatry, the Associate Dean for Faculty Affairs at the Yale University School of Medicine, and the Director of Women's Health Research at Yale, an interdisciplinary program focusing on sex differences in health and disease. Her research focuses on factors determining illness onset and treatment response particularly in depression and, more recently, in addictive disorders. Professor Mazure is the Principal Investigator for the NIH-funded Yale Interdisciplinary Women's Health Research Scholar Program on Women and Drug Abuse, the Core PI for the Sex-Specific Factors Core of the NIH-funded Transdisciplinary Tobacco Use Research Center studying sex-related factors in nicotine-dependence and treatment, and the Scientific Program Director for Yale's Specialized Center of Research on Sex, Stress and Cocaine. She has served on review committees for the National Institutes of Health, has been an invited speaker to the U.S. Women's Congressional Caucus, and testified in three consecutive years to the U.S. Congress on the importance of research funding and its practical applications.

**Josephine Nhongo-Simbanegavi, Ph.D.**, is currently a professor of history at the University of Alabama and, until 2003, was at the University of

Zimbabwe. Much of her research focuses on gender and cross-border migration in Southern Africa, looking at sexuality, health, citizenship, and cross-cultural issues. Her most recent book entitled *For Better or Worse? Women and ZANLA in Zimbabwe's Liberation Struggle* is a thought-provoking analysis of women's experiences with ZANLA during the war of independence. Josephine Nhongo-Simbanegavi was recently coordinating a University of Zimbabwe-based research project on the Historical Dimensions of Human Rights and Democracy, of which her own study of gender and international migration was a part. She takes an active interest in research that promotes the integration of the Southern African region into the global network for mutual benefit. As a member of the Overseas Advisory Board and editorial board of the *Journal of Southern African Studies* (JSAS), she contributes to the process by which JSAS identifies its research priorities.

**Jerry Spiegel, Ph.D.**, is Director, Global Health, Liu Institute for Global Issues, Assistant Professor, Health Care and Epidemiology, and Director of the Centre for International Health at University of British Columbia (UBC). Dr. Spiegel currently directs research programs on globalization, social organization, and health and eco-system approaches to human health that place particular emphasis on gender. His focus is on Latin America and he currently heads research projects in Cuba, Mexico, and Ecuador on matters such as the impacts of tourism development on gender and health in coastal communities, sustainable prevention and control of dengue, and effective intersectoral and transdisciplinary methods for managing environmental health risks. Recent publications include: Spiegel JM, Yassi A. "Lessons from the margins of globalization: Appreciating the Cuban health paradox," *Journal of Public Health Policy*, 2004, 25(1): 96–121.

**Michael L. Tan, D.V.M., Ph.D.**, is Associate Professor and chairperson of the Department of Anthropology, University of the Philippines, Diliman, Quezon City, and coordinator for the university's Health, Society and Culture Program. He is a medical anthropologist who has worked on gender and sexuality issues for many years, including, currently, a research capability building project for the Southeast Asian Consortium on Gender, Sexuality and Health. He has worked as an adviser in various government projects and in 1995 he was appointed to the Philippine National AIDS Council, a presidential advisory body. He has acted as a consultant to the World Health Organization, UNICEF, European Commission, DANIDA and other international agencies, and is currently the Philippine Country Program Adviser for The David and Lucile Packard Foundation.
