**M. Stella Atkins** received the BSc degree in Chemistry from Nottingham University in 1966 and the Ph.D. degree in computer science from the University of British Columbia in 1985. She is a Professor in the School of Computing Science at Simon Fraser University (SFU), and director of the Medical Computing Lab at SFU.
