Perver Korça Baran is a research associate professor in both the College of Design and the College of Natural Resources at North Carolina State University. She has a Bachelor of Architecture degree from the University of Kiril i Metodij-Skopje and master's and Ph.D. in urban planning from Istanbul Technical University. Her current research interests center on measuring the quality of urban life, understanding urban and neighborhood spatial structure as it relates to health and socio-psychological processes, and GIS, in particular its potential for urban design and active living research.

Fulin Bölen is an architect and planner and professor emeritus in the Department of Urban and Regional Planning, at the Istanbul Technical University. She served as head of the Department from 2000 until 2003. Her principal research interests and publications deal with urban land values, land-use intensity, and the quality of residential environments. Between 2005 and 2007 she served as team leader of a research project on “The Objective Measures of Quality of Life in Residential Areas” in İstanbul that was used in preparing an environmental plan for the Greater Istanbul Municipal area.

Ying Cao is completing his Ph.D. in the College of Architecture and Environment, Sichuan University in Chengdu, China. From September 2008 to June 2010, he was a visiting scholar at Arizona State University where he collaborated on the Digital Phoenix project in the areas of future land use and water sustainability.

John I. Carruthers is the director of the Sustainable Urban Planning Program at The George Washington University in Washington, DC. His current research focuses on land use and urban form, estimating the value of environmental quality; urban quality of life and sustainability, and immigrant assimilation. His recent research has been published in the *Journal of Regional Science*, *Papers in Regional Science*, *Regional Science and Urban Economics*, and *Urban Studies*. Dr. Carruthers is a member of the RSAI Council, the governing board of the Regional Science Association International. He serves on the editorial boards of several journals,

including the *Annals of Regional Science*, the *Journal of the American Planning Association*, and Papers in Regional Science.

Prem Chhetri is an associate professor of logistics and geographic systems and the deputy head of the School for Industry Engagement at the Royal Melbourne Institute of Technology (RMIT) in Melbourne Australia. He is also the manager for the Urban and Regional Sustainable Future Program within RMIT's Global Cities Institute. His research interests include urban quality of life, emergency logistics and policy response, and application of GIS and GPS technologies in urban modeling and logistics systems analysis.

Donald Dillman currently is Regents Professor in the Department of Sociology and serves as deputy director for Research in the Social and Economic Sciences Research Center at Washington State University, where he has been a faculty member since 1969. From 1991 to 1995 he was senior survey methodologist at the US Bureau of the Census, providing leadership for the development of the 2000 Decennial Census Form and implementation procedures. A past president of the American Association for Public Opinion Research, he is also the recipient of the 2002 Roger Herriot Award for Innovation in Federal Statistics. He has authored more than 250 publications. His 1978 book, *Mail and Telephone Surveys*, was the first to provide step-by-step procedures for conducting such surveys, and is now in its third edition as *Internet, Mail and Mixed-Mode Surveys: The Tailored Design Method* (Wiley 2009).

Subhrajit Guhathakurta is professor and associate director of the School of Geographical Sciences and Urban Planning at Arizona State University (ASU). He is also among the founding faculty members of ASU's School of Sustainability and holds a faculty appointment in that school. Prof. Guhathakurta serves as the lead member of several research centers at ASU including the GeoDa Center for Geospatial Analysis and Computation, Decision Center for a Desert City, and the project on Sustainable Urban Systems, Technologies, and Infrastructure (SUSTaIn). He is author of 5 books and monographs and over 70 scientific papers. He has held visiting appointments at the Center for Urban Spatial Analysis at University College London, the Indian Institute of Information Technology, Bangalore, and at the Center for Sustainable Urban and Regional Futures at the University of Queensland in Brisbane. More recently, he held the German National Science Foundation (DFG) Mercator Guest professorship at Technische Universitat Kaiserslautern, Germany.

Alexander G. Keul is trained as a meteorologist and environmental psychologist. He is currently an associate professor of psychology at Salzburg University in Austria and honorary professor at the Vienna University of Technology. He has been a strong advocate for housing evaluation studies throughout Austria and served as co-organizer of the 2004 International Association of People-Environment Studies (IAPS) 2004 conference in Vienna. Dr. Kuel has headed research projects for the Austrian Safety Research project (KIRAS) and the Austrian Ministry of Agriculture. More recently, he has conducted research on passive solar housing and user satisfaction with housing.

Byoung-Suk Kweon is an assistant professor in the Department of Plant Science & Landscape Architecture, College of Agriculture and Natural Resources at the University of Maryland. Previously, she was a research investigator at the University of Michigan's Institute for Social Research and a faculty member at Texas A and M University. She is a recipient of a national recognition award from the Council of Educators in Landscape Architecture for her research on improving environments for school children. Dr. Kweon is a board member for the Environmental Design Research Association.

Robert W. Marans is a research professor at the Institute for Social Research and a professor emeritus of architecture and urban planning in the Taubman College of Architecture and Urban Planning at the University of Michigan. Marans is a registered architect and is active in recreation policy and planning in southeastern Michigan. He is president of the Washtenaw County Parks and Recreation Commission and commissioner of the Huron-Clinton Metropolitan Authority (HCMA), the governing body responsible for the planning, development, and operations of the metroparks throughout Southeastern Michigan. Dr. Marans is the author or coauthor of 7 books and more than 100 articles and technical reports. He currently serves on the editorial boards of several professional journals and has lectured extensively throughout the USA, and in Europe, Asia, South Africa, South American, Australia, and the Middle East.

Rod McCrea is an adjunct research fellow with the Institute for Social Science Research at The University of Queensland. His Ph.D. dissertation modeled links between objective characteristics and subjective evaluations of urban quality of life, and it won the 2008 Best Dissertation Prize from the Australian and New Zealand Regional Science Association International. He has also published nine other refereed papers in the field of urban quality of life, including winning the 2007 Best Paper Prize in the journal *Applied Research in Quality of Life*. Rod also has other research interests in quality of life issues more generally including subjective well-being, work-life balance, community social processes, and community wellbeing.

Benjamin L. Messer is a Ph.D. candidate in the Department of Sociology and a research assistant in the Social and Economic Sciences Research Center at Washington State University. During his stay at Washington State, he has written and published papers covering aspects of survey methodology. His dissertation, research examines public attitudes toward energy resources and technologies used for electricity generation and consumption in urban and rural regions of the USA.

Gary T. Moore is an emeritus professor of Environment-Behavior Studies at the University of Sydney, Australia and former dean of the university's Faculty of Architecture. He has been a guest professor at the College of Architecture and Urban Planning, Tongji University, China. Prior to his tenure at the University of Sydney, he was professor of architecture and director of the NASA Wisconsin Space Grant Consortium at the University of Wisconsin-Milwaukee. Dr. Moore was an early pioneer in the environment-behavior field, publishing important books on environmental cognition, designing environments for handicapped children,

emerging environmental design research directions, and a three-volume series, *Advances in Environment, Behavior and Design*. He is a fellow of the American Psychological Association, and currently serves as editor-in-chief of the *Architectural Science Review*.

Abul Mukim Mozammel Haque Mridha is an architect and educator who has spent most of his academic life as a faculty member at Khulna University, Bangladesh. He received his Ph.D. from the Faculty of Architecture, Design and Planning at the University of Sydney in 2010. He has been an active member of Environment, Behaviour and Society (EBS) Research Group and worked as a research associate for *Architectural Science Review (ASR)* while pursuing his doctoral studies. Dr. Mridha is currently a research assistant in the Urban Research Centre at the University of Western Sydney. His research interest and activities focus on architecture and the nexus between built environments and human behavior. He also has a number of publications in his credit.

Gordon F. Mulligan is professor emeritus in the School of Geography and Development at the University of Arizona. He is past editor of the *Journal of Regional Science*, recipient of the Boyce prize for service to regional science, and currently sits on numerous editorial boards in geography, regional science, and urban studies. His extensive research interests include location theory, spatial competition, shopping behavior, regional multiplier analysis, migration, urbanization, crime, and housing.

Derya Oktay is currently a professor of architecture and urban design at the Department of Architecture and director of the Urban Design Programme, Eastern Mediterranean University, North Cyprus, and the director of the Urban Research & Development Center at the same institution. Her teaching and research focus on sustainable urbanism, socio-spatial aspects of housing environments, architectural design in urban context, urban identity, public urban spaces, and quality of urban life. She was a visiting scholar in such universities as University of California – Berkeley, Politecnico di Milano, University of Michigan, and Oxford Brookes University. Dr. Oktay has authored nearly 100 publications including books, book chapters, journal articles, conference papers, and popular press articles. She currently serves on the editorial boards of *Urban Design International*, *Journal of Urban Design & Planning*, and *Asian Journal of Environment-Behaviour Studies*.

Thomas Prinz has served as primary researcher at the Research Studios Austria – iSPACE since 2002. He studied geography and applied geo-informatics at the University of Salzburg completing his Ph.D. in 2007. His doctoral thesis examined spatial indicators as planning criteria for settlement areas in Salzburg. Dr. Prinz is an analytical scientist with expertise in spatial analysis and modeling, cartography, and GIS-aided planning instruments and methods. His on-going research focuses on the use of spatial indicators and indicator systems to support sustainable planning and development.

Ahmet Rustemli retired from Eastern Mediterranean University (Northern Cyprus) in the summer of 2008 where he taught social psychology, research methodology, and social statistics. Prior to moving to Cyprus, Dr Rustemli was affiliated with Middle East Technical University in Ankara, Turkey. One of his co-authored paper received the “*Applied Research in Quality of Life (ARQOLS) – Best Paper Award 2006*” presented by the International Society for Quality of Life Studies (ISQOLS) and Springer Publications, December 2007.

Robert Stimson is the director of the Australian Urban Research Infrastructure Network (AURIN) at The University of Melbourne. He is also emeritus professor in the School of Geography, Planning and Environmental management at the University of Queensland where he was professor of Geographical Sciences and Planning from 1997 to January 2011. He is an analytical human geographer and regional scientist. He is a fellow of the Academy of the Social Sciences in Australia and a fellow of the Regional Science Association International. He is author of 48 books and monographs and more than 300 scientific papers. He was the convener of the Australian Research Council Research Network in Spatially Integrated Social Science from 2004 to 2009.

Fatih Terzi is a research assistant in the department of Urban and Regional Planning at Istanbul Technical University. He received his Ph.D. degree in Urban and Regional Planning (2010) at Istanbul Technical University. He participated in teaching and related academic activities in Department of Landscape Architecture at Clemson University, South Carolina, USA as a visiting research scholar. He also was affiliated with the Centre for Advanced Spatial Analysis (CASA) at University College London, as an Academic Affiliate. His areas of interest include urban spatial development and GIS implementation in urban planning and urban modeling.

John Western passed away in January 2011. He was widely recognized as a leader in the field of sociology in Australia. At the time of his death, Dr. Western was professor emeritus in the School of Sociology at The University of Queensland and had remained active in research throughout his retirement. During his long career at the University of Queensland, he was actively engaged in interdisciplinary research and teaching and served as head of the School of Sociology. Dr. Western was a prolific writer with numerous publications. He was a fellow of the Academy of the Social Sciences in Australia and a member of the Order of Australia.

Mark Western is a sociologist and the director of the Institute for Social Science Research at the University of Queensland. He previously worked at the University of Tasmania and the Australian National University and has held visiting fellowships at the University of Wisconsin-Madison, the University of Manchester and the Institute of Education. He is a member of the editorial boards of *American Sociological Review*, *Journal of Sociology and Research in Social Stratification and Mobility*, and a member of the Board of the International Sociological Association's Research Committee on Social Stratification. He has research interests in social stratification and inequality, the sociology of education, quantitative research methods, and family demography.
