Matthew Carey has conducted fieldwork in the High Atlas mountains of Morocco, exploring topics ranging from local politics and accidental anarchy to mental illness and extra-marital sexuality. He is currently an External Lecturer at the University of Copenhagen and a research associate at the EHESS, Paris.

Morgan Clarke is University Lecturer in Social Anthropology at the University of Oxford and Tutorial Fellow at Keble College. He was previously Simon Research Fellow in the Department of Middle Eastern Studies at the University of Manchester and held a British Academy Postdoctoral Fellow in the Department of Social Anthropology at the University of Cambridge, and holds a doctorate in social anthropology from the University of Oxford. He is the author of *Islam and New Kinship: Reproductive Technology and the Shariah in Lebanon* (Berghahn Books, 2009) and a number of articles on Islam and anthropology.

Simon Coleman is Chancellor Jackman Chaired Professor in the Centre for the Study of Religion at University of Toronto. Among his many publication are: *Locating the Field?: Changing Contexts of Fieldwork and Ethnography* (ed. with P. Collins) 2006, *Reframing Pilgrimage: Cultures in Motion* (ed. with J. Eade), 2004, *Pilgrim Voices: Narrative and Authorship in Christian Pilgrimage* (ed. with J. Elsner), 2003, *The Globalisation of Charismatic Christianity: Spreading the Gospel of Prosperity*, Cambridge: Cambridge University Press, 2007.

Chris Hann taught social anthropology at the Universities of Cambridge and Kent (Canterbury) before moving in 1999 to Halle, Germany, as a Founding Director of the Max Planck Institute for Social Anthropology. In addition to his research in Xinjiang and Turkey, he retains strong interests in the political and economic anthropology of Eastern Europe and (post)socialism in general.

Kai Kresse is Vice-Director for Research at Zentrum Moderner Orient (ZMO) in Berlin. His publications include *Philosophising in Mombasa* (Edinburgh UP 2007), *Struggling with History: Islam and Cosmopolitanism in the Western Indian Ocean*, co-edited with Edward Simpson (Hurst and Columbia UP 2007), and *Knowledge in*

Practice: Expertise and the Transmission of Knowledge in Africa, co-edited with Trevor Marchand (Edinburgh UP).

Magnus Marsden is Senior Lecturer in Social Anthropology at the School of Oriental and African Studies. Edward Simpson has a Ph.D. from the London School of Economics and is currently a Senior Lecturer in Social Anthropology at the School of Oriental and African Studies. He is the author of *Muslim Society and the Western Indian Ocean: The Seafarers of Kachchh* (2006), co-editor of *Struggling with History: Islam and Cosmopolitanism in the Western Indian Ocean* (2007) and *The Idea of Gujarat: History, Ethnography and Text* (2010) and sole editor of *Society and History of Gujarat since 1800: A Select Annotated Bibliography of English and European Language Sources* (2011). His writing has appeared in journals such as *The Annals of the Association of American Geographers*, *Contributions to Indian Sociology*, *Critique of Anthropology* and the *Journal of the Royal Anthropological Institute*. His current research is focused on the consequences of catastrophic natural disasters in South Asia.

Gabriele vom Bruck is senior lecturer in Social Anthropology at the School of Oriental and African Studies, University of London. She has conducted extensive field research in the Republic of Yemen, focusing on elites, gender issues and religious movements. She is the author of *Islam, memory and morality in Yemen: Ruling families in transition* (Palgrave 2005) and co-editor of *The anthropology of names and naming* (Cambridge University Press 2006). She is currently completing a biography of the daughter of the 1948 interregnum-Imam 'Abdullah al-Wazir.
