Wartime exigencies expose the contingency of both masculine and feminine gender roles. In a series of thoughtful essays, the authors unpick the complex intersections between sexuality (both coerced and consensual), war, and politics. They construct carefully historicized arguments, all of which pay attention to the specificities of each conflict, from the Armenian genocide to the conflict in Bosnia. Innovative uses of primary sources (many of which have rarely been used by historians before) contribute to the analytical persuasiveness of the chapters. As with all volumes in the series *Genders and Sexualities in History*, the authors present multifaceted and subtle analyses of the past within narratives that are sophisticated methodologically and theoretically.

Matthias Bjørnlund is a historian and an independent scholar specializing in the Armenian genocide. He has researched, authored, and co-authored articles and papers on the concept of genocide, on aspects of the Rwandan genocide, and on missionary history. He is currently writing a book on Denmark and 'the Armenian Question,' 1900–1940.

Raphaëlle Branche teaches at the University of Paris 1-La Sorbonne. She is the author of *La torture et l'armée pendant la guerre d'Algérie, 1954–1962* (Paris, Gallimard, 2001) and *La guerre d'Algérie: une histoire apaisée?* (Paris, Le Seuil, 2005). She is currently working on French colonial and post-colonial history.

Richard S. Fogarty is Assistant Professor of History at the State University of New York at Albany, and is the author of *Race and War in France: Colonial Subjects in the French Army, 1914–1918* (Baltimore, MD: Johns Hopkins University Press, 2008), as well as several articles on race, colonialism, and war in twentieth-century France.

Lulu Anne Hansen is writing her PhD in Contemporary History at the University of Southern Denmark, Esbjerg. Her dissertation focuses on forms of collaboration, mechanisms of exclusion, and the social dynamics following the German occupation of Denmark 1940–1945. She is the author of *Sex in Crisis: The New Sexual Revolution and the Future of American Politics* (Basic Books, 2008), *Sex after Fascism: Memory and Morality in Twentieth-Century Germany* (Princeton, 2005), and *Intimacy and Exclusion: Religious Politics in Pre-Revolutionary Baden* (Princeton, 1996, Transaction, 2007); the co-editor of *Sexuality in Austria* (Transaction, 2007); and the editor of *Lessons and Legacies VII: The Holocaust in International Perspective* (Northwestern, 2006) and *Sexuality and German Fascism* (Berghahn Books, 2004).

Teresa Iacobelli is a doctoral candidate in the Department of History at The University of Western Ontario in London, Ontario, Canada. Her dissertation explores the application of the death penalty in the Canadian Expeditionary Force during the First World War. She also holds a Master's Degree in History from Wilfrid Laurier University and a B.A. in History and Politics from Trent University in Peterborough, Ontario, Canada.

Marie-Anne Matard-Bonucci is Professor of Contemporary History at the Université de Grenoble II. She is a specialist on fascism, antisemitism, and modern Italian history. Her publications include *Antisémythes* (Nouveau monde ed., 2005) as well as (with P. Milza) *L'homme nouveau dans les régimes fascistes* (Fayard, 2004). *L'Italie fasciste et la persécution des juifs* (Perrin, 2006).

Regina Mühlhäuser is the contact person for the working group 'War and Gender' at the Hamburg Institute for Social Research, Germany. She finished her PhD dissertation, 'Between "Racial Awareness" and Fantasies of Potency: Nazi Sexual Politics and Children of German Men and Local Women in the Occupied Territories of the Soviet Union (1941–1945)' in March 2008 (funded by the Hamburg Foundation for the Benefit of Research and Culture). She has published several articles on sexual violence in times of war, gender and sexuality under National Socialism, and German memory politics.

Na'ama Shik works at the International School for Holocaust Studies in Yad Vashem, Israel. She is a doctoral candidate in history at Tel Aviv University. Her dissertation (under the direction of Shulamit Volkov) is on Jewish women in Auschwitz-Birkenau, 1942–1945, and she has published several articles on this topic.

Robert Sommer is a doctoral candidate at the Humboldt University of Berlin and has finished his PhD dissertation on the history and role of brothels in Nazi concentration camps. In 2006 he published essays on the camp brothels of Auschwitz in the anthology *Nationalsozialistische Lager*, on oral history and SS brothels in *BIOS* (Journal for Biography and Oral History) and on the reactions of the society of Nazi camp prisoners to sexual slavery in *Theresienstädter Studien und Dokumente*. The same year, his master's thesis (completed in 2003) – on the reasons for the establishment of brothels in Nazi concentration camps and the history of the camp brothel of the Sachsenhausen concentration camp – was published on lulu.com/Morrisville (NC).

Emma Vickers is a senior teaching associate at the University of Lancaster, England. Her thesis explores military authority and homosexuality in the British armed forces during the Second World War.
