# Notes on Contributors

**Timothy Chappell** is Senior Lecturer in Philosophy at the University of Dundee. He is the author of *Understanding Human Goods* (1998), *Aristotle and Augustine on Freedom* (1995), and editor of *The Plato Reader* (1996), and *Philosophy of the Environment* (1997). His forthcoming books are *Reading Plato's Theaetetus* and *The Inescapable Self*.

**John Cottingham** is Professor of Philosophy at the University of Reading. He has published seven books as sole author, including *Descartes, The Rationalists*, and *Philosophy and the Good Life*, and has also produced many editions, translations, and edited collections. He is co-editor and translator of the three-volume Cambridge edition of *The Philosophical Writings of Descartes*, and editor of *Ratio*, the international journal of analytic philosophy. He has also published numerous articles on moral philosophy, and on the history of philosophy. His most recent book *On the Meaning of Life* (2002) deals with central themes in the philosophy of religion. He is currently Stanton Lecturer in the Philosophy of Religion at the University of Cambridge, and his *The Spiritual Dimension: Religion, Science, and Human Value* is to be published by Cambridge University Press.

**Gerard J. Hughes** was for many years chairman of the department of philosophy at Heythrop College, University of London, and is now Master of Campion Hall, University of Oxford. He has published articles on a variety of topics in moral philosophy, as well as *The Nature of God* and, most recently, *Aristotle on Ethics*.

**Jacqueline A. Laing** is Senior Lecturer in Law at London Metropolitan University, where she teaches jurisprudence and criminal law. She has also taught moral philosophy at the Universities of Oxford and Melbourne. She is co-editor (with David S. Oderberg) of *Human Lives: Critical Essays on Consequentialist Bioethics* and has published articles in legal and philosophical journals. Her current research interests focus on issues in biotechnology, especially human cloning and artificial reproduction.

**Christopher Martin** is a lecturer at the University of St Thomas, Houston. He has previously taught at the Universities of Glasgow, Navarre, and Oxford. He has written on medieval philosophy, especially

on St Thomas Aquinas, as well as on ethics, particularly Aristotelian ethics, and on related themes (e.g. moral psychology). His most recent book is *Thomas Aquinas: God and Explanations* (1997).

**Mark C. Murphy** is Professor of Philosophy at Georgetown University. His main work is on natural law theory, both in its historical manifestations and as a live option for ethics, politics, and jurisprudence. He is the author of *Natural Law and Practical Rationality* (2001) and *An Essay on Divine Authority* (2002), and is the editor of *Alasdair MacIntyre* (2003). He is currently at work on *Natural Law in Jurisprudence and Politics*.

**David S. Oderberg** is Professor of Philosophy at the University of Reading, England. He is the author of many articles in metaphysics, ethics, philosophical logic and other subjects. Among other books he is the author of *Moral Theory: A Non-Consequentialist Approach* (2000) and *Applied Ethics: A Non-Consequentialist Approach* (2000), as well as co-editor with Jacqueline A. Laing of *Human Lives: Critical Essays on Consequentialist Bioethics* (1997).

**Henry S. Richardson** is Professor of Philosophy at Georgetown University. He is the author of *Practical Reasoning about Final Ends* (1994); *Democratic Autonomy* (2002); 'Desire and the Good in *De Anima*', in *Essays on Aristotle's 'De Anima'*, ed. M. Nussbaum and A.O. Rorty (1992); and 'Thinking about Conflicts of Desires', in *Practical Conflicts: New Philosophical Essays*, ed. P. Baumann and M. Betzler (2004).

**Christopher Tollefsen** is an Associate Professor of Philosophy at the University of South Carolina. He works on issues in meta-ethics and ethical theory, as well as applied, and especially medical ethics. Recent work has appeared in *The Journal of Value Inquiry, Ethical Theory and Moral Practice*, and the *Journal of Medicine and Philosophy*, and volumes such as Ana Iltis (ed.), *Institutional Integrity in Health Care* (2003) and William Alston (ed.), *Realism and Antirealism* (2002). In 2004–2005, he will be a James Madison Fellow at Princeton University.

**Suzanne Uniacke** is Reader in Applied Ethics at the University of Hull, England. She has published widely in ethics, applied ethics, and philosophy of law. Her publications include *Permissible Killing: The Self-Defence Justification of Homicide* (1994), articles in edited collections and journals, and the entry on the 'Principle of Double Effect' in the *Routledge Encyclopedia of Philosophy*. Her current research addresses issues

of responsibility and moral obligation, and rights as permissions and constraints.

**Helen Watt** is Director of the Linacre Centre for Healthcare Ethics, London. She is the author of *Life and Death in Healthcare Ethics: A Short Introduction* (2000), and of various articles on bioethical issues, including reproductive ethics and end-of-life decisions.
