**Gunter Axt** has a doctorate in Social History from the University of São Paulo and is currently working on his *pós-doutorado*. Until 2006, he was a researcher at the Memorial do Ministério Público in Rio Grande do Sul, and he now presides over the Instituto Hominus de Desenvolvimento Sócio-Cultural. Axt is the author of *De homem só a guardião da cidadania: história associativa e institucional do MPRS* (Procuradoria-Geral de Justiça do Rio Grande do Sul/Memorial, 2003) and of 21 other books.

**John J. Crocitti** is Associate Professor of History at San Diego Mesa College, San Diego, CA. In 1999, he coedited *The Brazil Reader* (Duke Univ. Press) with Robert M. Levine. His current projects include a twentieth-century social history of a secondary Brazilian city and a history of popular culture among Brazilian railroad workers.

**Jerry Dávila** is Associate Professor of History at the University of North Carolina at Charlotte. He is the author of *Diploma of Whiteness: Race and Social Policy in Brazil, 1917–1945* (Duke University Press, 2003) and has research interests in the relationship between racial thought and public policy and in the formation of historical memory. He has been Fulbright Distinguished Chair in American Studies at the Pontifícia Universidade Católica in Rio de Janeiro (2005) and visiting Fulbright scholar at the Universidade de São Paulo (2000).

**Oliver Dinius** is Croft Assistant Professor of History and International Studies at the University of Mississippi. He received his Ph.D in Latin American history from Harvard University in 2004. His research focuses on the history of labor, industry, and economic development in Brazil, where he did extensive field work for his dissertation on the history of the country's foremost state enterprise, the Companhia Siderúrgica Nacional.

**Jens R. Hentschke** obtained his *Habilitation (Livre-Docência)* at Heidelberg University and is Professor of Latin American History and Politics at Newcastle University, U.K. He is the author of *Estado Novo* (Verlag für Entwicklungspolitik Saarbrücken, 1996), *Populismus* (CeLA Münster, 1998), *Positivism gaucho-Style* (Verlag für Wissenschaft und Forschung, 2004), and numerous articles and chapters on nineteenth and twentieth century Brazil. Currently, he is completing a research monograph on Vargas's educational reforms and their implementation in the states of Rio de Janeiro and Rio Grande do Sul.

**Frank D. McCann** is Professor of History at the University of New Hampshire. His publications include: *The Brazilian-American Alliance, 1937–45* (Princeton Univ. Press, 1973); *A Nação Armada: Ensaios sobre a História do Exército Brasileiro* (Ed. Guararapes, 1982); and *Soldiers of the Pátria: A History of the Brazilian Army 1889–1937* (Stanford Univ. Press, 2004). In 1986, the Brazilian government gave him the rank of “Comendador” in the Order of Rio Branco.

**Thomas D. Rogers** is Assistant Professor of Africana Studies at the University of North Carolina at Charlotte. He completed his Ph.D in Latin American History at Duke University in 2005, writing a dissertation that combines elements of environmental and labor history to offer a new interpretation of the historic 1963 and 1979 strikes in the sugar region of Pernambuco. A Fulbright Fellowship funded a year of archival research and extensive oral history interviewing in Pernambuco. Tom Rogers also studies labor and politics in the Caribbean and has published an article on the early career of Jamaican labor leader Alexander Bustamante.

**Lisa Shaw** is Reader in Brazilian Studies at the University of Liverpool, U.K. She is the author of *The Social History of the Brazilian Samba* (Ashgate, 1999), and coauthor of *Popular Cinema in Brazil* (Manchester UP, 2004) and *Brazilian National Cinema* (Routledge, 2006). In the autumn term of the 1999–2000 academic year, she was Visiting Lecturer in Brazilian Civilization and Popular Culture at the University of California, Los Angeles.

**Daryle Williams**, Associate Professor at the University of Maryland, College Park, is author of *Culture Wars in Brazil: The First Vargas Regime, 1930–1945* (Duke University Press, 2001), 2001 winner of the American Historical Association's John Edwin Fagg prize. He has also authored several articles and book chapters on twentieth-century Brazilian cultural history. Recent research has examined the cultural politics of World Heritage in Argentina, Brazil, and Paraguay;

humanities computing; and blackness in nineteenth-century Brazilian fine arts. Daryle Williams is Associate Editor of the *Hispanic American Historical Review*.

**James P. Woodard** (Ph.D., A.M., Brown University, B.A. University of North Carolina) has written widely on twentieth-century Brazilian history, including articles published in the *Hispanic American Historical Review*, the *Journal of Latin American Studies*, the *Luso-Brazilian Review*, *Estudios Interdisciplinarios de América Latina y el Caribe*, and the University of São Paulo's *Revista de História*.
