Past projects tested diabetes, cervical cancer, breast, nutrition and smoking cessation interventions among tribes in the Northern Plains, Minnesota, and California regions. Dr. Hodge is a member of the

National Institute of Nursing Research National Advisory Council, UCLA Graduate Council, is the director of the Center for American Indian/Indigenous Research and Education, and is Chair of the UCLA American Indian Studies Interdepartmental Program.

Jeremiah Hurley

Jeremiah Hurley is a Professor in the Departments of Economics and Clinical Epidemiology and Biostatistics, and Associate Director of the Centre for Health Economics and Policy Analysis at McMaster University, Hamilton, Canada. Dr. Tom-Orme holds graduate degrees in transcultural nursing and public health from the Nursing, University of Utah. Dr. Tom-Orme has been active in several local and national committees related to the health of American Indians. Consistent with her beliefs in increasing the number of ethnic students involved in research, she serves as mentor to many students throughout the country. Dr. Tom-Orme chaired the Cultural Diversity Committee for the University of Utah College of Nursing. She is a consultant and author in transcultural nursing and health. She also is active in the work of the local Indian Walk-in Center serving as consultant in its Special Diabetes Program for urban-based American Indians. Her current research includes patterns of cancer care and a national public health study of chronic conditions among a cohort of American Indian/Alaska Natives.

Marcia Faria Westphal

Marcia Faria Westphal was Vice- President for Latin America of the International Union for Health Promotion and Education from 1998 to 2007. She was also vice Dean of the School of Public Health of the University of Sao Paulo, from 1998 to 2001.
