Notes on Contributors

Patrick Alexander is College Lecturer in Social Anthropology at St Hugh's College, Oxford, and a Research Fellow in the School of Education at Oxford Brookes University. Patrick received his doctorate in 2010 from the Department of Education at the University of Oxford, where his research focused on the negotiation of age as an aspect of social identity for teachers and students in an English secondary school. Since then he has been involved in research exploring young people's perspectives of university, and is currently involved in research looking at how experiences of university frame contemporary transitions into adulthood.

Sara Bragg is Senior Research Fellow in the Education Research Centre at the University of Brighton, UK. Her doctoral research focused on 'violent' media genres, youth audiences and media education in the United Kingdom; she has also researched debates about the 'sexualization' of childhood; youth 'voice' and participation in schools; school ethos and 'creative' research methods. She is the co-author of *Young People, Sex and the Media* (with David Buckingham, 2004); co-editor of *Children and Young People's Cultural Worlds* (with Mary Jane Kehily, 2013) and has published in journals including *Feminist Media Studies*, *Gender and Education*, *Children and Society*, and edited collections including *Researching Creative Learning: Methods and Issues* (2011) and *The Routledge Companion to Media and Gender* (2013).

David Buckingham is Professor of Communications and Media Studies at Loughborough University, UK, and a Visiting Professor at the Norwegian Centre for Child Research, NTNU Trondheim. His research focuses on children's and young people's interactions with electronic media, and on media education. David is the author, co-author or editor of numerous books, including most recently *Beyond Technology: Children's Learning in the Age of Digital Culture* (2007), *Youth, Identity and Digital Media* (2008), *Video Cultures: Media Technology and Amateur Creativity* (2009) and *The Material Child: Growing Up in Consumer Culture* (2011).

Elisabeth El Rafaie is Senior Lecturer in The Centre for Language and Communication Research at Cardiff University. Her main research

interests are in visual and multimodal communication, with a particular focus on newspaper cartoons, autobiographical comics (or 'graphic memoirs'), and the use of visual storytelling in health campaigns. Much of her work has explored the differences between verbal and visual/multimodal forms of metaphor, irony and humour. Her publications include 'Heterosemiosis: Mixing sign systems in graphic narrative texts' (*Semiotica*, 2012) and *Autobiographical Comics: Life Writing in Pictures*.

Carles Feixa is Professor of Social Anthropology at the University of Lleida (Catalonia, Spain). Former VP for Europe of ISA RC34 (Sociology of Youth), he is author of several books: *De Jovenes bandas y tribus* (1998), *Jovens na America Latina* (with S. Caccia-Bava and Y. Rosalind Gill is Professor of Social and Cultural Analysis at King's College London. She is interested in questions of power, inequality and social justice as they relate to culture, subjectivity, technology, representation and labour. She is the author of *Gender and the Media* (2007), and the co-editor of *Secrecy and Silence in the Research Process* (with Roisin Ryan-Flood, 2010); *New Femininities* (with Christina Scharff, 2011) and *Theorising Cultural Work* (with Mark Banks and Stephanie Taylor, 2013).

Christine Griffin is Professor of Social Psychology at the University of Bath. She has been involved in a wide variety of research projects on aspects of young people's lives, often working in multi-disciplinary teams. Much of her recent work explores the relationship between identities and consumption for young people, with a long-standing interest in gender relations and young women's negotiation of contemporary femininity. Her publications include *Standpoints and Differences: Essays in Practice of Feminist Psychology* (with Karen Henwood and Ann Phoenix, 1998), *Typical Girls? Young Women from School to the Job Market* (1985) and *Representations of Youth* (1993).

Rupa Huq is Senior Lecturer in Sociology at Kingston University, UK. She has also taught on Media and Cultural Studies courses at Kingston University. Research interests largely cluster around youth culture and pop music, which were the subject of her first book *Beyond Subculture* (2006), which was shortlisted for the Philip Abrams Memorial Prize of the British Sociological Association; and around cultures of suburbia, the subject of two further books: *On the Edge: The Contested Cultures of English Suburbia* (2013) and *Making Sense of Suburbia Through Popular Culture* (2013).

Kathrin Hörschelmann is Senior Lecturer in Human Geography at the University of Durham and currently a Visiting Research Fellow at the Leibniz Institute for Regional Studies in Leipzig, Germany. Her research interests include the political geographies of youth; visual and media culture; globalization, youth culture and social inequalities; feminist theory and the cultural politics of post-socialist transformation. She is the co-author of *Children, Youth and the City* (2011), co-editor of *Contested Bodies of Childhood and Youth* (2010) and *Spaces of Masculinities* (2004) and author of several articles in international journals such as *Transactions of the Institute of British Geographers*, *Antipode*, *Political Geography*, *Social and Cultural Geography*, and *Environment and Planning A*.

Mary Celeste Kearney is Associate Professor of Film, Television, and Theatre at the University of Notre Dame, Indiana. She earned her PhD from the University of Southern California's School of Cinematic Arts, and has taught in the Department of Radio–Television–Film at the University of Texas at Austin the past 14 years. Mary's research to date has focused primarily on gender, youth and media culture. She is the author of *Girls Make Media* (2006) and the editor of *Mediated Girlhoods: New Explorations of Girls' Media Culture* (2011) and *The Gender and Media Reader* (2011). She is Founding Director of Cinemakids, a programme for inspiring young media producers.

Mary Jane Kehily is Professor of Childhood and Youth Studies at the Open University, UK. She has a background in cultural studies and education and research interests in gender and sexuality, narrative and identity and popular culture. Recent work explores changing conceptualizations of Western childhood and new motherhood as a site of identity change. Books include *Gender, Sexuality and Schooling: Shifting Agendas in Social Learning* (2002), *An Introduction to Childhood Studies* (2009), *Understanding Youth: Perspectives, Identities and Practices* (2007), *Gender, Youth and Culture: Young Masculinities and Femininities* (with Anoop Nayak, 2008), *Making Modern Mothers* (co-authored with Rachel Thomson, Lucy Hadfield and Sue Sharpe, 2011) and *Understanding Childhood* (2013).

Ofra Koffman has recently completed a Leverhulme Postdoctoral Fellowship at the Department for Culture, Media and Creative Industries, King's College London, and is currently on maternity leave. Her post-doctoral research examined the recent focus on adolescent girls within development policy, particularly the work of DFID, the Nike Foundation

and the World Bank. She has previously researched 'adolescence', 'girlhood' and 'teenage pregnancy' policy in Britain.

Ritty A. Lukose is Associate Professor at The Gallatin School of New York University. Her research and writing focus on the cultural and political dimensions of globalization within India. She is currently focused on the transformations of feminist political imaginaries within this context. She is the author of *Liberalization's Children: Gender, Youth and Consumer Citizenship in Globalizing India* (2009/2010) and the co-editor of *South Asian Feminisms* (with Ania Loomba, 2012).

Sunaina Maira is Professor of Asian American Studies at the University of California, Davis. She is the author of *Desis in the House: Indian American Youth Culture in New York City* (2002). She co-edited *Youthscapes: The Popular, the National, the Global and Contours of the Heart: South Asians Map North America*, which won the American Book Award in 1997. Her most recent book is *Missing: Youth, Citizenship, and Empire after 9/11* (2009).

Angela McFarlane is Director of Public Engagement and Learning at Kew Gardens and Visiting Professor at Kings College London. Until 2008, she was Professor of Education at Bristol University. She is responsible for the public programme at Kew, including the visitor experience of the gardens, visitor services, marketing, PR, publishing, digital media and education.

Anoop Nayak is Professor of Social and Cultural Geography at Newcastle University. His research interests are in race and ethnicity, youth cultural identities, class cultures, and masculinities and social change. of *Self-abasement* (2009–2013) and the EC-funded FP7 ‘MYPLACE’ project on youth and civic engagement (2011–15).

Oriol Romaní is Professor of Social Anthropology at the University Rovira i Virgili of Tarragona and President of the interdisciplinary association on Drugs and Health Group, Igia. He specializes in medical and urban anthropology, biographical methodology, use of drugs, youth and marginalization. He has published widely on these themes.

Elisabeth Soep is Senior Producer and Research Director at Youth Radio, the Oakland, California-based youth-driven production company that serves as National Public Radio’s official youth desk. With a PhD from Stanford, Lissa has written about digital media and learning for academic journals (*Harvard Educational Review*, *National Civic Review*, *Comunicar*); popular outlets (Boing Boing, NPR, Edutopia) and books including *Drop that Knowledge* (with V. Chávez, 2010) and *Youthscapes* (with S. Maira, 2004). In 2011, Lissa became one of the six members of the MacArthur Foundation’s Youth and Participatory Politics Research Network, which explores how young people use digital and social media to express voice and exert influence in public spheres.

Helen Thornham is Research Fellow in the Institute of Communication Studies, University of Leeds. She is the author of *Ethnographies of the Videogame* (2011) and the co-editor of *Renewing Feminisms* (with Elke Weissmann, 2013) and *Content Cultures* (with Simon Pople, 2013). She currently leads an RCUK Digital Economy Network+ investigating the digital transformations of communities and culture, and is interested in issues of gender, technology, youth, mediations and identity.

Kyong Yoon is Assistant Professor in Cultural Studies at the University of British Columbia’s Okanagan Campus where he teaches new media culture. He has recently researched new media audiences, mediated tourism and reputation on the Internet.
