Contributors

Len Arthur worked for over 30 years teaching trade union studies and industrial relations. For the last 10 years of his career he was Director of Cardiff Institute for Cooperative Studies. Academically, he is still involved in exploring cooperatives as social movements, how they can reconnect with the labour movement and in developing concepts that may help this process, such as 'deviant mainstreaming' and 'transitional demands and actions'.

Maurizio Atzeni is Lecturer in Labour and Industrial Relations at Loughborough University School of Business and Economics, UK. He is also a Research Fellow at CEIL/CONICET, Buenos Aires. His general research interests include the investigation of the role of labour and workers in societies. He has researched and published extensively in books and academic journals on workplace conflict and workers' collective action, on Argentinian trade unionism and workers' self-management.

Joseba Azkarraga Etxagibel is a cooperative member and Professor of Contemporary Social Change and Social Economics at Mondragon University. He is the founder of LANKI (Institute of Cooperative Research at Mondragon University) and a researcher there. He was Head of the Department of Social Science at Mondragon University and a member of the Board of Directors. Professor Azkarraga has published several essays and articles on his main areas of research: the Mondragon cooperative experience and social economics, Western development models and the transition to sustainability, and contemporary Basque society.

George Cheney is Professor of Communication Studies at Kent State University. Previously he held faculty positions at the universities of Illinois, Colorado, Montana, Utah and Texas. He has held administrative positions or roles in communication departments, a campus quality-of-worklife programme, an interdisciplinary peace and conflict studies

programme, a human rights centre and a service learning institute. He has taught, lectured, conducted research and consulted in Europe and Latin America, in addition to holding a position as adjunct professor at the University of Waikato in Hamilton, New Zealand, since 1998. Professor Cheney has published eight books and more than 90 articles, chapters and reviews. His award-winning book on the Mondragon cooperatives is *Values at Work* (Cornell University Press, 1999, 2002). He is the North American book review editor for the journal *Organization* and is a faculty associate of the Ohio Employee Ownership Center at Kent State University.

Martino Ghielmi has an MA in African studies from the University of Pavia, Italy. He spent a year in Nairobi taking part in the evaluation of a non-governmental organization support programme for informal workers and currently works in management consulting. His research interests include informal labour, social entrepreneurship and innovation in East Africa.

Anita Hammer is Senior Lecturer in Comparative and International Human Resource Management at Leicester Business School, De Montfort University, UK. Her research interests include globalization and its impact on economic development and social change; multinational corporations and international human resource management; industrial relations and social movements; and the political economy of India. She has worked in the industry for several years and teaches on a range of undergraduate and postgraduate management programmes.

Tom Keenoy is Emeritus Professor at the University of Leicester and Honorary Professor at Cardiff Business School, UK. He has published widely and has a continuing research interest in organizational discourse analysis, the social construction of human resource management, time and organization, the co-construction of management in cooperative organizations and the changing temper of sensemaking in academic work.

Camila Piñeiro Harnecker is a researcher and professor at the Center for the Study of the Cuban Economy, University of Havana, where she focuses on self-management and democratic coordination. She is editor and author of *Cooperatives and Socialism: A Cuban Perspective* (Ed. Caminos, Havana, 2011).

Molly Scott Cato works as a green economist, seeking to develop a sustainable and just economy. She is Professor of Strategy and Sustainability at Roehampton University, UK, and a former Director of the Cardiff Institute for Cooperative Studies.

Russell Smith is an economist and the Acting Director of Cardiff Institute for Cooperative Studies (CICS), UK. With other colleagues in Cardiff Metropolitan University's Management School, he helped to establish CICS in 2000. He is involved in exploring cooperatives as social movements, human firms and demonstrable radical alternatives to conventional businesses through the concept of 'deviant mainstreaming'.

Alan Tuckman currently teaches at Nottingham Trent University, UK. He has researched and published widely on employment relations and the sociology of work, most recently on migrant labour, employee voice and workplace conflict.

Ainara Udaondo Alberdi is the Head of LANKI (Institute of Cooperative Research at Mondragon University) and of the Department of Cooperative Training and Development there. She is a member of the Board of Directors of the School of Humanities and Education and has been the Head and a faculty member of the graduate programme of Cooperative Development. She has contributed to the development of educational and audiovisual materials on the Mondragon cooperative experience. In addition, she offers advice and training on cooperative enterprise to the cooperatives of Grupo Mondragon.

Marcelo Vieta holds a PhD in social and political thought (York University) and is a postdoctoral research fellow at the European Research Institute on Cooperative and Social Enterprises (EURICSE) in Trento, Italy. He is also a research associate at York University's Center for Research on Latin America and the Caribbean (CERLAC) and sits on the board of the Canadian Association for Studies in Co-operation (CASC). In recent years, Marcelo has been researching and publishing on the historical conditions, the political economic environments, and the lived experiences of the worker-recuperated enterprises of Argentina, as well as on the social and solidarity economies of Latin America. More

broadly, he is interested in the prefigurative possibilities for alternative economic arrangements, as well as the socio-technological spheres within which alternatives to capitalism emerge. He has lectured and taught broadly on topics such as the social economy, critical theory and communication. Since 2005, he has been actively involved in helping develop researcher and practitioner linkages between cooperative experiences in Canada and Latin America.
