About the Authors

Brian P. An is an Associate Professor of Educational Policy and Leadership Studies at the University of Iowa. He received his M.S. and Ph.D. in Sociology from the University of Wisconsin–Madison. His research focuses on the sociology of education, educational stratification, and college-student success. He is currently working on cross-national comparative studies regarding stability and change in social inequalities over the life course. His work has appeared in academic journals such as *Educational Evaluation and Policy Analysis*, *Social Science Research*, *Journal of Higher Education*, *Research in Higher Education*, *Review of Higher Education*, *Higher Education*, and *Journal of College Student Development*.

Lorenzo DuBois Baber Ph.D., is an Associate Professor of Higher Education and Head in the Division of Higher Education at Iowa State University. He also serves as the Director of the Community College Leadership Institute (CCLI) at Iowa State University. Dr. Baber's research interests include educational equity and justice with specific focus on community colleges, postsecondary education in Science, Technology, Engineering, and Mathematics (STEM), and advancement of critical frameworks in higher education research. His research has appeared in various outlets, including all the major journals dedicated to community college research and practice.

Thomas R. Bailey is the President of Teachers College, Columbia University. He is also the George and Abby O'Neill Professor of Economics and Education. As the Director of the Community College Research Center (CCRC) at Teachers College and the Center for the Analysis of Postsecondary Readiness (CAPR), funded by the Institute for Education Sciences, Professor Bailey is a leading expert on America's community colleges. Along with Shanna Smith Jaggars and Davis Jenkins, Dr. Bailey wrote *Redesigning America's Community Colleges: A Clearer Path to Student Success*, published in 2015 by Harvard University Press. Professor Bailey holds a Ph.D. from MIT with specialties in education, labor economics, and econometrics. He is an AERA Fellow and member of the National Academy of Education.

Clive R. Belfield is a Professor of Economics at Queens College, City University of New York. He is also a Researcher at the Community College Research Center, Teachers College, Columbia University, and Principal Economist at the Center for Benefit-Cost Studies of Education. Professor Belfield's area of expertise is the economics of education, including benefit-cost and cost-effectiveness analysis. He has published widely in the economics of education, including four books. His most recent book is *Economic Evaluation of Education* (Russell Sage, 2017).

Gerardo Luu Blanco is an Assistant Professor of Higher Education & Student Affairs in the Department of Educational Leadership at the University of Connecticut, United States. His research focuses on how colleges and universities build, develop, and communicate quality to multiple constituents, and on the role that internationalization and competition play in these processes. His research is theoretically grounded in postcoloniality and postmodernity, and methodologically oriented toward visual methods and comparative education.

Kathryn L. Boucher is an Assistant Professor of Psychology at the University of Indianapolis. In her research, she explores stereotypes: how they can hurt us, how we respond to them, and how they can be changed or their effects lessened. She examines how stereotype and social identity threat negatively impact students from underserved, underrepresented, and/or negatively stereotyped groups. In her intervention work with the College Transition Collaborative, she develops, tests, and disseminates insights from social psychological interventions for student success. Kathryn received her B.A. from the University of Kentucky and her Ph.D. from Indiana University.

Deborah Faye Carter is an Associate Professor of Higher Education in the School of Educational Studies at Claremont Graduate University. Her scholarship examines the impact of college on students, especially students of color and low-income students, and focuses on degree aspirations, transition to college, and the effects of undergraduate research on STEM major choices and graduate school attendance.

Evelyn R. Carter is the Director of Translational Research & Anti-Bias Training in the UCLA Office of Equity, Diversity and Inclusion. Her research examines the factors that shape how people detect racial bias, and her work on identifying successful racial bias confrontation strategies has been funded by the National Science Foundation. Evelyn is passionate about translating social psychological research into evidence-based practices, with an emphasis on increasing awareness about interpersonal and structural discrimination as a way to create truly inclusive environments. Evelyn earned her B.A. from Northwestern University, her M.A. from the University of Illinois at Chicago, and her Ph.D. from Indiana University.

Christopher J. Devers is an Assistant Professor of Education at Johns Hopkins University. He is also the Director of the Lumen Research Institute. Broadly, Professor Devers's research focuses on learning and technology and includes four lines of research: online education, video learning, student success, and the Scholarship of Teaching and Learning.

Erin Drummy is a junior in the Honors Guild at Taylor University earning her B.A. in political science, philosophy, and economics (PPE). Manuel S. González Canché relies on econometric, quasi-experimental, geospatial, and network analysis methods to better understand structural factors that influence minority and at-risk students' likelihood of success. His cosmivision is based upon the assertion that talent is universally distributed and is therefore not mostly concentrated among those who have the most. Accordingly, he aims to identify plans of action capable of closing socioeconomic gaps resulting from students' reduced access to financial, academic, and social resources. His research is driven by the desire to offer better and more nuanced understandings of the effect of location, influence, and competition on access, persistence, and success in higher education. Similarly, he aims to provide analytic and methodological frameworks that may translate into more robust qualitative and quantitative education research findings, conclusions, and implications.

Rodney P. Hughes is an Assistant Professor of Higher Education Administration at West Virginia University and senior scientist in the Center for the Future of Land-Grant Education. Prior to joining the faculty at West Virginia University, Dr. Hughes served as a research manager in the Center for Education Policy Research at Harvard University and a graduate research assistant in the Center for the Study of Higher Education at the Pennsylvania State University. Dr. Hughes' research focuses on students' college-going decisions, financial aid, tuition pricing, early labor market outcomes for recent college graduates, college and university governance, and higher education scandals.

Ezekiel W. Kimball is an Assistant Professor of Higher Education and the Associate Director of the Center for Student Success Research at the University of Massachusetts Amherst. An expert on the postsecondary educational trajectories of students with disabilities, his publications have appeared in the *Journal of College Student Development*, *Review of Higher Education*, *Journal of Diversity in Higher Education*, and *Higher Education: Handbook of Theory and Research*. In recognition of his scholarly achievements, Dr. Kimball has been named an ACPA Emerging Scholar by ACPA: College Educators International, a Family Research Scholar by the Center for Research on Families, and a Public Engagement Fellow by the University of Massachusetts Amherst.
