Alexandra Effe is a postdoctoral fellow at the Department of Literature, Area Studies and European Languages, University of Oslo. Her research focuses on narrative theory, life writing, autofiction, and cognitive literary studies. As visiting scholar at the Oxford Centre for Life-Writing, she co-runs the project “Autofiction in Global Perspective.” She is the author of *J. M. Coetzee and the Ethics of Narrative Transgression: A Reconsideration of Metalepsis* (Palgrave, 2017).

Helle Egendal is Lecturer in Danish at the University of Freiburg, Germany. Her research focuses on multiculturalism and multilingualism in Scandinavian literature.
