## Contributors

**Dr. Christina E. Bejarano** is an associate professor of political science at the University of Kansas. Her research and teaching interests are in American politics, particularly in the areas of gender, race/ethnicity, and political behavior. She focuses on Latino political candidates and voters in US electoral politics. Carroll also has published numerous journal articles and book chapters focusing on women candidates, voters, elected officials, and political appointees in the USA.



**Dr. Cecilia Conrad** is emeritus professor at Pomona College where she was the Stedman-Sumner Professor of Economics. She served two terms on the American Economic Association's Committee on the Status of Women in Economics Profession and is a past President of the International Association of Feminist Economics. Her scholarship focuses on effects of race and gender on economic status and economic thought. She is a past editor of the journal *The Review of Black Political Economy* and past associate editor of the journal *Feminist Economics* and co-editor of the *Aids, Gender, Sexuality and Development* (2011), *African Americans in the US Economy* (2005), and *Building Skills for Black Workers* (2004).

**Dr. Lisa Corrigan** is an associate professor of communication and the Director of the Gender Studies Program at the University of Arkansas, where she is also a faculty affiliate of the African and African-American Studies Program and the Latin American Studies Program. She is a feminist rhetorical scholar who researches and teaches in the areas of social movement studies, the Black Power and civil rights movement, prison studies, political communication, and the history of the Cold War. Her new book, *Prison Power: How Prison Influenced the Movement for Black Liberation* (2016), examines the role of prison in shaping the Civil Rights and Black Power movements.

**Dr. Sara M. Evans** is Regents Professor Emerita at the University of Minnesota where she chaired the history department and served as director of the Center for Advanced Feminist Studies. In addition to serving on the editorial board for *Feminist Studies*, Evans is the author of seven books, including *Personal Politics: The Roots of Women's Liberation in the Civil Rights Movement and the New Left* (1980); *Born for Liberty: A History of Women in America* (1997); *Tidal Wave: How Women Changed America at Century's End* (2004), and she edited *Journeys that Opened Up the World: Women, Student Christian Movements, and Social Justice, 1955–1970* (2003).

**Dr. Laura Foxworth** is a visiting assistant professor in the Women's Leadership Program at Clemson University. She received her PhD from the University of South Carolina where she studied the women's movement, the American South, and changing religious institutions in the USA. Her dissertation, "The Spiritual is Political: The Modern Women's Movement and the Transformation of the Southern Baptist Convention," was supported by the Sallie Bingham Center for Women's

History and Culture at Duke University, the Gerald R. Ford Presidential Library, and the Southern Baptist Historical Library and Archives in Nashville, Tennessee. Dr. Foxworth has presented research at meetings for the Organization for American Historians, Southern Historical Association, Southern Association for Women Historians, and National Council on Public Historians. She currently serves as Managing Editor of *French Historical Studies*.

**Dr. Valerie Martinez-Ebers** is a University Distinguished Research professor of political science at the University of North Texas and former editor of the *American Political Science Review*, the flagship journal of the discipline. Dr. Martinez-Ebers has published widely on education policy, Latino/a politics, women in politics, and methods of survey research in outlets such as *American Political Science Review*, *American Journal of Political Science*, *Journal of Politics* and *Political Research Quarterly*. She is co-author of *Politicas: Latina Public Officials in Texas* (2008), *Latino Lives in America: Making It Home* (2010), and *Latinos in the New Millennium: An Almanac of Opinion, Behavior and Policy Preferences* (2012). She also edited *Perspectives on Race, Ethnicity and Religion: Identity Politics in America* (2009) and is one of the principal investigators for the Latino National Survey, an 8,600-respondent survey funded by the Ford, Carnegie, Russell Sage, Hewlett, Joyce, and National Science Foundations.

**Dr. Claire Bond Potter** is professor of history and Director of the Digital Humanities Initiative at The New School. She also serves as co-director of OutHistory.org, an LGBT digital history project, as a Distinguished Lecturer for the Organization of American Historians, and as a member of the Schlesinger Library Council at the Radcliffe Institute, Harvard University. From 2006 to 2015, she blogged at *Tenured Radical*, carried by the *Chronicle of Higher Education*.
