The series *Bernard Shaw and His Contemporaries* presents the best and most up-to-date research on Shaw and his contemporaries in a diverse range of cultural contexts. No one engaged with his contemporaries more than Shaw, whether as controversialist, or in his support of other, often younger writers. In many respects, therefore, the series as it develops will offer a survey of the rise of the modern at the beginning of the twentieth century and the subsequent varied cultural movements covered by the term modernism that arose in the wake of World War I.
