## NOTES ON CONTRIBUTORS

**Anca Bejenaru** is Associate Professor in Social Work at the Lucian Blaga University of Sibiu. Her education includes a BA in Psychology and an MA in Sociology. In 2010, she received her Ph.D. in Sociology with a thesis focusing on Romanian child adoption granted by Babeş-Bolyai University of Cluj-Napoca. Her research interests include childhood and migration, children in out-of-home care, child adoption, violence against children, young people, and women. Her publications include two books, several scholarly articles, research reports, and several chapters in books.

**Claudio Bolzman** holds a Ph.D. in Social and Economic Sciences from the University of Geneva. He is professor at the Geneva School of Social Work, University of Applied Sciences and Arts Western Switzerland (HES-SO), and Senior Lecturer at the Department of Sociology, University of Geneva. His main research interests are migration, life course, transnational practices, immigration policies, and social policies. He has carried out many research projects on these topics and is the author of more than 100 sociological publications.

**Alin Croitoru** is a lecturer at the Department of Sociology, the Lucian Blaga University of Sibiu, and a researcher at the Center for Migration Studies—CeSMig (University of Bucharest).
