## NOTES ON CONTRIBUTORS

**Michelle L. Beer** is an independent scholar and part-time lecturer living and working in the San Francisco Bay area. She earned her Ph.D. in history from the University of Illinois at Urbana-Champaign, and she is currently working on her first monograph, *Queenship at the Renaissance Courts of Britain: Catherine of Aragon and Margaret Tudor, 1503–1533*, which will be published as part of the Royal Historical Society’s *Studies in History* series. Her work focuses on the creation of queenly identity, authority and power and the thematic connections between queenship at the English and Scottish royal courts during the early sixteenth century.

**Susan Broomhall** is Professor of History at The University of Western Australia, where she specialises in the history of women, gender and emotions in early modern France. She has published most recently (with Jacqueline Van Gent) *Dynastic Colonialism: Gender, Materiality and the early modern House of Orange-Nassau* (Routledge, 2016) and *Gender, Power and Identity in the Early Modern House of Orange-Nassau* (Ashgate, 2016). She currently holds an Australian Research Council award through which she is researching emotions in the letters of Catherine de’ Medici, with an edited collection, *Women and Power at the French Court, 1483–1563*, forthcoming from Amsterdam University Press. She is undertaking, with Carolyn James and Lisa Mansfield, an Australian Research Council project, “Gendering the Italian Wars.”

**Hannah Coates** is a historian of early modern political culture, with a particular interest in rhetoric and political argument and in the relationships between the constituent parts of early modern Britain and Ireland. She has



recently completed her PhD, ‘Sir Francis Walsingham and Mid-Elizabethan Political Culture’, at the University of Leeds.

**Catherine Fletcher** is Associate Professor in History and Heritage at Swansea University. She is the author of two books on early modern diplomacy: *Our Man in Rome: Henry VIII and his Italian Ambassador* (Bodley Head, 2012) and *Diplomacy in Renaissance Rome: The Rise of the Resident Ambassador* (Cambridge University Press, 2015). Her current research concerns politics and material culture in the period of the Italian Wars, 1494–1559. She has written a biography of Alessandro de’ Medici, *The Black Prince of Florence* (Bodley Head, 2016) and is now working on the early history of the handgun.

**Alexandra Nancy Johnson** is a doctoral candidate at the University of Edinburgh. She is working on the court and household of Mary Queen of Scots and her current research focuses on the politics of access at Holyrood Palace during the sixteenth century. Her other publications include “Mary Stuart’s inner chamber at Holyrood, as an embodiment of power”, in Krista de Jonge et al. (eds.), *The Interior as an Embodiment of Power: The Image of the Prince and its Spatial Setting, 1400–1700* (PALATIUM, forthcoming) and “Mary Stuart’s Holyrood state apartments: performance of ceremonial ritual”, *Rituals of Power: The Ceremonies for Courts and States from the Late Medieval Period to the Modern Era* (Warsaw, forthcoming).

**Katarzyna Kosior** is a historian of early modern Europe, particularly France and Poland-Lithuania, specialising in the culture and politics of royal courts, ceremony, diplomacy and gender. She is currently an honorary fellow at Durham University and working on her book, the first work to compare the Polish and French ceremonies accompanying royal weddings, coronations and childbirth, for Palgrave’s ‘Queenship and Power’ series.

**Helen Matheson-Pollock** is an Honorary Research Associate at University College London. She has published on the rise of the female courtier in mid-Tudor England, Elizabethan female courtiers as diplomatic agents (Brill, 2014) and the question of whether women had a Renaissance (*Journal of Early Modern Women*, 2013). She is currently working on a monograph arguing for Elisabeth Parr, marchioness of Northampton, as the idealised female courtier.

**Susanna Niiranen** is a Senior Researcher at the Department of History and Ethnology, University of Jyväskylä, Finland. Her publications concern various aspects of medieval and early modern literature, medicine, gender, vernacularisation and transmission of knowledge. In 2015–16 she worked for the ERC-project “The Jagiellonians. **John Walters** is a Visiting Lecturer in the Department of English at Indiana University, Bloomington. His research examines the literature of counsel in England during the sixteenth and early seventeenth centuries, exploring the efforts of authors such as Spenser, Donne, and Thomas Elyot to re-imagine the acts of reading and writing as methods for counseling a variety of publics in ethical, political, and religious virtue.
