

# Contributors

**Tara L. Andrews** is a researcher and developer at the Catholic University, Leuven. She holds a PhD in Oriental Studies from Oxford and a degree in Computer Science from MIT. She was a lecturer of Byzantine History at Oxford University before moving to a research position at Leuven. Her research interests lie in Byzantine and Armenian history; her current work also focuses on computational stemmatology and text transmission studies.

**Smiljana Antonijevic** is Assistant Professor of Culture and New Media at Roskilde University. Smiljana holds a PhD in Rhetoric and Communication from the University of Minnesota–Twin Cities, a Master's in Social Anthropology, and BA in both Social Anthropology and Music. **Adelheid Heftberger** is a researcher and archivist at the Austrian Film Museum in Vienna, where – among other responsibilities – she curates the Vienna Vertov-Collection. She holds Master's in Slavic Studies and in Comparative Literature, both of which she received from the University of Innsbruck in Austria. She is currently writing her PhD thesis on data mining and the visualisation of filmic structures in the films of Dziga Vertov.

**Yu-Wei Lin** is Lecturer in Future Media in the School of Media, Music and Performance at the University of Salford, UK. Her research interests centre on the Sociology of Science and Technology, Free/Libre Open Source Software (FLOSS) studies, digital cultures and user requirements analysis. She received her PhD in Sociology from the University of York in 2005, after which she conducted research at the Business School, Vrije Universiteit, Amsterdam, on social capital and social dynamics in virtual communities. Prior to taking up her current post, she worked as a research associate at the UK ESRC National Centre for e-Social Science at the University of Manchester, studying the opportunities and challenges of developing, implementing and adopting a variety of e-Research tools (including grid computing, text mining, data mining, social networking and data-sharing infrastructures) in the fields of social sciences and humanities.

He is the author of *Software Takes Command* (2010), *Soft Cinema: Navigating the Database* (2005) and *The Language of New Media* (2001) which is described as 'the most suggestive and broad ranging media history since Marshall McLuhan'. He has been working with computer media as an artist, computer animator, designer, and educator since 1984. His art projects have been presented by, among others, the Graphic Design Museum (Breda), the Chelsea Art Museum (New York), ZKM, The Walker Art Center, KIASMA, Centre Pompidou, and the ICA (London). In 2007 Lev founded the Software Studies Initiative ([softwarestudies.com](http://softwarestudies.com)). The lab is using digital image processing and new visualisation techniques to explore massive visual cultural data sets.

**Jussi Parikka** is Reader in Media and Design at the Winchester School of Art, University of Southampton, and Adjunct Professor of Digital Culture Theory at the University of Turku, Finland. He holds an Honorary Visiting Fellow position at Anglia Ruskin University. He has written about computer viruses and network accidents (*Digital Contagions*, 2007; *The Spam Book*, 2009), insects and the biophilosophy of digital culture (*Insect Media*, 2010; the special issue on *Media Ecology for Fibreculture*, 2011; and the MediaNatures – online-edited book, 2011) as well as on media archaeological theory and methods (*Media Archaeology*, 2011 and *What Is Media Archaeology?*, forthcoming, 2012). She is General Editor of *DHQ* and Secretary of the Association of Literary and Linguistic Computing. Her research focuses on the use of computational techniques to enable research in the arts and humanities that would otherwise be impossible.

**Douwe Zeldenrust** is Coordinator of External Cooperation at the Meertens Institute, a research institute of the Royal Netherlands Academy of Arts and Sciences.
