

Anna Danielsson is a visiting researcher and lecturer at the Institute of Political Science, University of Tübingen, Germany. She obtained her PhD from Uppsala University in 2014. In her dissertation, she analyses how the idea of 'informality' has been conceptualized and

constituted by various theoretical schools, and how these conceptualizations have subsequently been put to use and acted upon through the policy instruments and practices of international organizations in Kosovo. Her present work focuses on questions of knowledge production, dissemination and performativity in and through international interventions in conflict contexts. This includes the issue of how informal economies are conceptualized and acted upon in international peacekeeping operations.

Thom Davies is a social and cultural geographer with an interest in geographies of exclusion and the lived experience of nuclear space.
