Annie Benveniste is an anthropologist and Professor in the Department of Educational Sciences and on the Masters programme in Gender Studies at the University of Paris VIII, France. She has conducted many studies in the fields of migration, ethnicisation of social relations, ethnicisation of religion and discrimination, including research in Soweto on violence against women in the post-apartheid context. She is currently involved in other European projects (SPRINGARAB, GENDERCIT). She is a past president of the Association Française des Anthropologues and is currently a member of the publishing committee of *Le Journal des anthropologues*.

She has coordinated many issues of this review, including on the concepts of 'Sexe and Gender' 2011, and on 'Norms and Ethics', 2014. Other recent publications are 'Racialisation et ethnicisation de la religion' in *Dictionnaire des faits religieux*, Paris 2010; *Se Faire Violence. Analyse des coulisses de la recherche*, 2013; and a forthcoming article in a collected volume *Women and religion; comparison Jews and Muslims*.

Giovanna Campani is Professor of Intercultural Education, Gender Anthropology and Intercultural Communication in the Department of Education and Psychology, University of Florence. She earned a Ph.D. in Ethnology from the University of Nice with a thesis titled 'Family, Village and Regional Networks of Italian Immigrants in France' and a Master of Philosophy from the University of Pisa with a thesis on 'History, Science and Sociology in Max Weber's Thought'. Her research interests have included social movements, social inclusion, comparative education, the sociology of migration and gender issues. The intersectionality of gender with class and ethnicity has become her main field of study during the last ten years. She has been principal coordinator of the Italian team on numerous EU projects and has coordinated EU projects in the field of migration and gender.

Anna Krasteva is full professor at the Department of Political Sciences at the New Bulgarian University and doctor honoris causa of the University of Lille III, France. She has authored and edited 29 books and published numerous articles in Bulgaria, the USA, France, the UK, Belgium, Russia, Switzerland, Germany, FYROM, Slovakia, Greece, Serbia, Turkey, Italy, the Netherlands and Romania. She has been visiting professor and lecturer at numerous universities, as well as a fellow of the Institute for Advanced Studies in Nantes, France. Her main fields of research are migration and ethnic politics and policies, populism, border politics, digital democracy, and e-citizenship. Balkan Europe at the University of Bologna, the Réseau des Maisons des Sciences de l'Homme in France (2008–2012), Association Internationale des Sociologies de Langue Française (1996–2004), and an evaluator for the European Commission and Fonds de recherche du Québec - Société et Culture. She has been awarded the Palmes Académiques of France and is president of Amopa-Bulgarie (Association of the members of the Palmes Académiques). She is a member of the Board of the Diplomatic Institute, vice-president for international relations of the Bulgarian Political Sciences Association and member of the board of the Balkan Political Science Association.

Roman Kuhar is an Associate Professor of sociology at the University of Ljubljana (Faculty of Arts, Department of Sociology) and researcher at the Peace Institute, Ljubljana. His research interests include GLBT/queer topics, intolerance and equality, media, citizenship and sexuality. He is the author of several books, including *Media Construction of Homosexuality* (2003, MediaWatch, Ljubljana), *At the Crossroads of Discrimination* (2009, Peace Institute, Ljubljana), co-author (with A. Her latest books, *International Migration in Europe: from Subjects to Abjects* (monograph), and *Securitization of Migration in the EU: debates after 9/11* (co-edited with Khursheed Wadia) were both published in 2015 by Palgrave.

Susi Meret is an Associate Professor at the Department of Culture and Global Studies, Aalborg University, Denmark. She is affiliated to the research group COMID, Center for the Studies of Migration and Diversity. She is the main coordinator of a research network on Nordic Populism,

financed by NordForsk, and a partner in the NORDCORP project 'Ideological transformations, organizational development and mainstream reactions.
