# Preface

## Welcome to the ICCHP 2012 Proceedings

The information society is moving towards eAccessibility and eInclusion around the world, facilitated by better and user-friendlier assistive technologies. Research and development are important drivers in moving the sector forward and also in implementing accessibility as a key feature of today's mainstream systems and services. Evidence of this trend can be seen in new free and commercial products, such as screenreader software, working seamlessly on all up-to-date smartphones, pads and tablets.
